SUMMARY OF OPINION:

A teacher who was discharged by a private school filed an age discrimination case against the school, which filed a motion for summary judgment following the completion of discovery. Under the 3-part burden-shifting framework governing age discrimination cases, the employee has the initial burden of demonstrating a *prima facie* case of age discrimination by showing that the employee (a) belonged to the protected class of employees at least 40 years of age, (b) was qualified for the position and dismissed despite being qualified, and (c) was terminated under circumstances giving rise to an inference of discrimination, such as being replaced by someone substantially younger. If the employee establishes a *prima facie* case, the burden of production shifts to the employer to articulate a legitimate, non-discriminatory reason for the termination, but the employer's burden in that respect involves no credibility assessment. Assuming the employer articulates a legitimate business explanation for the discharge, the presumption of discriminatory intent is rebutted and the employee must demonstrate that the employer's proffered reason is pretextual by identifying evidence upon which a factfinder could, *inter alia*, reasonably disbelieve the employer's stated reason.

The employee presented a *prima facie* case of discrimination by producing evidence that he was 69 years of age at the time of his dismissal, that he was deemed capable of performing his teaching job, that he was terminated from his position despite being qualified, and that he was replaced by someone approximately 40 years younger. In satisfaction of its resulting burden of production, the employer articulated legitimate, nondiscriminatory reasons for the firing; however, the employee identified evidence in the record from which the factfinder could reasonably disbelieve those stated reasons and instead conclude that they were pretexts for the employer's discriminatory motivation. Consequently, although the employer's unopposed motions to strike the employee's punitive damages claim and his demand for a jury trial were granted, the motion for summary judgment with regard to the age discrimination claim was denied.

SUMMARY OF OPINION:

The mother of a minor, who was allegedly assaulted and injured by defendant's employee, filed a civil action against the employee and the employer seeking to recover compensatory and punitive damages. The mother alleged that the employee "grabbed [the minor] in a bear hug and violently threw him to the floor," thereby causing the minor to fracture his leg in three places, while the employee was acting within the course and scope of his employment. The mother also averred that the employer failed to properly train, supervise, and hire the employee.

The employer filed a preliminary objection in the nature of a demurrer with respect to the claim for punitive damages. In Pennsylvania, an employer may be vicariously liable for the tortious acts of an employee, including intentional acts, which cause harm to a third party if those acts were committed during the course of and within the scope of the employment. Based upon the allegations of the amended complaint, the employee's "willful and reckless" actions arguably were within the scope of his employment under the Restatement (Second) of Agency § 228. Moreover, an employer may be independently liable for punitive damages based upon a negligent supervision theory pursuant to Section 317 of the Restatement (Second) of Torts. Accordingly, the employer's demurrer to the punitive damages claim was overruled.
