IN ACCORDANCE WITH SECTION 305 OF THE EMINENT DOMAIN CODE, THE PENNSYLVANIA TURNPIKE COMMISSION HEREBY GIVES NOTICE:

Condemnor, The Pennsylvania Turnpike Commission (the "Commission") filed a Declaration of Taking on May 2, 2017 in the Court of Common Pleas of Washington County, Pennsylvania at No. 2017-2238. This was filed pursuant to the requirements of the Commonwealth of Pennsylvania Eminent Domain Code of 2006, 26 Pa.C.S. §302.

The Commission is an instrumentality of the Commonwealth of Pennsylvania, with its principal office at Exit 247 of the Pennsylvania Turnpike system located in Lower Swatara Township, Dauphin County, Pennsylvania. Its post office address is P.O. Box 67676, Harrisburg, Pennsylvania, 17106-7676.

The Commission is authorized and empowered by Section 3 of the Act of July 18, 2007, P.L. 169, No. 44, as amended, to acquire by condemnation any lands, rights, easements, franchises and other property deemed necessary or convenient for the construction or efficient operation of the Turnpike.

The Commission is the fee simple owner of the property subject to this condemnation, which is known and identified as Washington County Tax Parcel ID No. 140-012-07-00-0001-00 by virtue of a general warranty deed by Steve Borda, a widower, dated May 5, 2010 and recorded May 6, 2010 in the Washington County Recorder of Deeds Office at Instrument No. 201014671.

The Declaration of Taking was authorized by a Resolution adopted January 3, 2017 by the Commission. The record thereof may be examined at the Pennsylvania Turnpike Commission's Central Office at Exit 247 of the Pennsylvania Turnpike.

The purpose of the condemnation is to acquire property interests necessary to construct the Southern Beltway of the Pennsylvania Turnpike and its requirements.

The property condemned is situate in the Cecil Township, Washington County and consists of 23.215 Acres as required right-of-way, a total take. Plans showing the area condemned were filed with the Washington County Prothonotary and
