KENNEDY T. FRIEND EDUCATION FUND FOR YALE UNIVERSITY AND UNIVERSITY OF PARIS STUDENTS

Under the will of Kennedy T. Friend, a trust fund known as the **Kennedy T. Friend Education Fund** was established to provide financial assistance to any child of an attorney whose principal place of practice is in Allegheny County and who attends either Yale University or the University of Paris. There are two permanent Trustees of the fund, PNC Bank and Alice B. Mitinger, Esq., and two ex officio Trustees, the President of the Allegheny County Bar Association, and the President of the Yale Club of Pittsburgh.

The Trustees determine the amount of the grants for students attending Yale or the University of Paris in June of each year for the following school year. The amount of the grants varies in accordance with the income of the fund and the number of eligible applicants.
