SUMMARY OF OPINION:

A Lackawanna County Township filed a declaratory judgment action against a Luzerne County Township which had conveyed a road and bridge to the Lackawanna County Township for \$1.00 in 2003 to be used for travel purposes by residents of the Lackawanna County Township. The Lackawanna County Township sought leave of court to reconvey the road and bridge to the Luzerne County Township and to invalidate the deed of dedication since the Lackawanna County Township believed that costly repairs to the bridge and road would become necessary in the near future, as a result of which its continued ownership of that land was no longer in its best interest. The Luzerne County Township filed preliminary objections asserting improper venue in Lackawanna County.

Venue was governed by Pa.R.C.P. 2103(b), which provides that "an action against a political subdivision may be brought only in the county in which the political subdivision is located." Since the defendant-township was situated in Luzerne County, venue was proper only in the Court of Common Pleas of Luzerne County. Thus, the preliminary objection challenging venue under Pa.R.C.P. 1006(b) and 2103(b) was sustained and the litigation was transferred to the Court of Common Pleas of Luzerne County, with the costs associated with the transfer of the court record being borne by the Lackawanna County Township.

SUMMARY OF OPINION:

A patient's estate instituted this wrongful death action against the patient's cardiologist and the distributor of an implantable cardioverter defibrillator (ICD) generator and the associated cardiac leads that were inserted in the patient for treatment of his cardiomyopathy. The estate alleged that a defect in the sensing channel for the right ventricular (RV) lead created noise which the ICD device misinterpreted as ventricular fibrillation (VF), and in response, it appropriately shocked the patient. It was alleged that the cardiologist replaced the ICD generator during a procedure at Regional Hospital of Scranton, but opted not to change the RV lead or any other cardiac lead, as a result of which the patient experienced unwarranted, post-operative shocks from the newly implanted ICD that caused arrhythmia and resulted in his death later that day. His estate alleged negligent monitoring of the ICD and cardiac leads by the treating cardiologist, negligent replacement surgery by that cardiologist, and negligent representations by the technical representatives of the ICD distributor during the procedure.

The estate served a subpoena upon the non-party hospital demanding production of all "screens, data, visuals, monitors" that were available in the EP Lab for doctors to use during any cardiology procedure for the four period from the date of the ICD generator replacement to the present. In response to objections by the non-party hospital and a motion to compel by the estate, it was held that the discovery request for four years of information was overly broad, lacked reasonable particularity, and would cause unreasonable burden and expense to fulfill. Based upon the medical and product issues raised in the case, discovery was allowed only for records and information "regarding screens, data, visuals, monitors" that were available for use in the EP Lab for doctors to use in the same month as the patient's procedure and during any procedure to repair or replace an ICD generator or cardiac lead. In all other respects, the non-party's motion to quash the subpoena was granted.
