CONSOLIDATED RETURN OF UPSET TAX SALE

Notice is hereby given that on November 14, 2017, the Mercer County Tax Claim Bureau presented the Court of Common Pleas of Mercer County, Pennsylvania, a Consolidated Return of the Upset Tax Sale held on September 19, 2017, and continued to October 25, 2017, of properties situated in Mercer County, Pennsylvania. The Court entered a confirmation nisi of said Consolidated Return on November 14, 2017. Objections or exceptions to the said Upset Tax Sale may be filed with the Court of Common Pleas by any owner or lien creditor within thirty (30) days after November 14, 2017.
