Purpose of Sale: To collect real estate taxes, tax liens, tax judgments and municipal claims. This sale may be adjourned, re-adjourned or continued with no additional notice as provided by law.

REPURCHASE BY OWNER AND RESTRICTIONS OF PURCHASERS

ANY PERSON WHO PURCHASES A PROPERTY FROM THIS SALE IN VIOLATION OF THE PROVISIONS OF THE REAL ESTATE TAX SALE LAW SHALL BE SUBJECT TO CIVIL AND/OR CRIMINAL PROSECUTION, INCLUDING BUT NOT LIMITED TO FRAUD.

4. Bidder registrations returned to the Tax Claim Bureau by the appropriate deadline shall include:

- a. the completed registration form
- b. a signed and notarized affidavit certifying that the prospective bidder is not delinquent in paying either municipal bills or real estate taxes within Schuylkill County; that the prospective bidder is not an owner, nor has an ownership interest, in any property to be exposed at the Upset Sale, nor is the prospective bidder acting in accordance with or on behalf of any such owner; and that the prospective bidder has not had a landlord license revoked in any municipality within Schuylkill County, nor is the prospective bidder acting in accordance with or on behalf of any such person.

TERMS OF SALE

A. Immediately upon offering the successful bid, purchaser must pay the FULL AMOUNT of the bid and costs by CASH, CERTIFIED or CASHIERS CHECK or MONEY ORDER.

B. The APPROXIMATE upset price, which is the MINIMUM BID, includes all State and Federal tax liens, corporate liens, tax judgments, municipal claims, sale costs and unpaid real estate taxes through 2015, which were either filed with or provided to the Tax Claim Bureau within the time frame as prescribed by the Real Estate Tax Sale Law. The approximate upset price may increase to reflect additional liens certified to the Tax Claim Bureau following advertisement. **NO PROPERTY WILL BE SOLD FOR LESS THAN THE UPSET PRICE.**
