# Commonwealth v. Konyves

Defendant appeals from the judgment of sentence entered by this court after the Superior Court granted the Commonwealth's Motion to Quash and/or Dismiss Appeal. Defendant appeals from the judgment of sentence and denial of post trial motions.

Criminal law – Corpus delicti – Custodial detention – Investigatory stop – Restricted lot as a traffic way – DUI – Public drunkenness – Held, issues raised on appeal without merit and appeal should be denied.

- 1. A restricted parking lot can be concluded to be a traffic way under the Motor Vehicle Code. 75 Pa. C.S. §102. The public use component of section 102 can be satisfied even where access to a parking lot is restricted, but where there are sufficient number of users.
- 2. The *corpus delicti* rule is two-tiered; it must first be considered as a rule of evidentiary admissibility using a *prima facie* standard, and later, under a beyond a reasonable doubt standard.

# **OPINION**

# I. INTRODUCTION

Lawrence Konyves has appealed from the judgment of sentence entered by this Court on March 23, 2013. This Opinion is filed pursuant to Pennsylvania Rule of Appellate Procedure 1925(a).

# II. PROCEDURAL BACKGROUND

Defendant Lawrence Konyves was arrested for driving under the influence (DUI) on June 14, 2012. On October 19, 2012, Defendant was charged with the following violations of the law: Count I—Driving Under Influence of Controlled Substance, Impaired Ability – 4th Offense;¹ Count II—Habitual Offenders;² Count III—Public Drunkenness and Similar Misconduct;³ Count IV—Disorderly Conduct, Hazardous Physically Offensive Condition;⁴ and Count V – Operating while License is Suspended.⁵ On January 15, 2013 a suppression hearing was held before this Court. At the hearing, Defendant's pretrial Motions to Suppress Defendant's Statements

were denied. The Defendant waived his right to a jury trial and the Court found Defendant guilty on Counts I, II, III, and V and not guilty on Count IV. Imposition of sentence was deferred until March 25, 2013. On March 25, 2013, Defendant was sentenced to not less than two and half and no more than five years and ordered to pay the costs of prosecution.<sup>6</sup> On April 5, 2013 Defendant filed a Post Sentence Motion to Reconsider his sentence which was denied. On August 27, 2013, Defendant filed an appeal to the Superior Court. On February 25, 2014, the Superior Court granted the Commonwealth's Motion to Quash and/or Dismiss Appeal. On April 7, 2014, counsel for Appellant and the Commonwealth agreed to reinstate Appellant's right to appeal Nunc Pro Tunc.<sup>7</sup> Defendant now appeals from the judgment of sentence and denial of post-trial motions.

# III. FINDINGS OF FACT

On June 14, 2012, at approximately 8:00 p.m., Officer Schuck of the Middletown Township Police Department was on patrol in a marked patrol car, working the 7:00 p.m. to 7:00 a.m. shift. Notes of Testimony, Motion to Suppress, January 15, 2013 at 31.8 While stopped at a traffic light on West Old Lincoln Highway, 9 near the intersection at Wheeler Way, he observed a silver Acura drive behind a church to his right. N.T., M.T.S., p. 31. Officer Schuck testified that he was familiar with this particular area since it was part of his patrol zone and that landscaping equipment is frequently kept out in the open at the church parking lot. N.T., M.T.S., p. 32. Officer Schuck observed the vehicle travel towards the landscaping or equipment area. *Id.* 

The parking lot is accessible by two common entrances; one entrance is off of Wheeler Way and the other entrance is off West Old Lincoln Highway. N.T., M.T.S., pp. 34-35. Wheeler Way is an industrial, two-lane roadway separated by a grass median that is frequently traveled by individuals since it leads to a U.S. Post Office, as well as a church and daycare center. N.T., M.T.S., pp. 35-36. Officer Schuck testified that at the time of the incident, he believed the church and daycare center were operating, and that the church was "an open, functioning church, and that the church building was occupied generally at that time." N.T., M.T.S., pp. 38-39. Special permits are not required to park in the parking lot and there are no barriers that would prohibit entrance. According to Officer Schuck, there are approximately fifty to seventy-five parking spots in the parking lot, and the parking lot does not have any "no parking" or "no trespassing signs." N.T., M.T.S., pp. 43-44.

Officer Schuck entered the parking lot, as part of his routine, and noticed the vehicle was stopped and parked between a trailer and a truck and that the Defendant was standing outside of his vehicle, with the car door open, urinating. N.T., M.T.S., pp. 43, 49. When the Defendant noticed Officer Schuck, he explained to the Officer that the equipment in the parking lot was his and that he had just stopped to "take a piss." N.T., M.T.S., p. 49. Officer Schuck then proceeded to get out of his patrol car and asked the Defendant for identification. N.T., M.T.S., p. 50. The Defendant told Officer Schuck his name, but did not give Officer Schuck any identification cards. Officer Schuck stated that the Defendant appeared dumbfounded, as if he was in some sort of "stupor." N.T., M.T.S., pp. 50-51. After asking the Defendant for his identification three or four times, the Defendant handed Officer Schuck a stack of cards. N.T., M.T.S., p. 51. The stack of cards contained business cards and a Pennsylvania non-driver photo ID. N.T., M.T.S., pp. 52-53.

Officer Schuck proceeded to ask the Defendant whether or not he had been drinking and the Defendant replied that he had not. N.T., M.T.S., p. 53. During this time, Officer Schuck observed that the Defendant was having trouble standing and was "swaying" as he stood. *Id.* When Officer Schuck approached the Defendant, there was no odor of alcohol present, N.T., M.T.S., p. 57, but the Defendant's pupils were small and did not change size when Officer Schuck introduced Defendant's eyes to light. N.T., M.T.S., p. 55. Officer Schuck then asked the Defendant if he had taken any drugs and the Defendant "shrugged his shoulders" and told Officer Schuck that he was prescribed the drugs he was taking. N.T., M.T.S., pp. 55-56. The Defendant told the Officer that he had taken two Xanax within three hours, and that he was prescribed to take two Xanax a day. N.T., M.T.S., p. 56.

Officer Schuck stated that he suspected the Defendant was under the influence of a controlled substance and called for other units to come as backup. N.T., M.T.S., p. 57. Officer Schuck administered a preliminary breath test on the Defendant and ruled out alcohol when the test revealed zero alcohol content. *Id.* While waiting for backup to arrive, Officer Schuck noticed that the Defendant was still unsteady on his feet and at one point, the Defendant fell back on Officer Schuck's patrol vehicle. N.T., M.T.S., p. 58. When Officer Schuck asked the Defendant if he could stand by himself and not lean on the patrol car, the Defendant had trouble and continued to lean on the patrol car several times. *Id.* When the Defendant spoke to Officer Schuck his speech was very slow and Officer Schuck testified that he believed the Defendant was going to "fall asleep while he was talking." N.T., M.T.S., p. 58. According to Officer Schuck, the Defendant would "start to answer or not answer and close his eyes, and then it would take a couple of seconds and some prodding from me [Officer Schuck] before he'd open his eyes and respond." N.T., M.T.S., p. 58.

After backup arrived, Officer Schuck administered three field sobriety tests, all of which the Defendant failed. N.T., M.T.S., p. 59. After the last test, Officer Schuck asked the Defendant whether or not he should be driving in this condition and the Defendant responded that he should not be and asked to call his wife. N.T., M.T.S., p. 60. At this point in time, Officer Schuck formed the opinion that the defendant was

under the influence of a controlled substance to a degree that rendered him incapable of safely driving and placed Defendant under arrest. N.T., M.T.S., pp. 60-61.

Officer Schuck transported the Defendant to St. Mary Medical Center and while en route to the Hospital, the Defendant asked Officer Schuck multiple times if he could be given an opportunity to take a breath test. N.T., M.T.S., p. 61. After explaining to the Defendant that he had already taken a breath test and that the portable breath test that was administered at the scene would not detect drugs that may be in his system, the Defendant still continued to ask for a breath test up until he was released from the police station. N.T., M.T.S., p. 62. When Officer Schuck and the Defendant arrived at the hospital, the Defendant refused to give blood and asked Officer Schuck to not charge him with any offense. *Id.* Specifically, Defendant "swore that he would go into treatment and that he and his wife were arguing about his drug use and that it would be nice of me [Officer Schuck] to let him and his wife deal with it between themselves and not to charge him with this." N.T., M.T.S., p. 62. In response, Officer Schuck informed the Defendant that he was proceeding with charges for DUI, regardless of his treatment or what he would be doing with his wife. N.T., M.T.S., p. 63.

After leaving the hospital, Officer Schuck brought the Defendant to Middletown Township so that he could be processed and fingerprinted. N.T., M.T.S., p. 63. While at the police barracks, the Defendant voluntarily stated that he "couldn't wait until he saw me [Officer Schuck] off duty, and that he had a team of doctors and lawyers to get him off these charges." N.T., M.T.S., p. 64. The statements made by the Defendant were not in response to any question that Officer Schuck had asked the Defendant. N.T., M.T.S., p. 68.

# IV. STATEMENT OF MATTERS COMPLAINED OF ON APPEAL

Defendant raises the following issues on appeal: (1) whether this Court erred in not suppressing Statements allegedly elicited by Officer Schuck without first advising Defendant of his State and Federal Constitutional Rights pursuant to Miranda v. Arizona, 384 U.S. 436 (1966), (2) whether this Court erred by failing to suppress evidence obtained by Officer Schuck through his interactions with Defendant as well as statements made by Defendant to Officer Schuck since Officer Schuck lacked probable cause and/or reasonable suspicion by not observing the Defendant operate a motor vehicle on a traffic way or highway, and that the evidence was insufficient to sustain the verdict because the Commonwealth could not prove that Defendant drove the vehicle beyond a reasonable doubt, (3) whether this Court erred by admitting the statements of Defendant without proof of the corpus delicti of the crime with which Defendant was charged, and (4) whether Appellant's conviction was supported by sufficient evidence beyond a reasonable doubt for the crimes of Driving Under the Influence, 75 Pa.CS 3802 D2, Habitual Offenders, 75 Pa.CS 6503.1, Public Drunkenness, 18 Pa. CS 5505, and Driving Under Suspension DUI Related, 75 Pa. CS 1543 (b)(1). See Concise Statement of Matters Complained of on Appeal.

# V. ANALYSIS OF ISSUES

1. Whether this Court erred in not suppressing Statements allegedly elicited by the arresting Police Officer without advising Defendant of his State and Federal Constitution Rights pursuant to *Miranda v. Arizona*, 384 U.S. 436 (1966).

A fundamental principle fortified in the United States Constitution states that a suspect subject to custodial interrogation by police must be warned that he has the right to remain silent, that anything he says may be used against him in court, and that he is entitled to the presence of an attorney. *Miranda v. Arizona*, 384 U.S. 436 (1966). If an individual is not advised of his *Miranda* rights prior to custodial interrogation by law enforcement officials, evidence obtained through the interrogation cannot be used against him. "In order to trigger the safeguards of *Miranda*, there must be both custody and interrogation. Statements not made in response to custodial interrogation are classified as gratuitous and are not subject to suppression for lack of *Miranda* warnings." *Commonwealth v. Heggins*, 809 A.2d 908, 914 (Pa. Super. 2002).

Determining whether a person is in custody for *Miranda* purposes depends on "whether the person is physically denied of his freedom of action in any significant way or is placed in a situation in which he reasonably believes that his freedom of action or movement is restricted by an interrogation." *Commonwealth v. Williams*, 941 A.2d 14, 31 (Pa. Super. 2008). Moreover, "police detentions become custodial when, under the totality of the circumstances, the conditions and/or duration of the detention become so coercive as to constitute the functional equivalent of arrest." *Id* at 31. Factors relevant under the totality of the circumstances test for custody include, "the basis for the detention; its length; its location; whether the suspect was transported against his or her will, how far, and why; whether restraints were used; whether the law enforcement officer showed, threatened or used force; and the investigative methods employed to confirm or dispel suspicions." *Commonwealth v. Levanduski*, 907 A.2d 3, 24 (Pa. Super. 2006). Similarly, in determining whether an individual has been interrogated, interrogation has been defined as "police conduct calculated to, expected to, or likely to evoke admission." *Heggins*, 809 A.2d at 914.

While a court must consider the totality of the circumstances in evaluating whether *Miranda* warnings were necessary, not every statement made by an individual during a police encounter amounts to an interrogation. Volunteered or spontaneous utterances by an individual are admissible even without *Miranda* warnings. *Commonwealth v. Gaul*, 590 Pa. 175 (2006). In addition, the Superior Court in *Commonwealth v. Proctor*, 441 Pa.Super. 176, 183 (1995) found that a policeman's unspoken plan has no bearing on whether a suspect is in custody at a particular time. Specifically, when discussing the Officer's questioning of the Defendant in *Proctor*, the Superior Court concluded:

"The only relevant inquiry is how a reasonable man in the suspect's position would have understood his situation. From aught that appears in

the stipulation of facts, a single police officer asked defendant a modest number of questions and requested him to perform a simple balancing test at a location visible to passing motorists. Treatment of this sort cannot fairly be characterized as the functional equivalent of formal arrest." *Proctor,* 441 Pa. Super at 183.

In the instant case, the Commonwealth was able to prove that Officer Schuck was entitled to make an investigatory stop under the circumstances presented, and that no *Miranda* warnings were necessary. Officer Schuck testified that he was familiar with the parking lot in question, and was aware that landscaping materials and equipment were kept out in the open in this particular parking lot. Knowing this, Officer Schuck acted appropriately in entering the parking lot to determine whether any suspicious activity was occurring. When he found the Defendant urinating outside his car, Officer Schuck believed it was necessary, under the circumstances, to stop and inquire as to the Defendant's whereabouts and why he was there. It was during this conversation that Officer Schuck noticed the Defendant was having difficulty with not only providing identification, but with standing and communicating. Officer Schuck then conducted the field sobriety test, an appropriate investigative method to confirm or dispel his suspicion that the driver may have been under the influence.

In order for *Miranda* warnings to be given there must be a custodial interrogation. Only a short period of time elapsed between Officer Schuck's investigatory stop and Defendant's subsequent arrest. At no point during that time was Defendant informed that the stop would not be temporary. While Officer Schuck may have concluded after his initial interactions with Defendant that he would be taken into custody and charged with a DUI, Officer Schuck never communicated his intention to the Defendant.

Consistent with what was stated in *Proctor*, a single police officer, Officer Schuck, asked the Defendant a modest number of questions and requested him to perform field sobriety tests. This was not a formal interrogation, nor was the Defendant in custody at that time. The Defendant's statements were voluntarily given, without any prodding from Officer Schuck, and therefore, the statements made by Defendant are admissible.

 Whether this Court erred in not suppressing evidence obtained by Officer Schuck as Officer Schuck lacked probable cause and/or reasonable suspicion to arrest Defendant by not observing Defendant operate a motor vehicle on a traffic way or highway.

On appeal, the standard that the appellate court applies "in reviewing the sufficiency of evidence is whether, viewing all the evidence admitted at trial in the light most favorable to the verdict winner, there is sufficient evidence to enable the fact finder to find every element of the crime beyond a reasonable doubt." *Com-*

*monwealth v. Heberling*, 678 A.2d 794, 795 (Pa. Super. 1996). The Superior Court in *Commonwealth v. Ventrini*, 734 A.2d 404 (Pa. Super. 1999) elaborated:

In applying [the above] test, we may not weigh the evidence and substitute our judgment for that of the fact-finder. In addition, we note that the facts and circumstances established by the Commonwealth need not preclude every possibility of innocence. Any doubts regarding a defendant's guilt may be resolved by the fact-finder unless the evidence is so weak and inconclusive that as a matter of law no probability of fact may be drawn from the combined circumstances.

The Commonwealth may sustain its burden of proving every element of the crime beyond a reasonable doubt by means of wholly circumstantial evidence. Moreover, in applying the above test, the entire record must be evaluated and all evidence actually received must be considered. Finally, the trier of fact while passing upon the credibility of witnesses and the weight of the evidence produced, is free to believe all, part or none of the evidence. 734 A.2d 404, 406-07 (Pa. Super. 1999)(citations and quotation marks omitted).

In addition, Defendant argues that the Commonwealth failed to prove beyond a reasonable doubt that Defendant was operating a motor vehicle on a highway or traffic way, which is defined and required by 75 Pa.C.S. §3101(b) of the Motor Vehicle Code. Section 3101(b) provides that: "The provisions of ... Chapter 38 relating to driving after imbibing alcohol or utilizing drugs shall apply upon highways and traffic ways throughout this Commonwealth." The Motor Vehicle Code's definitional section provides the following definitions for "highway" and "traffic way":

"Highway." The entire width between the boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purposes of vehicular traffic. The term includes a roadway open to the use of the public for vehicular travel on grounds of a college or university or public or private school or public historical park. 75 Pa.C.S. §102. "Traffic way." The entire width between property lines or other boundary lines of every way or place of which any part is open to the public for purposes of vehicular travel as a matter of right or custom. 75 Pa.C.S. §102.

In <u>Commonwealth v. Cameron</u>, 668 A.2d 1163 (Pa. Super. 1995), the Superior Court concluded that a restricted lot can be a traffic way. In *Cameron*, the apartment building's parking lot in which the DUI-defendant was a tenant was a traffic way under the Motor Vehicle Code, despite the fact that the parking lot was restricted to tenants, where each tenant had an assigned parking place, and there was only one entrance. The Court's basis behind treating a restricted parking lot as a "traffic way" was stated in *Cameron* as follows, "we conclude that tenants, employees, and others

who have the advantage of a restricted parking facility still deserve and expect to be protected from incidents involving serious traffic offenses.... the public use component of Section 102 can be satisfied even where access to a parking lot is restricted, but where there are a sufficient number of users." *Id.*, 668 A.2d at 1164. Moreover, the Superior Court's reasoning in *Cameron* followed its prior holding in *Commonwealth v. Wilson*, 381 Pa.Super. 253 (1989), wherein the Superior Court found that a parking lot of an Elks Club, marked with a sign designating the lot a private parking lot, was a "traffic way" under the Motor Vehicle Code, stating:

"It would raise form to towing levels above substance if parking lots in which vehicular traffic is encouraged and occurs, sometimes at high rates of speed, were to become "DWI-free zones", in which drunk driving is tolerated from entrance to exit. Such a construction would seriously undermine the effectiveness of any drunk driving prohibitions." *Wilson*, 381 Pa.Super at 257.

Similarly, in *Commonwealth v. Proctor*, 625 A.2d 1221 (Pa. Super. 1993), the Superior Court found a mall parking lot, open to the public, was a traffic way.

In the instant case, Officer Schuck testified that he observed the vehicle travel approximately 100 to 150 yards towards a landscaping or equipment area of the parking lot. Upon Officer Schuck's arrival in the parking lot, he observed the Defendant standing outside of his vehicle urinating, and upon further investigation, opined that the Defendant was intoxicated or under the influence. This Court has accepted Officer Schuck's testimony in its entirety and finds Officer Schuck's testimony credible. Viewing the totality of the circumstances that Officer Schuck was presented with at the time, this Court found that Officer Schuck acted appropriately and responsibly as a Middletown Township Police Officer, and had probable cause to arrest the Defendant.

In addition, the Commonwealth was able to prove that the Defendant was operating his vehicle on a highway or traffic way for purposes of the Motor Vehicle Code. Officer Schuck testified that he saw Defendant's vehicle being operated as it drove into the church parking lot. He also testified that there are no bars or gates that preclude entry and exit into the parking lot, and to access the parking lot, there is no need for a special permit or pass. More importantly, there is no trespassing sign or no "no parking" sign. Furthermore, Officer Schuck testified that the parking lot is open to the public - for individuals attending church or visiting the daycare facility. Officer Schuck admitted that when he is on patrol, he typically goes through one entrance of the parking lot and out the other. When asked if he had seen other cars enter and exit through both areas of the parking lot, Officer Schuck testified that he had. Specifically, Officer Schuck stated that a Dunkin Donuts near the parking lot "has weird access in that you can't make a left turn off 213 to get into there [Dunkin Donuts] and that a lot of time, people in order to defeat that will turn on to Wheeler Way, turn through this parking lot to make the right on to 213 to be oriented in the

right direction to get into the Dunkin Donuts." N.T., M.T.S., p. 45. This seems to suggest that the parking lot is customarily used by at least certain members of the public, and that it can be used for vehicular traffic. Therefore, accepting Officer Schuck's testimony as credible, the Commonwealth proved that Officer Schuck had probable cause to arrest Defendant and that the Defendant was operating a vehicle on a traffic way for purposes of the Motor Vehicle Code.

 Whether this Court erred in allowing evidence of Defendant's Statements without proof of the Corpus Delicti of the crime with which he was charged.

Ordinarily, a confession is inadmissible as evidence in Pennsylvania unless the Commonwealth can independently prove the *corpus delicti* of the crime charged. See *Commonwealth v. Taylor*, 831 A.2d 587, 590 (Pa. 2003). The *corpus delicti* rule has been extended to admissions and statements of the accused and is not limited to formal confessions. *Id.* (citing *Commonwealth v. Smallwood*, 442 A.2d 222, 225 (Pa. 1982)). *Corpus delicti* literally means "the body of the crime" and the rule requires the Commonwealth to show "the occurrence of a loss or injury, and some person's criminal conduct as the source of that loss or injury." *Commonwealth v. Zugay*, 745 A.2d 639, 652 (Pa. Super. 2000). It should be noted that the Commonwealth must show that <u>some</u> person engaged in criminal conduct and that proof of the identity of that person is not required to establish the *corpus delicti*. *Id.* Furthermore, "the *corpus delicti* may be proved by circumstantial evidence." *Id.* at 653.

"The corpus delicti rule is two-tiered; it must first be considered as a rule of evidentiary admissibility using a prima facie standard, and later, under a beyond a reasonable doubt standard, as one of proof for the fact-finder's consideration at the close of the case." <u>Id.</u> at 652. In <u>Zugay</u>, where the defendant protested the admissibility portion of the rule, the court clarified that, "'before introducing an extra-judicial statement, the Commonwealth is not required to prove the existence of a crime beyond a reasonable doubt." Id. (quoting Commonwealth v. Edwards, 555 A.2d 818, 823 (Pa. 1989)). "Rather, it is enough for the Commonwealth to prove that the injury or loss is more consistent with a crime having been committed than not." *Id*. More specifically, in order to establish the *corpus delicti* of driving under the influence, "someone must be in control of a vehicle, and that same person must be under the influence." Commonwealth v. Hogans, 400 Pa.Super. 606, 609 (1990). In Hogans, the corpus delicti of the crime was sufficiently established by circumstantial evidence in the form of the police officer's testimony concerning the scene of the crime, as well as Defendant's field sobriety test, and therefore, the police officer could testify regarding the Defendant's admission.

In the instant case, the Commonwealth was able to prove, through the testimony of Officer Schuck, that the Defendant operated a motor vehicle on a traffic way and that based on his observations of the scene, Officer Schuck had reasonable suspicion to believe that a crime had occurred or was going to occur. Upon arriving in the park-

ing lot where Defendant had parked his car, Officer Schuck observed the Defendant urinating outside his car. Defendant was the only person standing beside his vehicle and no one else was with the Defendant, which seems to suggest that Defendant was the only individual in control of the vehicle for purposes of satisfying the first element for corpus delicti rule of driving under the influence. Moreover, Defendant asked if he could call his wife to come pick him up, which further suggests that Defendant should not have been driving in the first place and that he was alone at the time of the incident. Additionally, the Officer had to ask the Defendant three or four times for his identification and had difficulty communicating with the Defendant. According to Officer Schuck, the Defendant appeared lethargic and his pupils were small and failed to change size when introduced to light. The Defendant appeared to be in some sort of "stupor" and was having trouble standing. Based on these observations by Officer Schuck, Officer Schuck administered three field sobriety tests which the Defendant subsequently failed. As was noted in *Hogans*, circumstantial evidence alone may be used to prove the corpus delicti. The Commonwealth was able to prove the corpus delicti of the crime of DUI based on this circumstantial evidence, and therefore, Defendant's statements are admissible.

> Whether Appellant's conviction was supported by sufficient evidence for the crime of Driving Under the Influence, 75 Pa.CSA 3802 D2, Habitual Offenders, 75 Pa.CSA 6503.1, Public Drunkenness, 18 Pa. CSA 5505, and Driving Under Suspension DUI Related, 75 Pa. CSA 1543 (b)(1)?

As was stated previously, on appeal, the standard that the appellate court applies in reviewing the sufficiency of evidence is whether, viewing all the evidence admitted at trial in the light most favorable to the verdict winner, there is sufficient evidence to enable the fact finder to find every element of the crime beyond a reasonable doubt. *Commonwealth v. Heberling*, 678 A.2d 794, 795 (Pa. Super. 1996). The Superior Court in *Commonwealth v. Ventrini*, 734 A.2d 404 (Pa. Super. 1999) elaborated:

none of the evidence. 734 A.2d 404, 406-07 (Pa. Super. 1999)(citations and quotation marks omitted).

The Appellant argues that the Commonwealth failed to prove beyond a reasonable doubt that he committed the crimes for which he was charged. Furthermore, Appellant contends that the evidence presented at trial was not sufficient to support the finding that he was in actual physical control of the vehicle while under the influence of alcohol, as is required to support a DUI conviction. However, we find that Appellant had been in "actual physical control," as is required by statute, when he was found by police.

In addition the trier of fact is charged with not only evaluating and weighing the evidence, but evaluating the credibility of the witnesses. "The trier of fact, while passing upon the credibility of witnesses and the weight of the evidence produced, is free to believe all, part, or none of the evidence." *Commonwealth v. Reynolds*, 835 A.2d 720, 726 (Pa. Super. 2003). This Court heard the testimony from Officer Schuck who observed the vehicle travel approximately 100 to 150 yards towards a landscaping or equipment area of the parking lot. He then observed the Defendant urinate outside his vehicle, and upon further investigation, was of the opinion that the Defendant was intoxicated or under the influence. This Court found Officer Schuck's testimony to be credible in its entirety and accepted the Commonwealth's version of the facts. The Commonwealth provided ample circumstantial evidence to establish that Appellant committed the crimes beyond a reasonable doubt.

# VI. CONCLUSION

For the foregoing reasons, we find that the issues Appellant has raised in this appeal are without merit.
