3. Cause a copy hereof to be published in the *Northampton County Reporter*, the official legal periodical for Northampton County, once a week for two successive weeks.

RULE N202. APPROVAL OF ALL SEARCH WARRANT APPLICATIONS BY THE ATTORNEY FOR THE COMMONWEALTH

The District Attorney of Northampton County, having filed a Certificate pursuant to Pennsylvania Rule of Criminal Procedure 202, requires that any and all search warrants based upon the Rules of Criminal Procedure shall not be issued by any judicial officer unless a search warrant application has the approval of an attorney from the Office of District Attorney prior to approval and filing.

The approval by the District Attorney shall be noted on the face page of the search warrant, with the name of the Assistant District Attorney approving the warrant and the date of approval.

If the attorney for the Commonwealth disapproves a search warrant application, the attorney shall furnish to the police officer who prepared the application a written notice of disapproval in substantially the form set forth in Pennsylvania Rule of Criminal Procedure 507(C). The attorney shall maintain a record of the written notice.

No defendant shall have the right to relief based solely upon a violation of this Rule.
