

- No on-line searching fees, only a .50 charge to print per page. Work from home or your office, with the same benefits as coming into our office.
- The IQS system will stay in place for the older records back to 1749, until all documents are loaded into Eagle.
- An E-recording program will be available at \$3.00 per document, charged at recording with no additional fees if rejected. Unlike Simplifile, EPN and CSC, who charge \$5.00 per submission.
- Should you decide to come into our office, the public will be able to use any device to pay their
 recording fees with Apple Pay, credit cards and e-checks.
- Integration with the York County Assessment Office Tyler GIS system will improve recording efficiency.
- Updates to Assessment will happen as soon as a single document is verified, creating no delay for assessment to keep their records current for searching and taxing purposes.
- Continued, free sign-ups for the "Records Notification Service" to assure, no document is recorded without the knowledge of the homeowner.
- Upgraded "Hometown Heroes Program" for Veterans who file their DD-214 documents with our office for safe keeping.
- Reduced annual fees for the county.
- And the benefit of surrounding counties using the same recording system, such as Lancaster County who recently changed to Tyler Eagle. Adams County is seriously considering the Tyler system.
