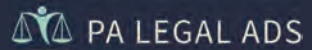

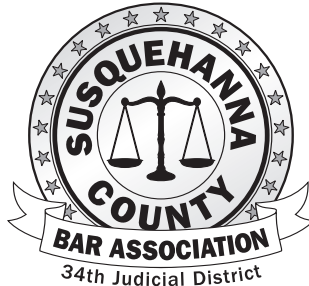

**ORDER**

**NOW**, this 30th day of October, 2019, upon consideration of plaintiff’s motion to compel deposition and motion for sanctions, and upon review of the pleadings as well as the exhibits submitted by plaintiff at the October 25, 2019 hearing, and after oral argument, **IT IS HEREBY ORDERED THAT:**

1. Plaintiff’s motion for sanctions seeking an order prohibiting defendants from presenting any testimony at trial based upon their failure to conduct a full deposition of plaintiff is **DENIED.**<sup>1</sup>

<sup>1</sup> Under Pennsylvania Rule of Civil Procedure 4001(c), any party may take a deposition of any person, including a party “upon petition, motion or rule.” Rule 4002(a) allows the parties to agree to the time and place of a deposition without the need for court intervention or formal compliance with specific procedural rules relating to depositions. Finally, Rule 4007.1(a) provides the procedure through which a party may be deposed – without the need of a court order or agreement under Rule 4002(a) – upon appropriate notice to the other party.

In this case, the parties were amicably working toward a deposition of plaintiff – and there was at least one occasion where plaintiff’s counsel canceled the deposition of the plaintiff on the same day as the scheduled deposition based upon plaintiff’s unavailability. (Plf. Ex. 1, January 14, 2109 letter.) Defendants actually deposed plaintiff earlier this year but terminated that deposition when defendants’ counsel had concerns regarding the competency of plaintiff to testify. (Plf. Ex. 1.) In response, plaintiff’s counsel sought to depose his own client and defendants filed a motion for a protective order seeking to prevent the deposition based upon the alleged incompetence of plaintiff. The court denied defendants’ motion for a protective order and directed that the deposition of plaintiff could occur but the court made no determination as to whether plaintiff was competent to testify.

Thereafter, the parties have been attempting to schedule a deposition date in the midst of other collateral discovery disputes. (Plfs. Ex. 2 & 3.) Defendant’s counsel refused to attend a July 2019 deposition based upon outstanding discovery disputes. (Plf. Ex. 2.) Until the present motion was filed in August 2019, plaintiff never filed any motion seeking to compel plaintiff’s deposition nor does the record reflect that any notice of deposition had been provided under Rule 4007.1(a); rather,

2. Plaintiff's motion to compel deposition is **DISMISSED AS MOOT** given that plaintiff's counsel represented that he believes that plaintiff is not currently competent to provide a deposition at this time.

the parties were proceeding under Rule 4002(a) that permitted a deposition upon agreement and notice to the other party.

Prior to the hearing on plaintiff's motion to compel the deposition, plaintiff fell and sustained injuries to his shoulder. Plaintiff's counsel now has concerns regarding whether plaintiff is competent to testify based upon (1) his current medication regimen; and/or (2) his deteriorating mental state. While the motion to compel was pending, however, the record demonstrates that defendants' counsel was actively working with plaintiff's counsel to set up a deposition date – and the parties had agreed upon the date of September 18, 2019. (Plf. Ex. 3.) Thus, the record shows that defendants' counsel actively engaged with plaintiff's counsel in connection with the deposition of plaintiff, that any refusal by defendant's counsel to complete plaintiff's deposition was reasonable and not pursued in bad faith, and defendant's counsel never disobeyed any discovery order compelling her attendance at the deposition of plaintiff.

Plaintiff contends that sanctions are appropriate under Rule 4019(a)(1)(viii) which authorizes sanctions where "a party or person . . . fails to make discovery or to obey an order of court requesting discovery." In this case, defendants have not violated any court-ordered discovery obligation. The record also demonstrates that defendants have actively engaged in the discovery process and there is no evidence that defendant's counsel "fail[ed] to make discovery." Defendants were not required to depose plaintiff under the discovery rules. The record fails to show that defendants were ever noticed to attend a deposition under Rule 4007.1(a). Finally, to the extent that the parties were attempting to work out a deposition agreement under Rule 4002(a), the record submitted by plaintiff demonstrates that defendants' counsel was acting in good faith in an effort to work out a deposition date that accommodated both parties. For these reasons, the court finds no evidentiary exists of any discovery violations sufficient to impose sanctions upon defendants. See Cove Centre, Inc. v. Westhafer Const., Inc., 965 A.2d 259, 261 (Pa. Super. Ct. 2009) ("Generally, imposition of sanctions for a party's failure to comply with discovery is subject to the discretion of the trial court as is the severity of the sanctions imposed.").


