U.S. BANKRUPTCY JUDGESHIP VACANCY District of New Jersey

Chief Judge Michael A. Chagares of the United States Court of Appeals for the Third Circuit announces the application process for a bankruptcy judgeship in the District of New Jersey, seated in Trenton. A bankruptcy judge is appointed to a 14-year term pursuant to 28 U.S.C. § 152.

To be qualified for appointment an applicant must:

- a. Be a member in good standing of the bar of the highest court of at least one state, the District of Columbia, or the Commonwealth of Puerto Rico and every other bar of which they are members.
- b. (1) Possess and have a reputation for integrity and good character; (2) possess and have demonstrated a commitment to equal justice under the law; (3) possess and have demonstrated outstanding legal ability and competence; (4) indicate by demeanor, character, and personality that they would exhibit judicial temperament if appointed; and (5) be of sound physical and mental health sufficient to perform the essential duties of the office.
- c. At the time of the initial appointment, not be related by blood or marriage, within the degrees specified in 28 U.S.C. § 458, to (1) a judge of the United States Court of Appeals for the Third Circuit, (2) a member of the Judicial Council of the Third Circuit, or (3) a judge of the district court to be served.
- d. Have been engaged in the active practice of law for a period of at least five years. The Judicial Council may consider other suitable legal experience as a substitute for the active practice of law.

The selection process will be confidential and competitive. At present, the annual salary for this position is \$223,836. Applicants shall be considered without regard to race, color, sex, gender, gender identity, pregnancy, sexual orientation, religion, national origin, age (40 years and over), or disability. The name of the person selected will be submitted to the Director of the Administrative Office, who shall request background reports by the Federal Bureau of Investigation (FBI) and the Internal Revenue Service (IRS). In addition, a nominee for a bank-

ruptcy judgeship may be required by the court of appeals to complete a preliminary disclosure statement that includes questions seeking sensitive financial and personal information. The disclosure must be filed with the court of appeals and will be kept confidential. The individual selected must comply with the financial disclosure requirements pursuant to the Ethics in Government Act of 1978, Pub. L. No. 95-521, 92 Stat. 1824 (1978) (codified as amended at 5 U.S.C. app. §§ 101-111).

The application process is entirely automated. No paper applications will be accepted. Applications must be submitted electronically by **noon on March 6, 2024**. Applications must be submitted only by the applicant personally, indicating the applicant's willingness to serve if selected. Commonwealth v. Murph

Evidence is sufficient to show actual and constructive possession of a firearm where DNA found on the weapon matches defendant's and where the firearm was located within defendant's sight and reach; A defendant is not prejudiced by mere passing reference to serving a term of probation where evidence of the same underlying conviction is introduced as an element of Persons Not to Possess Firearms charge.

OPINION BY WRIGHT, J., July 6, 2023. Kenny S. Murph ("Appellant") has filed a direct appeal to the Superior Court of Pennsylvania from the judgment of sentence imposed on April 26, 2023. This Opinion is written pursuant to Rule 1925(a) of the Pennsylvania Rules of Appellate Procedure. For the reasons set forth below, the instant appeal is without merit and should be denied.

BACKGROUND

On July 5, 2017, Petitioner was charged with, among other things, Persons Not to Possess a Firearm. A jury trial commenced on August 6, 2018. During the trial, Officer Isaac Witmer from the Lancaster City Bureau of Police testified that on the evening of July 5, 2017, he was on patrol with his partner Officer Schwebel in Lancaster City. (Notes of Testimony, Jury Trial, Aug. 6, 2018, at 103 [hereinafter N.T. Jury Trial, at ___]). At approximately 12:22 a.m., Officer Witmer and his partner pulled up to an intersection and noticed a red Jeep Cherokee with two occupants crossing the intersection in front of them. (N.T. Jury Trial, at 103). Officer Witmer testified that as the Jeep traveled in front of his cruiser, he noticed the two male occupants "intently staring" at the cruiser with "wide eyes." (N.T. Jury Trial, at 104). Based on his observation, Officer Witmer told his partner, who was driving the cruiser, to follow the Jeep. (N.T. Jury Trial, at 104).

As Officers Witmer and Schwebel continued to follow the Jeep, Officer Witmer noticed that the entire front windshield of the vehicle was cracked, stating that it appeared as "spider glass." (N.T. Jury Trial, at 105). Officer Witmer testified that the condition of the windshield constituted a violation of the vehicle code and that, consequently, the Officers pulled the vehicle over. (N.T. Jury Trial, at 105). After the Jeep was pulled over, Officer Witmer approached the passenger side of the vehicle and identified the passenger as Petitioner, Kenny S. Murph. (N.T. Jury Trial, at 107).

Officer Witmer testified that during his on-scene interaction with Pe-

titioner, he "immediately noted that something appeared not right with [him]," specifically recalling that Petitioner was "breathing at a rate which was extremely un-normal for the situation," that his "chest and abdomen were rising rapidly," that he was "sweating extremely profusely," and that he had his "arms covering . . . the center section of his body and was not moving them at all." (N.T. Jury Trial, at 107–08). Officer Witmer noted that Petitioner's behavior made him "suspicious that something else was going on"—that Petitioner "may have been armed." (N.T. Jury Trial, at 110).

Officer Witmer returned to his vehicle to verify the identification that Petitioner had provided and found that both Petitioner and the driver had suspended licenses and that neither individual was the registered owner of the vehicle. (N.T. Jury Trial, at 111–12). The Officers then made the decision to remove both the driver and Petitioner from the vehicle. (N.T. Jury Trial, at 111–12). While Officer Witmer was interacting with Petitioner outside of the vehicle, another officer who had responded to the scene during the stop, Officer Thomas, noticed a gun under the passenger seat where Petitioner had been sitting. (N.T. Jury Trial, at 113). Officer Thomas notified Officer Witmer of the gun and Officer Witmer placed Petitioner in the back of the police cruiser. (N.T. Jury Trial, at 114).

Officer Witmer then photographed the scene and collected the gun to place into evidence. (N.T. Jury Trial, at 116–18). Petitioner was taken to the police station and officers swabbed the inside of Petitioner's mouth to take a DNA sample. (N.T. Jury Trial, at 120). Lancaster City Evidence Specialist Drew Hollinger then processed the gun for DNA and fingerprints. (N.T. Jury Trial, at 80–81). Although no fingerprints were located on the firearm, the DNA swabs taken from the weapon were sent to the Pennsylvania State Police lab for processing. (N.T. Jury Trial, at 87).

Sandra Newhart, a Forensic DNA scientist from the Pennsylvania State Police lab, testified at trial and explained that when she compared the DNA found on the gun to Petitioner's DNA, she found that the major component of the DNA taken from the gun matched Petitioner's DNA profile. (N.T. Jury Trial, at 163). She explained that "[t]he probability of randomly selecting an unrelated individual exhibiting this specific DNA profile would be one in 640 septillion in the Caucasian population, one in 80 octillion in the African American population, and one in 35 nonillion in the Hispanic population." (N.T. Jury Trial, at 163).

Both the driver of the Jeep and the owner of the Jeep also testified at trial. Both disclaimed ownership and any awareness of the gun found under Petitioner's seat. (N.T. Jury Trial, at 188–89). Both testified that they never owned a gun, never had a gun in the vehicle, and did not loan the vehicle out for other people to use. (N.T., Jury Trial, at 188–89; 195–96).

On August 7, 2018, the jury found Petitioner guilty of Persons not to Possess a Firearm. On January 9, 2019, I sentenced Petitioner to 5 to 10 years incarceration and awarded time credit for his imprisonment

from August 7 to August 13, 2018, and from January 6 to January 9, 2019. On January 22, 2019, Petitioner filed a Post-Sentence Motion for Time Credit, requesting that I grant Petitioner credit for time served between July 5, 2017, and May 20, 2018. I denied Petitioner's Post-Sentence Motion for Time Credit on May 29, 2019.

On June 20, 2019, Petitioner, through public defender MaryJean Glick, Esq., filed a Notice of Appeal to the Superior Court. In his counseled Statement of Errors Complained of on Appeal, Petitioner argued that I erred in denying his Post-Sentence Motion for Time Credit. In response to Petitioner's Statement of Errors, the Commonwealth filed a response conceding that a hearing should be held on the issue of time credit.

On August 14, 2019, Attorney Glick filed with the Superior Court a Motion for Grazier hearing. The Superior Court thereafter issued an Order directing this Court to conduct an on-the-record inquiry to determine whether [Petitioner] wished to proceed with current counsel, or pro se. A Grazier hearing was held before me on October 23, 2019. During the Grazier hearing, Attorney Glick, Petitioner, and the Assistant District Attorney had an off-the-record discussion. (Notes of Testimony, Grazier Hearing, Oct. 23 2019, at 2 [hereinafter "N.T. Grazier Hearing, at _____"). Attorney Glick then summarized the discussion on the record, carefully outlining and providing new documentary evidence of the time credit that Petitioner was owed. (N.T. Grazier Hearing, at 5-6). Attorney Glick also noted that Petitioner would be willing to withdraw the appeal if he was awarded the time credit he sought. (N.T. Grazier Hearing, at 5). The Assistant District Attorney conveyed that the time credit issue was "a matter for the Court" and that she "would not oppose the time credit on this docket." (N.T. Grazier Hearing, at 8).

October 24, 2019, I entered an Order granting the requested time credit on. On the same day, Petitioner filed with the Superior Court an Application for Discontinuance and the Superior Court discontinued his appeal on October 28, 2019.

On August 7, 2020, Petitioner filed a *pro se* Petition for Post Conviction Collateral Relief in which he raised various claims of ineffective assistance for alleged errors of his trial and appellate counsel. On August 12, 2020, I entered an Order appointing Attorney Dennis Dougherty to represent Petitioner and granting 60 days to file an Amended Petition. On October 8, 2020, Attorney Dougherty filed a Motion seeking an additional 60 days to file an Amended Petition, or to inform the Court that no Amended Petition would be filed. I granted Attorney Dougherty's Motion on the same day it was filed.

On November 25, 2020, Attorney Dougherty filed a Motion to Withdraw as Counsel, noting that he had complied with the requirements of <u>Commonwealth v. Finley</u>, 644 A.2d 204 (Pa. Super. 1988) and that he found no meritorious issues to raise or advance on Petitioner's behalf. On December 9, 2020, I entered an Order granting Attorney Dougherty's Motion to Withdraw and a 907 Notice of Intent to Dismiss

Petitioner's pro se Petition.

Petitioner thereafter filed an Amended Petition for Post Conviction Collateral Relief in which he reframed his argument that appellate counsel, Attorney Glick, was ineffective. He argued that Attorney Glick's representation was the functional equivalent of having no representation at all because she failed to file a requested direct appeal on the issue of whether the Commonwealth had presented sufficient evidence regarding constructive possession. I entered an Order denying the Amended Petition and Petitioner filed a Notice of Appeal to the Superior Court.

After further consideration, I determined that an evidentiary hearing on the Amended Petition was, in fact, warranted. I notified the Superior Court that I scheduled an evidentiary hearing to take place on November 2, 2021, and appointed counsel, Daniel Bardo, Esq., to represent Petitioner at the hearing. On August 17, 2021, the Superior Court entered an Order dismissing Petitioner's appeal in light of the hearing scheduled for November 2, 2021. Following the hearing and briefing by the parties, I determined that Petitioner's claim for post-conviction relief was meritless and, on February 1, 2022, I entered an Order dismissing his Petition. On February 8, 2022, Petitioner filed an Appeal in the Superior Court in which he claimed that I erred in denying his PCRA Petition.

On December 22, 2022, the Superior Court issued an Opinion and Order finding that I lacked jurisdiction to enter the October 29, 2019, Order modifying Petitioner's sentence. Consequently, the Superior Court found that the sentence was a legal nullity warranting PCRA relief under 42 Pa.C.S.A. § 9543(a)(2)(viii). On April 26, 2023, after the case was remanded, I issued a Sentencing Order identical to the Order issued in October of 2019. Petitioner filed a timely, counseled appeal to the Superior Court from my April 26th Order. On May 18, 2023, I issued an Order requiring Petitioner to file a statement of errors complained of on appeal pursuant to Pa.R.A.P. 1925(b). On June 19, 2023, Petitioner filed his Statement and the Commonwealth filed a response on June 23, 2023.

DISCUSSION

Appellant raises two issues on appeal. First, Appellant argues that insufficient evidence exists to support his conviction for Persons Not to Possess Firearms. Second, Appellant asserts that I erred in denying his trial counsel's motion for a mistrial after the officer who arrested Appellant testified that he was on probation at the time of his arrest. I will address each issue in turn.

I. Sufficiency of the Evidence

In his first issue, Appellant contends that insufficient evidence exists to support his conviction for Persons Not to Possess Firearms. To convict Appellant of this offense, the Commonwealth was burdened with proving the following two elements beyond a reasonable doubt: *first*, that Appellant possessed a firearm; and *second*, that he was convicted of an enumerated offense that prohibits him from possessing, using,

controlling, or transferring a firearm. 18 Pa.C.S.A. § 6105; <u>Commonwealth v. Thomas</u>, 988 A.2d 669, 670 (Pa. Super. 2009). It is the first element that is at issue in Appellant's claim of error.

To prove that Appellant possessed the weapon that Officers located underneath his seat, the Commonwealth needed to establish that Appellant "was in physical possession or control" of the weapon, "which may be proven through evidence of a direct, physical association between [Appellant] and the weapon" or through evidence that Appellant had "constructive control" of the weapon. Commonwealth v. Gomez, 224 A.3d 1095, 1101 (Pa. Super. 2019) (quoting Commonwealth v. Hanson, 82 A.3d 1023, 1036–37 (Pa. 2013)). Constructive control requires a showing that Appellant had the power to control the contraband and the intent to exercise that control. Commonwealth v. McClellan, 178 A.3d 874, 878, 1101 (Pa. Super. 2018) (quoting Commonwealth v. Valette, 613 A.2d 548 (1992)). "The requisite knowledge and intent may be inferred from the totality of the circumstances." Commonwealth v. Thompson, 428 A.2d 223 (1981).

Instantly, contrary to Appellant's assertion, the Commonwealth presented substantial evidence to show he both actually and constructively possessed the firearm found underneath his seat. Although no fingerprints were found on the weapon, DNA swabbed from the gun overwhelmingly matched Appellant's profile. The forensic DNA scientist who testified at trial explained that the probability selecting an unrelated individual exhibiting the specific DNA profile found on the weapon would be one in 640 septillion in the Caucasian population, one in 80 octillion in the African American population, and one in 35 nonillion in the Hispanic population. Unquestionably, this evidence establishes a direct physical link between Appellant and the weapon and was sufficient to support the jury's finding that he actually possessed the firearm. See Gomez, 224 A.3d at 11071 (concluding that a defendant's DNA on a firearm revealed that the defendant had "physical possession of the [weapon] at some point, thus exerting actual control over the weapon").

The evidence presented at trial also established that Appellant had the power to control the contraband and the intent to exercise that control. The weapon—which DNA established Appellant had handled at some point prior to the vehicle stop—was found in the vehicle directly underneath where Appellant was seated and was within his reach. See Commonwealth v. Hopkins, 67 A.3d 817, 821 (Pa. Super. 2013) (concluding that sufficient evidence had been presented to show constructive possession where the firearm was visible from where the defendant was sitting, was within his arms-length reach). For these reasons, the evidence presented at trial was sufficient to show the Appellant possessed the firearm. Appellant's claim of error is, therefore, without merit.

II. Motion for a Mistrial

In his second claim, Appellant argues that erred by denying his trial counsel's motion for a mistrial after the arresting officer told the jury that Appellant was on probation at the time of his arrest. During Officer Witmer's cross-examination, he mentioned in passing that Appellant was on probation at the time of his arrest. Appellant's trial counsel promptly requested a sidebar, where the following exchange occurred:

Trial Counsel: Your Honor, at this point, I would

like to ask for a mistrial based on [Officer Witmer's] statement that [Appellant] was on probation at

the time.

Probably a little gratuitous, not responsive, I would ask for a mis-

trial.

Commonwealth: He is being responsive. In fact,

he's trying to be careful with what he is. She keeps pushing on what he did and when. There are things I instructed him not to say, which is why he is having a difficult time, and some of these questions are the result of that. When she's asking why he took so long to do this, he is dealing with a number of people. He is trying

to do the best he can.

The Court: Out of curiosity, is supervision re-

lated to the underlying charge?

Commonwealth: Correct.

The Court: So, in part, you opened the door

to that. I don't think it's prejudicial. It's relating to the crime that the jury is going to know about anyway. It will be told in the charge a couple of times that it can't be used against him. It's simply an element of the crime.

Trial Counsel: Okay.

(N.T. Jury Trial, at 148–49). Later in the trial, the Commonwealth entered into evidence the certified conviction that served as the basis of the Persons Not to Possess charge for which Appellant was on trial—

and for which Appellant had been serving the term of probation that Officer Witmer mentioned during his cross-examination. (N.T. Jury Trial, at 197–99).

During my final instructions to the jury, I stated:

The defendant has been charged with persons not to possess or control a firearm. To find the defendant guilty of that offense, you must fin that the following two elements have been proven beyond a reasonable doubt. First, that the defendant was a person prohibited by law from possessing or controlling a firearm. To be prohibited, the Commonwealth must show that the defendant at the time of this conduct had previously been convicted of the crime of robbery. In this case, the Commonwealth introduced testimony that the defendant had been convicted of the offense of robbery on May 18, 2013. This evidence is to be used for, but only for, determining whether the defendant was a person prohibited by law from possessing or controlling a firearm, the charge for which he now stands trial.

You are not to consider this prior conviction as evidence of his propensity to commit a crime or for any other reason. To do so would be a violation of your oaths as jurors.

(N.T. Jury Trial, at 241-42).

In a Persons Not to Possess Firearms case, a defendant does not "suffer[] unfair prejudice merely by the admission into evidence of his or her certified conviction of a specific, identified, predicate offense, which has been offered by the Commonwealth to prove the prior conviction element" of the offense. Commonwealth v. Jemison, 98 A.3d 1254, 1262 (Pa. 2014). "Any possibility of unfair prejudice is greatly mitigated by the use of proper cautionary instructions to the jury, directing them to consider the defendant's prior offense only as evidence to establish the prior conviction element of the [Persons Not to Possess] charge, not as evidence of the defendant's bad character or propensity to commit crime." Id. Further, "[r]eferences during trial to [a] defendant's unrelated criminal acts may be grounds for a new trial; however, where they are mere passing references and the court issues a cautionary instruction to the jury, a mistrial will not be granted." Commonwealth v. Johnson, 459 A.2d 5, 10 (Pa. Super. 1983).

Instantly, at the sidebar reproduced above, the Commonwealth clarified that the term of probation that Officer Witmer mentioned was, in fact, related to the conviction that served as the basis of the Persons Not to Possess charge for which Appellant was on trial. The jury was thereafter presented with a certified copy of that conviction and, as required by Pennsylvania law, I gave a detailed cautionary instruction

regarding the proper use of the prior offense. To the extent that the jury may not have understood that the term of probation mentioned that Officer Witmer mentioned was being served for the specific, identified, predicate offense, the reference was merely in passing and my cautionary instruction remedied any need for a mistrial. Accordingly, Appellant's argument that I erred in refusing to grant his trial counsel's motion for a mistrial is misplaced.

CONCLUSION

For these reasons, each of the errors that Appellant complains of are without merit and the appeal should be denied. Accordingly, I enter the following:

ORDER
