CRIMINAL CASES

Wayne County District Attorney A.G. Howell announces the following cases were addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — May 27, 2021

MATTHEW NORMAN ANDERSON, age 33 of Farmington NM, was sentenced 12 months probation for one count of Simple Assault (M2). He was also ordered to pay the cost of prosecution, pay a fine in the amount of \$500.00, pay restitution, complete an anger management program, and undergo a drug and alcohol evaluation and comply with any recommendations for treatment. This incident occurred on December 28, 2018 in Berlin Township.

DANIEL BARNES, age 51 of Honesdale Pa, was sentenced to 6 months probation with 72 hours house arrest through the SCRAM program for one count of Driving Under the Influence of Alcohol: Highest Rate (M). He was also ordered to pay the cost of prosecution, pay a mandatory minimum fine of \$1,000.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, and complete the Alcohol Highway Safety Program. This incident occurred on September 6, 2020 in Hawley Borough.

SEAN ROBERT CARNEY, age 44 of Browndale Pa, was sentenced to 6 months probation with 30 days house arrest through the SCRAM program for one count of Driving Under the Influence of Alcohol (M) and one count of Driving While Operating Privilege Suspended/Revoked (S). He was also ordered to pay the cost of prosecution, pay a mandatory minimum fine of \$500.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Program, and complete 25 hours of community service. This incident occurred on May 30, 2020 in Clinton Township.

AUTUMN DELONG, age 35 of Honesdale Pa, was previously resentenced on November 14, 2019 to 2 months to 23 2/1 months for one count of Endangering the Welfare of Children as Parent or Guardian (M1). On April 30, 2021 the Defendant violated parole when she was found to be in possession of a loaded firearm. The Defendant was found in violation and remanded to the Wayne County Correctional Facility for the remainder of her sentence, which is October 29, 2021.

KELLY LOGAN, age 27 of Keansburg NJ, was issued a Bench Warrant for failure to appear in Court for sentencing. The Defendant was issued a second Bench Warrant for failure to appear for a Parole Violation.

DEVYN VALENTINE SULLIVAN, age 27 of Honesdale Pa, previously sentenced on June 18, 2020 to 98 days to 23 1/2 months in the Wayne County Correctional Facility for one count of Criminal Conspiracy-Theft by Unlawful Taking or Disposition (F3) was

remanded to the Wayne County Correctional Facility for the remainder of her sentence, which is February 27, 2022 for a parole violation. On April 14, 2021 the Defendant failed to report to probation as instructed, it was learned the Defendant had moved out of state in violation of probation.

DETLEF VON-HAHN, age 66 of Scranton Pa, was sentenced to 60 months probation with 6 months house arrest through the SCRAM program for one count of Driving Under the Influence of Alcohol (M1). He was also ordered to pay the cost of prosecution, pay a mandatory minimum fine of \$1,500.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Program, and continue with ongoing mental health treatment and comply with all recommendations. This incident occurred on June 7, 2020 in Palmyra Township.


