In Re: Estate of R.C.

Orphans' Court – Petition – Special emergency relief – Life-preserving treatmeant - Incompetent person – End-stage medical condition

- 1. The plain language of the Health Care Agents and Representatives Act provides that absent a health care directive or health care agent, life-preserving treatment must be provided for an incompetent person.
- 2. The issue of the authority of a guardian is governed by the Health Care Agents and Representatives Act and the provisions of the Probate, Estates and Fiduciary Code relating to incapacitated persons.
- 3. The right to act as Plenary Guardian includes the duty to assert and act in the best interests of the incapacitated person guided by the principle that expressed wishes and preferences of the incapacitated person shall be respected to the greatest possible extent.
- 4. A guardian's power is limited in that the court may not grant to a guardian powers controlled by statute.
- 5. Where an individual has espoused his or her intentions regarding the use of life-sustaining treatment prior to becoming incapacitated, their wishes shall be respected to the greatest possible extent.
- 6. Where life-preserving treatment is at issue for an incompetent person who is not suffering from an end-stage condition or permanent unconsciousness, and that person has no health care agent, the Health Care Agents and Representatives Act mandates that the care must be provided.
- Only a principal or health care agent may authorize refusal of life-preserving medical treatment.
- 8. Health care necessary to preserve life shall be provided to an individual who has neither an end-stage medical condition nor is permanently unconscious, except if the individual is competent and objects to such care or a health care agent objects on behalf of the principal if authorized to do so by the health care power of attorney or living will.
- 9. The court is without authority to convert a plenary guardianship into a health-care agent to enable authorization of refusal of treatment of life-preserving nature. As such, the medical providers are required to provide health care necessary to preserve life.
- 10. Court-appointed plenary guardian filed a Petition for Special Emergency Relief seeking to have the Court permit the guardian to approve Do Not Resuscitate and Do Not Intubate code status for the incapacitated person and permission to place him in hospice care. Following a hearing, the Court <u>Held</u>, that the Petition was denied.

MEMORANDUM

This matter arises out of the Petition for Special Emergency Relief (the "Petition") filed by Guardian Services of Pennsylvania/Carol J. Hershey ("GSP" or "Petitioner"). After considering evidence and testimony presented at a hearing on May 13, 2020, the Petition is denied based on the plain language of 20 Pa.C.S. § 5462(c) and related provisions as well as the Pennsylvania Supreme Court's holding in In Re D.L.H., 2 A.3d 505 (Pa. 2010) (holding that the plain language of the Health Care Agents and Representatives Act provides that absent a health care directive or health care agent, life-preserving treatment must be provided for an incompetent person).

BACKGROUND

This court originally appointed GSP as plenary guardian on January 27, 2020 following a hearing at which R.C. was represented by counsel but where R.C. was not present by his own choice. An Order (the "Appointment Order") was issued in which the court found that R.C.'s ability to make and communicate decisions is "totally impaired." Accordingly, GSP was appointed as plenary guardian of the person and estate. In addition, although it is represented that no health care agent exists presently, the Appointment Order stated that "[t]he Guardian(s) of the Person is hereby authorized to revoke the appointment of the health care agent."

On May 8, 2020, GSP filed the instant five (5) paragraph Petition and alleged that R.C. is seventy-eight (78) years old and has no known advance health care directive or living will. R.C. is a resident of Twin Pines Health Care Center, a nursing home located in West Grove, PA. He suffers from: (i) chronic kidney disease (stage 4 in the Petition although testimony stated that it was stage 5); (ii) hypertension; (iii) diabetes mellitus Type 2; (iv) anemia; and (v) dementia.¹

GSP requested this Court to "grant permission to [GPS] to approve Do Not Resuscitate and Do Not Intubation [sic] code status for [R.C.] and permission to place him in hospice care." The Petition states that the treating physicians believe that Do Not Resuscitate (DNR) code status would be in R.C.'s best interest and that GSP did not have clear legal authority to approve the DNR or Do Not Intubate (DNI) status.

DISCUSSION

The issue of the authority of a guardian is governed by, inter alia, the Health

Care Agents and Representatives Act, 20 Pa.C.S. §§ 5451-5471 (the "HCAR ACT") and the provisions of the Probate, Estates and Fiduciary Code (the "PEF Code") relating to incapacitated persons, 20 Pa.C.S. §§ 5501-5555 (the "Incapacitated Persons Act"). Here, the authority in question revolves around the ability of a plenary guardian to authorize a medical provider to refuse life-preserving medical treatment on a person who lacks capacity.

The Appointment Order granted GSP the right to act as Plenary Guardian of R.C. The duties include asserting and acting in the best interests of the incapacitated person guided by the principle that "[e]xpressed wishes and preferences of the incapacitated person shall be respected to the greatest possible extent." 20 Pa.C.S. § 5521(a). However, a guardian's power is limited in that, "[t]he court may not grant to a guardian powers controlled by other statute,". 20 Pa.C.S. § 5521(f). See In re Easly, 771 A.2d 844 (Cmwlth. Ct. 2001) (opining that the guardian does not have authority to admit the incapacitated ward to an inpatient psychiatric facility) (citing 20 Pa.C.S. § 5521(f)).

The testimony established that R.C. has no known health care directive, living will, or appointed health care agent. If he had then there would be additional points of reference because "where an individual has espoused his or her intentions regarding the use of life-sustaining treatment prior to becoming incapacitated, their wishes 'shall be respected to the greatest possible extent." In re Fiori, 652 A.2d 1350, 1376 (Pa. Super. 1995) (concurring and dissenting opinion). R.C. has apparently expressed a desire to refuse hemodialysis treatments which has been respected. See, e.g., May 13, 2020 Notes of Testimony at p. 13 ("But he has routinely and for some period of time refused to go to dialysis. . . . We can't force him to get dialysis.") (Testimony of Carol Hershey, president of GSP). However, the level of understanding of R.C. is at issue given his incapacitated state.²

Although R.C. is apparently refusing dialysis, the evidence regarding his wishes for a DNR or DNI was limited to Kimberly Carr, an employee of GSP, who testified that R.C.'s son relayed that GSP and the medical providers should provide life-preserving treatment and "should follow his father's wishes, which were to be a full code." May 13, 2020 Notes of Testimony at p. 16. Ms. Carr had not spoken directly to R.C. regarding his wishes (in part due to COVID-19 restrictions) but believed he "can make basic things known." Id. Accordingly, we are left without either prior directive or current reliable testimony on R.C.'s wishes (nor do we address here if R.C. would have the capacity and ability to understand the questions, results of certain actions/inactions, and/or make a knowing decision).

The difficulties of decisions regarding termination of life-preserving treatment are well discussed by the various opinions issued by the judges of the <u>In re Fiori</u> court and this court shares in the conflict of the best way to analyze and decide such a question as well as the appropriateness of court involvement. The Superior

Court in <u>In re Fiori</u> ultimately allowed a mother with the approval of two qualified physicians to terminate life-sustaining treatment of a person in a long-term persistent vegetative state and provided factors to be considered by the court in such a scenario. However, the In re Fiori court dealt with an individual in a persistent vegetative/unconscious state, which is markedly different from our present situation.

The Pennsylvania Supreme Court analyzed the issue of a plenary guardian requesting to be appointed as a Health Care Agent pursuant to the Act in order to withhold life-preserving treatment for an incompetent person not suffering from either an (1) end-stage condition; or (2) permanent unconsciousness. In Re D.L.H, 2 A.3d 505, 515 (Pa. 2010) ("We hold that where, as here, life-preserving treatment is at issue for an incompetent person who is not suffering from an end-stage condition or permanent unconsciousness, and that person has no health care agent, the Act mandates that the care must be provided.").

As with R.C., the <u>In Re D.L.H.</u> court had an incapacitated person who had no living will, no health care agent pursuant to 20 Pa.C.S. § 5422, and no healthcare directive. Additionally, like the case *sub judice* and as distinguished from <u>In re Fiori</u>, supra, the <u>In Re D.L.H.</u> court had an incapacitated individual who was not suffering from an end-stage condition or permanent unconsciousness.

Although stage 5 chronic kidney disease may ultimately result in death it is not an end-stage medical condition as defined by 20 Pa.C.S. § 5422, which provides:

An incurable and irreversible medical condition in an advanced state caused by injury, disease or physical illness that will, in the opinion of the attending physician to a reasonable degree of medical certainty, result in death, despite the introduction or continuation of medical treatment. Except as specifically set forth in an advance health care directive, the term is not intended to preclude treatment of a disease, illness or physical, mental, cognitive or intellectual condition, even if incurable and irreversible and regardless of severity, if both of the following apply:

- (1) The patient would benefit from the medical treatment, including palliative care.
- (2) Such treatment would not merely prolong the process of dying.

Testimony from the overseeing physician, Dr. Narveet Sharma, provided that "he probably *may* end up requiring [life support measures] on a permanent basis." May 13, 2020 Notes of Testimony at p. 7 (emphasis added). The timeline without treatment of the underlying condition was unknown but estimated to be "a week, two months, weeks to months." <u>Id.</u> at 9. With treatment, the prognosis could be "beyond one year". <u>Id.</u> at 9-10. It may be that in the future R.C. will meet the definition of an end-stage condition but the condition today does not meet that definition.

Unlike here, in In Re D.L.H. the guardian sought to "transform guardianship into health care agen[cy]"; however, the end goal of the guardian was the same – to be granted the authority to order the withholding of life-preserving treatment. Id. at 509 (modification in the original) (quoting the trial court opinion, In Re D.L.H., No. 21-02-293, slip op. at 3, 6 (C.P. Cumberland, Jan. 24, 2008) (quoting a party's brief with emphasis and footnotes omitted)). Therefore, although the instant Petition was framed as a request to have the authority to order treatment withheld with no statute or case law cited, the vehicle by which the Guardian could arguably attempt to do so is by being deemed the healthcare agent of R.C. pursuant to the HCAR Act. Accordingly, the In Re D.L.H. opinion is squarely on point with the instant matter. Further, the instant matter may be distinguished from In re Fiori, supra, which is expressly retained by 20 Pa.C.S. § 5423(a) ("Nothing in this chapter is intended to . . . affect or supersede the holdings of In re Fiori.").

The Pennsylvania Supreme Court found the plain language of the HCAR Act and Incapacitated Persons Act binding. 20 Pa.C.S. § 5521(f) explicitly limits the powers of a guardian. "The court may not grant to a guardian powers controlled by other statute,". The powers to refuse life-preserving treatment are controlled by another statute. Specifically, 20 Pa.C.S. § 5462(c)(1), which provides that only a principal or health care agent may authorize refusal of life-preserving medical treatment: "Health care necessary to preserve life shall be provided to an individual who has neither an end-stage medical condition nor is permanently unconscious, except if the individual is competent and objects to such care or a health care agent objects on behalf of the principal if authorized to do so by the health care power of attorney or living will."

In analyzing the totality of the HCAR Act and Incapacitated Persons Act, the Court summarized well that:

Chapter 54 reflects a careful legislative effort to balance various rights and interests in the sensitive arena of personal medical care provided to one who is not competent to assert his or her own rights. On the one hand, the statute manifests respect for advance health care directives, as well as the decisions of close relatives and friends, where the incompetent person suffers from an end-stage condition or permanent unconsciousness, and enables health care providers to comply with such decisions. See, e.g., 20 Pa.C.S. §§ 5423(a)(1), 5423(c)(4), 5426, 5431, 5456, 5462(c). The enactment, on the other hand, more sharply regulates the situation in which the incompetent person suffers from a life-threatening but treatable condition, obviously reflecting the Legislature's assertion of a policy position of greater state involvement to preserve life in such circumstances. . . . Section 5462(c)(1) does allow for life-preserving medical treatment to be refused in such instances, but only by a health care agent (or the principal should he or she regain the capacity to make health care decisions).

Being bound by the plain language of the applicable statutes as well as the precedent set by the Pennsylvania Supreme Court, we find that this court is without authority to convert the plenary guardianship into a healthcare agent to enable authorization of refusal of treatment of life-preserving nature. As such, the medical providers are required to provide "health care necessary to preserve life." 20 Pa.C.S. § 5462.³

In In Re D.L.H., the Pennsylvania Supreme Court recognized the "[appellants' concern with the possibility that [the incapacitated person] may face additional medical interventions which they may quite reasonably regard as painful and intrusive." In Re D.L.H., 2 A.3d at 515. This court is similarly concerned with the possibility that R.C. may be forced to undergo treatment which may be painful and intrusive. Further, it is not the desire of the court to force uncomfortable and expensive repeated trips to the emergency room to treat symptoms or direct medical problems caused by the existing kidney disease when the underlying condition is not being addressed. However, it is not the place of this Court to overturn the clear directive of the legislature or the precedent of the Pennsylvania Supreme Court.

Accordingly, the Petition is **Denied** pursuant to the plain language of the Act and precedent set by the Pennsylvania Supreme Court in <u>In Re D.L.H.</u>, 2 A.3d 505 (Pa. 2010). Such denial is without prejudice to re-file should R.C. become permanently unconscious or progress to an end-stage medical condition.

³ Although not raised as an issue in the Petition, this court is troubled by the evidence that hemodialysis has not been provided to R.C. due to his declining treatment. May 13, 2020 Notes of Testimony at p. 9 ("[I]t's documented in point and click electronic medical records as well and the interaction taken place between Autumn Smith, the Certified Registered Nurse Practitioner, and Dr. Kaufman, where [R.C.] has declined for the treatment, whether it is a diagnostic workup or a therapeutic intervention.") (Dr. Shwarma). Moreover, R.C.'s reason for declining hemodialysis appears to be discomfort. Id. at p. 13 ("But he has routinely and for some period of time refused to go to dialysis. Dialysis, from my understanding, is very uncomfortable for patients and he refuses to go.") (Carol Hershey). Although it may not be possible to force R.C. to undergo dialysis, the medical providers are bound by the language of 20 Pa.C.S. § 5462 to provide life-preserving treatment if possible.
