#### SUMMARY OF OPINION:

In this dram shop action, the tavern owners sought to strike plaintiff's allegations of reckless, willful, and wanton conduct and the claims for punitive damages on the basis that plaintiff failed to sufficiently allege facts warranting such a finding and award. Pa.R.C.P. 1019, which is entitled "Contents of Pleadings – General and Specific Averments," states that "[m]alice, intent, knowledge, and other conditions of the mind may be averred generally." Since 2009, the Superior Court of Pennsylvania has held that "[a]n example of a condition of the mind that may be averred generally is wanton conduct," and that "because recklessness is also known as 'wanton and willful misconduct,' 'recklessness' is a condition of the mind that may be averred generally." Archibald v. Kemble, 971 A.2d 513, 519 (Pa. Super. 2009), app. denied, 605 Pa. 678, 989 A.2d 914 (2010). Therefore, preliminary objections seeking to strike claims of recklessness and to dismiss punitive damages claims on the basis of factual insufficiency have been overruled, provided that the complaint generally avers willfulness, wantonness, or recklessness. #### SUMMARY OF OPINION:

Plaintiff in this malpractice action filed a motion to preclude the only non-settling defendant from presenting the testimony of a newly retained expert who produced an expert report one week prior to trial criticizing the care that was provided by the settling defendants. The factors to be considered in determining whether to exclude an expert's testimony are (1) the prejudice to the party against whom the witness will testify; (2) the ability of that party to cure the prejudice; (3) the extent which waiver of the exclusionary rule would disrupt the orderly and efficient trial of the case or other cases; and (4) the bad faith or willfulness on the part of the defaulting party. In the absence of bad faith or willful disobedience, the most significant considerations are the importance of the witness's testimony and the prejudice to the party against whom the witness will testify.

The delinquent production of the expert report was the product of the non-settling defendant's intentional strategy in foregoing a cross-claim against a co-defendant, as opposed to timely asserting a claim for contribution or indemnification. While the timing of the solicitation and receipt of the report did not appear to be the product of bad faith, the prejudice resulting to plaintiff on the eve of trial, and plaintiff's corresponding inability to cure that prejudice on such short notice, were self-evident. Since the non-settling defendant did not identify any "extenuating circumstances" which caused its noncompliance with Pa.R.C.P. 4003.5 to be "beyond the control of the defaulting party," and a continuance of the trial would disrupt the orderly and efficient trial of the case and other matters, plaintiff's motion to preclude was granted.
