**PROSPECTIVE BIDDERS AT ALL
TAX SALES ARE REQUIRED TO PRO-
VIDE AN AFFIDAVIT CERTIFYING TO
THE TAX CLAIM BUREAU THE FOL-
LOWING:**

1. Within any municipal jurisdiction, such bidder is not delinquent in paying real estate taxes owed to taxing bodies within the Commonwealth of Pennsylvania and is not delinquent in paying municipal utility bills owed to the municipalities within the Commonwealth of Pennsylvania.

2. The bidder is not the owner of any property being exposed at the upset tax sale, and is not a partner or shareholder of the owner of any property, nor in any of the following legal relationships with the owner: trust, partnership, limited partnership, corporation or any other business association.

3. No individual whose landlord license has been revoked in a municipality, pursuant to its ordinance, may purchase property in the county in which the local municipality is located at a tax sale. A \$50.00 registration fee will be charged per registration form. Registration forms will not be accepted after this date.
