PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE PIKE COUNTY SENTENCING INFORMATION

July 2, 2020 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Casey Ann Hockenberry, age 37, of Huguenot, NY, was sentenced to 1 year of probation and fined \$100.00 for the crime of Disorderly Conduct. Hockenberry struck an individual in the head with a dog gate and threatened violence to the individual at a residence in Westfall Township on September 11, 2019.

Gustave Debree, age 46, of Hawley, PA, was sentenced to 12 months of probation and fined \$200.00 for the crime of Possession of Drug Paraphernalia. The state police responded to a vehicle crash along Blooming Grove Road in Blooming Grove Township on September 15, 2018, in which Debree was a passenger. Debree was found in possession of baggies used for the storage of a controlled substance.

Brian Clyde Berryhill, age 24, of Matamoras, PA, was sentenced to 48 hours to 6 months in the Pike County Jail and fined \$500.00 for the crime of Driving Under the Influence. The state police were dispatched to Park Road in Delaware Township on February 11, 2018, where Berryhill had crashed his vehicle. In speaking with Berryhill, the trooper detected the smell of an alcoholic beverage. Berryhill admitted to drinking prior to driving. Field Sobriety Tests showed impairment and a blood test confirmed a blood alcohol content of .121%.


Mark Anthony Passaretti, age 30, of Shohola, PA, was sentenced to 48 days to 6 months in the Pike County Jail, followed by 6 months of probation, a fine of \$800.00 and a driver's license suspension of 12 months for the crimes of Possession of a Controlled Substance and Driving Under the Influence. The state police responded on July 2, 2017, to the intersection of SR 434 and SR 739 where Passaretti crashed his vehicle. Passaretti was observed staggering, emitting the smell of an alcoholic beverage and having bloodshot eyes and slurred speech. A breath test confirmed a blood alcohol content of .120%. Passaretti was a passenger in a vehicle that was stopped by the state police on September 22, 2019, for no inspection sticker while traveling along Log Tavern Road in Dingman Township. Passaretti was taken into custody on an active warrant and was found in possession of Cocaine.

Declan Andrew Preston, age 20, of Dingmans Ferry, PA, was sentenced to 30 days to 6 months in the Pike County Jail and fined \$200.00 for the crime of Harassment. In an attempt to harass or frighten an individual, Preston threatened or subjected the individual to physical contact at a residence in Dingman Township on October 30, 2019.

Christopher Robert Early, age 21, of Milford, PA, was sentenced to a fine of \$400.00 for the crime of Possession of a Small Amount of Marihuana. Early was stopped by the state police on November 7, 2019, for driving an unregistered vehicle along SR 739 in Dingman Township. In speaking with Early, the trooper detected the smell of Marihuana. A consent to search the vehicle revealed a zip lock bag containing less than 30 grams of Marihuana under the vehicle driver seat.

Wade Tyler John Robson, age 23, of Lexington, TN, was sentenced to 1 day to 6 days in the Pike County Jail and fined \$500.00 for the crime of Possession of a Small Amount of Marihuana. On May 20, 2015, Robson was observed by Security Officers at a school in Lehman Township acting in a suspicious manner. Robson was found in possession of an eyeglass case containing less than 30 grams of Marihuana.

Ashley Renee Bezzina, age 32, of Hawley, PA, was sentenced to 48 hours to 6 months in the Pike County Jail, fined \$500.00 and had her driver's license suspended for 12 months for the crime of Driving Under the Influence. The state police stopped Bezzina on May 9, 2019, for traveling along Blooming Grove Road in Blooming Grove Township without headlights. The trooper detected the smell of an alcoholic beverage when speaking with Bezzina and observed her to have glassy, bloodshot eyes and slurred speech. Bezzina admitted to drinking prior to driving. Field Sobriety Tests showed impairment and a breath test confirmed a blood alcohol content of .143%.

SHOHOLA TOWNSHIP MAN SENTENCED ON DOMESTIC ABUSE AFTER TRIAL IN PIKE COUNTY

July 10, 2020 — Pike County District Attorney Ray Tonkin announced today that Barry Schlegel, age 61, was sentenced to a period of 3 years to 6 years in state prison after a jury found him guilty of three counts of Simple Assault in relation to acts of domestic violence. The charges were the result of an incident occurring in a pick-up truck that Schlegel was driving in which the victim was a passenger back on August 4, 2018. During the trial that occurred in January, the victim testified that Schlegel struck her in the face repeatedly, pulled her hair and hit her on various other parts of her body. The assault left multiple bruises on the victim.

At the sentencing hearing, First Assistant District Attorney Bruce DeSarro argued in favor of the three to six year sentence, which was the maximum allowed for the charges under Pennsylvania Law. At sentencing, DeSarro spoke of Schlegel's criminal history that included four prior convictions for assault. DeSarro specifically highlighted two prior cases for domestic abuse that occurred since 2003 which involved two different victims. DeSarro also noted for the court the literal and figurative scars domestic violence victims endure and how the psychological trauma they experience often lasts well beyond their physical injuries.

In regard to the sentencing, District Attorney Ray Tonkin credited the Pennsylvania State Police for their investigation in the matter and stated, "my Office will continue to work hard combatting domestic violence through our Domestic Abuse Response Team, which includes the District Attorney's Office, law enforcement, and victims."

While awaiting transfer to a state correctional facility, Schlegel is currently in custody at the Pike County Correctional Facility, where he has been held since his conviction in January.
