

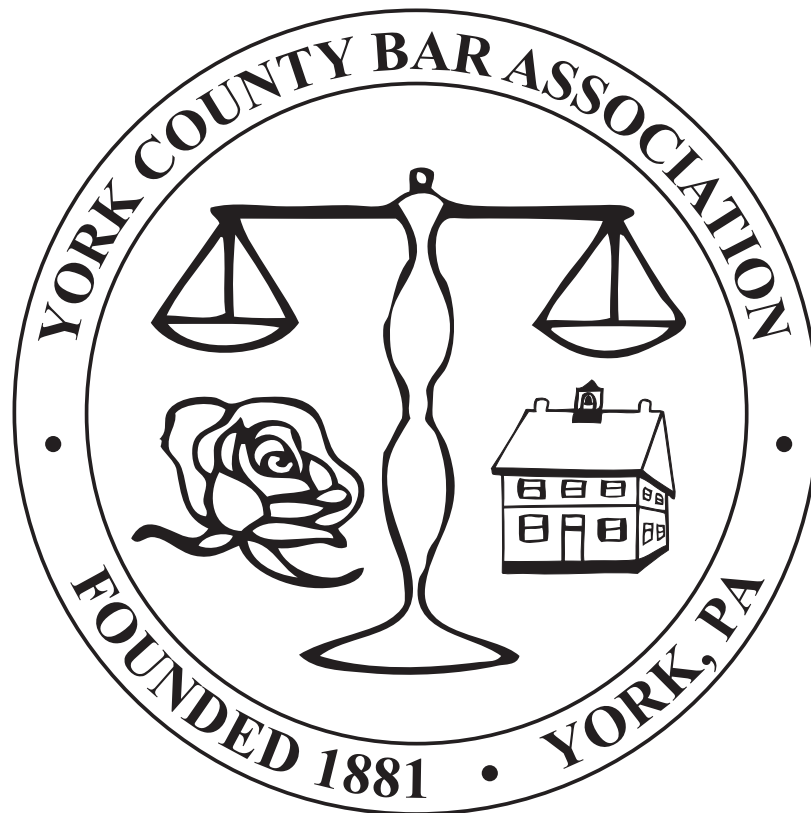

Are your clients worried about being evicted?

If any of your clients are worried about being evicted from their homes, it is crucial that they fill out a CDC Declaration Form to present to a magistrate should their landlord file for eviction.

While the national, CDC-declared, moratorium on evictions runs through the end of July 2021, renters are highly encouraged to visit <https://www.yorkcpc.org/cdc-eviction-moratorium/> and fill out the form at the bottom of the page.

When finished completing this form, they should make a copy, keep one and send the other to their landlord as soon as possible.
