COMMONWEALTH OF PENNSYLVANIA VS. ROBERT ANDREW NEWLIN

- 1. Section 6308 of the Pennsylvania Motor Vehicle Code constitutionally permits an officer to stop a vehicle if the officer has reasonable suspicion that a provision of the Motor Vehicle Code has been violated.
- 2. In this case while following Defendant's vehicle, Trooper Horan observed a lit cigarette being discharged from the window of the vehicle landing on the public roadway. That observation gave Trooper Horan probable cause to effectuate a motor vehicle stop. Specifically, his observations were that the operator or someone in the motor vehicle had violated the law by littering.
- 3. The totality of the circumstances observed by Trooper Horan on the evening in question combined to give him probably cause to believe that the Defendant was operating his motor vehicle under the influence of alcohol and/or controlled substances. He therefore had probable cause to make an arrest on suspicion of violating those provisions of the motor vehicle code.

OPINION ON DEFENDANT'S OMNIBUS PRE-TRIAL MOTION

Presently, before this Court is Defendant's Omnibus Pre-Trial Motion seeking to suppress evidence obtained following a motor vehicle stop and Defendant's subsequent arrest on suspicion of DUI. Specifically Defendant challenges the Pennsylvania State Police Trooper's probable cause to stop the motor vehicle, as well as his probable cause to arrest the Defendant on suspicion of DUI. For the following reasons Defendant's Motion is denied.

FINDINGS OF FACT

 Trooper Justin Horan is a Pennsylvania State Police Trooper having three years of experience on the job. He received field sobriety test training while at the Pennsylvania State Police Academy. Subsequent to completion of the State Police Academy, Trooper Horan received his ARIDE Certification. Trooper Horan's training included the detection of clues and signs of both alcohol and drug intoxication.

- On March 26, 2018 Trooper Horan was on duty working the 10:00 p.m. to 6:00 a.m. shift. At approximately 1:00 a.m. Trooper Horan was on roving patrol in New Oxford Borough, Adams County, Pennsylvania.
- At approximately 1:00 a.m. Trooper Horan conducted a motor vehicle stop of a white Mitsubishi Lancer that was traveling south on Hanover Street in New Oxford Borough heading out of the Borough.
- 4. While following the white Mitsubishi Lancer Trooper Horan observed the operator throw a lit cigarette out of the window. The lit cigarette landed on Hanover Street. This occurred several blocks from the center square of New Oxford.
- Trooper Horan testified that he conducted his motor vehicle stop based upon the cigarette being thrown out of the moving vehicle.
- 6. Upon effectuating the motor vehicle stop Trooper Horan identified Defendant as the driver of the motor vehicle.
- 7. Upon interacting with Defendant Trooper Horan observed a strong odor of alcohol coming from the Defendant's breath. Defendant admitted that he was coming from Earle's Tavern at which location he had "two drinks."
- 8. Trooper Horan testified that Defendant's eyes were glassy and bloodshot and that Defendant exhibited slow and slurred speech. Trooper Horan also testified that Defendant was slow in retrieving his license and registration documentation.
- 9. Based upon Trooper Horan's observations of Defendant together with Defendant's admission to having recently consumed alcohol and the Trooper's detection of a strong odor of alcohol coming from the Defendant, Trooper Horan asked Defendant to exit the vehicle to perform field sobriety testing.
- 10. Trooper Horan administered four field sobriety tests beginning with the HGN test. No testimony was elicited with regard to the Defendant's performance on this test.
- 11. The next test administered was the walk and turn test. The Defendant was given instructions on how to complete the test and the test was demonstrated for him.

- 12. During Defendant's attempt to perform the test a number of clues of impairment were noticed. There was a slight issue of balance during the instructional phase. More importantly, Defendant missed heal to toe, raised his arms in order to maintain balance, took the wrong number of steps on the first nine and made an improper turn. He was noticeably unsteady and lacking balance, particularly during the time he was turning to complete the second nine steps.
- 13. Defendant was able to successfully complete the one leg stand test showing no clues of impairment.
- 14. The final test administered was the Romberg Balance test. This test is used to show indicators of drug usage. The test was demonstrated and explained for the Defendant. During his performance of the test, Defendant had slight swaying. Trooper Horan testified to significant eyelid tremors and instead of estimating 30 seconds as instructed, Defendant stopped at 57 seconds believing 30 seconds had elapsed.
- 15. According to the Trooper, Defendant's performance of the Romberg balance test indicated the possibility of drug usage.
- 16. Likewise, Defendant's performance on the walk and turn test indicated impairment due to alcohol consumption.
- 17. Based upon Defendant's performance on the walk and turn test and the Romberg Balance test as well as the Trooper's personal observations, and Defendant's admission to consuming alcohol, Defendant was placed under arrest on suspicion of driving under the influence.

ISSUE

- 1. Did Trooper Horan have probable cause to effectuate a motor vehicle stop?
- 2. Did Trooper Horan have probable cause to arrest Defendant on suspicion of driving under the influence of alcohol and/or controlled substances?

CONCLUSION OF LAW

- 1. Trooper Horan had probable cause to conduct the motor vehicle stop.
- 2. Considering the totality of the circumstances Trooper Horan had probable cause to arrest Defendant on suspicion of DUI.

DISCUSSION

In a suppression hearing, the Commonwealth has the burden to establish by a preponderance of the evidence the admissibility of those items the accused seeks to preclude. *Commonwealth v. Ruey*, 892 A.2d 802, 807 (Pa. 2006). Section 6308 of the Pennsylvania Motor Vehicle Code constitutionally permits an officer to stop a vehicle if the officer has reasonable suspicion that a provision of the Motor Vehicle Code has been violated. **75 Pa. C.S.A. § 6308(b)**; *Commonwealth vs. Sands*, 887 A.2d 261, 271-72 (Pa. Super. 2005). Reasonable suspicion exists if the police officer reasonably believes that the individual is engaging in criminal conduct. *Commonwealth v. Ulman*, 902 A.2d 514, 518 (Pa. Super. 2006).

The purpose of a stop based upon reasonable suspicion is to "allow immediate investigation through temporarily maintaining the status quo." *Commonwealth v. Chase*, 960 A.2d 108, 114-15 (Pa. 2008). To ensure that such a stop will serve its goal, the underlying offense must be one that is capable of further investigation. *Id.* at 115-16. Thus, in practice, police officers should apply two different standards to determine whether they have the constitutional authority to stop a vehicle. *See id.* at 116.

For offenses where "a post-stop investigation is normally feasible," such as driving under the influence of alcohol, police may use the lesser standard of reasonable suspicion. *Id.* However, where the offense is not "investigatory," such as in the case of speeding or failing to obey a traffic signal, the purposes of a Terry stop cannot be achieved, and an officer must have probable cause to make the vehicle stop constitutional. *Id.* In the case of a non-investigatory stop, the officer must "articulate specific facts possessed by him, at the time of the questioned stop, which would provide probable cause to believe that the vehicle or the driver was in violation of some provision of the Code." *Commonwealth v. Gleason*, 785 A.2d 983, 989 (Pa. 2001).

In this case while following Defendant's vehicle, Trooper Horan observed a lit cigarette being discharged from the window of the vehicle landing on the public roadway. That observation gave Trooper Horan probable cause to effectuate a motor vehicle stop. Specifically, his observations were that the operator or someone in the motor vehicle had violated the law by littering. Under Section

3709 of the Pennsylvania Motor Vehicle Code it is unlawful to throw or deposit upon any highway or other property from a vehicle any waste paper...refuse or rubbish.... 75 Pa. C.S.A. § 3709(a). Trooper Horan's observation of a cigarette butt being discharged from the vehicle onto the highway is a personally observed violation of that provision of the Motor Vehicle Code by the Trooper giving him probable cause to stop the motor vehicle.

Turning to the second issue, it is equally clear that Trooper Horan had probable cause to arrest the Defendant on suspicion of DUI.

Under Section 3811 of Pennsylvania's Motor Vehicle Code:

a police officer is authorized to arrest an individual without a warrant if the officer has probable cause to believe that the individual has violated section 1543(b)(1.1) (relating to driving while operating privilege is suspended or revoked), 3802 (relating to driving under the influence of alcohol or controlled substance) or 3808(a)(2) (relating to illegally operating a motor vehicle not equipped with ignition interlock), regardless of whether the alleged violation was committed in the presence of the police officer.

75 Pa. C.S.A. § 3811.

Probable cause exists when the officer has knowledge of sufficient facts and circumstances to warrant a prudent person to believe that the driver has been driving under the influence. *Commonwealth v. Angel*, 946 A.2d 115, 118 (Pa. Super. 2006). Probable cause justifying a warrantless arrest is determined by the totality of the circumstances. *Id.* Finally, probable cause does not involve certainties, but rather the factual and practical considerations of everyday life on which reasonably prudent persons act. *Id.*

In this case upon interacting with the Defendant, Trooper Horan observed a strong odor of alcohol coming from the Defendant. The Defendant admitted to having consumed "two drinks" and coming from Earle's Tavern immediately prior to the motor vehicle stop. The Trooper believed the Defendant's mannerisms were slow and lethargic with slightly slurred speech. While successfully completing some field sobriety testing, the Defendant also failed on others. A review of the MVR depicts Defendant's poor performance on the walk and turn test, specifically. Furthermore, Defendant's performance on the

Romberg Balance test indicated a strong possibility of drug usage. He demonstrated significant eyelid tremors and substantially delayed time estimation skills, which are precisely the deficits the test is designed to elicit from someone who has recently used a controlled substance.

Probable Cause is a lesser burden than the burden of proof necessary to sustain a conviction. Probable cause does not require proof of certainties sufficient on their own to sustain a conviction. The totality of the circumstances observed by Trooper Horan on the evening in question combined to give him probable cause to believe that the Defendant was operating his motor vehicle under the influence of alcohol and/or controlled substances. He therefore had probable cause to make an arrest on suspicion of violating those provisions of the motor vehicle code.

Accordingly, for all of these reasons, Defendant's Omnibus Pre-Trial Motion will be denied.

ORDER
