### NOTICE OF CONDEMNATION

In accordance with Section 305 of the Eminent Domain Code, 26 Pa.C.S. § 305, the Township of Cumberland, Adams County, Pennsylvania (the "Township"), hereby gives notice to the Ramesh S. Rao and Gitana Bradauskaite Revocable Agreement of Trust, dated April 7, 2016 ("Condemnee"), lessees of the property, mortgagees of record, and lienholders of record of the following:

- A Declaration of Taking was filed on August 17, 2021, in the Court of Common Pleas of the 51st Judicial District of Pennsylvania, Adams County, at the above-named term and number.
- Condemnor is a Township of the Second Class, organized and existing under the laws of the Commonwealth of Pennsylvania, with a business address of 1370 Fairfield Road, Gettysburg, Pennsylvania.
- The condemned property is located at 1380 Chambersburg Road, Gettysburg, Cumberland Township, Adams County, Pennsylvania, 17325 (the "Property").
- 4. The title owner in fee simple of the Property is the Ramesh S. Rao and Gitana Bradauskaite Revocable Agreement of Trust, dated April 7, 2016 ("Condemnee"). Condemnee's trustees are Ramesh S. Rao and Gitana Bradauskaite—who reside at 1249 Meetinghouse Road, North Wales, Pennsylvania 19454.
- The Deed whereby the Condemnee took title to the Property includes a full legal description of the Property and is recorded at Instrument #201600003982 in the Recorder of Deeds Office at the Adams County Courthouse.
- The Township is authorized to take the Property herein described pursuant to its power of eminent

- domain under the Second Class Township Code, 53 P.S. § 65101, et seq., and the Eminent Domain Code, 26 Pa.C.S. § 101, et seq.
- 7. The Township's actions were duly authorized by the adoption of Resolution No. 2021-11 (the "Resolution"), on July 27, 2021, by the Board of Supervisors of Cumberland Township. The Resolution and proceedings associated with the adoption of the Resolution may be examined at the Township municipal offices located at the above stated address.
- 8. The public purpose of this condemnation is to enable the Township to ensure the long-term care, maintenance, and viability of the cemetery located on the Property, known as, Oak Lawn Memorial Gardens and to protect the public health, safety, and welfare against deterioration and degradation of the same.
- The nature of the title acquired in and to the condemned Property is a fee simple absolute title.
- The Property is not depicted on a plan in the Recorder of Deeds office for Adams County but is identified as Parcel ID # 09E12-0079---000 in the Adams County Tax Parcel Viewer system.
- 11. A total amount of just compensation in the amount of \$1.00 shall be made to Condemnee. Pursuant to 26 Pa.C.S. §§ 302(b)(8) and 303(b), the payment of just compensation is secured by funds raised or authorized by law to be raised by the power of taxation of the Condemnor, Township. Condemnor is therefore not required to file a bond with the Declaration of Taking to secure just compensation.
- Notice of the condemnation is hereby provided to the Condemnee who is the record title holder of the Property. Additionally, notice is hereby provided to all mortgagees of record and all lienholders of record.
- 13. If the Condemnee wishes to challenge the power or right of the Township to appropriate the condemned property, the sufficiency of the security, the procedure followed by the Condemnor, or the Declaration of Taking, Condemnee

must file preliminary objections within thirty (30) days after being served with this Notice of Condemnation.
