He taught the Basic Trial Advocacy Skills Course for many years at the Department of Justice's National Advocacy Center in Columbia, South Carolina.

Judge Arteaga served in the United States Marine Corps with 2d Battalion, 2d Marine Regiment, 2d Marine Division, Fleet Marine Force, and has multiple overseas deployments to his credit. Following his completion of Mortar Gunnery School at Marine Corps Base Camp Lejeune, North Carolina, Judge Arteaga was promoted to section leader of his rifle company's mortar section and was responsible for operation of the section's Fire Direction Center. He received numerous awards for outstanding performance of duty, including a Certificate of Commendation from the Commanding General, Fleet Marine Forces - Pacific, and was meritoriously promoted to noncommissioned officer after his first overseas deployment. Judge Arteaga was honorably discharged in 1988.

Nodecker v. Prokay et al. Constitutional Law – Section 1983 – Jurisdiction

Commonwealth Court had original jurisdiction over Section 1983 claim brought in state court seeking declaratory and injunctive relief against state officials in their official capacities.

OPINION

The matters before the court are the preliminary objections by moving defendants¹ to the amended complaint filed by Plaintiff John Nodecker. Except for defendant Donna Prokay, who remains unrepresented in her individual capacity and who has not participated in litigation, the parties have timely filed their briefs in support of and opposition to the objections and participated in oral argument. This matter is ripe for review. Because plaintiff has plead a claim for prospective injunctive and declaratory relief against former Secretaries of Education for the Commonwealth, this matter will be transferred to Commonwealth Court.²

Defendants raised numerous objections, but this court's jurisdiction is a threshold matter. The General Assembly has given the Commonwealth Court original jurisdiction over suits against the Commonwealth government, including actions against its officials who are acting in an official capacity. 42 Pa. C.S. § 761(a). For the reasons stated below, the preliminary objection of the PDE Defendants concerning this court's jurisdiction over the case are sustained and this court cannot consider the remaining defendants' objections. This case shall be transferred to the Commonwealth Court.

I. BACKGROUND

Plaintiff John Nodecker became superintendent of Manheim Township School District in July 2014. Am. Compl. ¶ 14. He alleges the School District, along with Bill Murry, Mark Anderson, Kathy Setlock, Donna Prokay, and Jane/John Does 1–3, made accusations of gender and age-based discrimination against him. *Id.* ¶ 16. Investigations determined these allegations to be meritless. *Id.* ¶ 17. Thereafter, Nodecker entered into a separation agreement with the School District on January 26, 2016. *Id.* ¶ 18. A review of his employee file showed that 1 Bill Murry, Mark Anderson, and Kathy Setlock each filed preliminary objections in their individual capacities to Mr. Nodecker's amended complaint. Manheim Township School District, on its own behalf and on behalf of Donna Prokay, Bill Murry, Mark Anderson, Kathy Setlock, and John/Jane Does 1–3 in their professional capacities, filed objections to the amended complaint. Pennsylvania Department of Education

professional capacities, filed objections to the amended complaint. Pennsylvania Department of Education defendants Noe Ortega, Eric Hagarty, and Angela Riegel ("PDE Defendants") filed objections to the amended complaint. Plaintiff has responded to all filed objections.

2 Plaintiff styles the claim as an "individual capacity" claim pursuant to 42 U.S.C. § 1983, but plaintiff

seeks no monetary damages but rather seeks injunctive and declaratory relief. Accordingly, it is an official capacity claim, not an individual capacity claim.

no "disciplinary actions or charges had ever been made by the district concerning [Nodecker], including gender/age-related harassment." Id. The agreement released all "claims for or because of any and all acts or omissions [of the School District] directly or indirectly related to Nodecker" through the date of the agreement. Nodecker states entering the release agreement would be illegal if he had truly engaged in such conduct. Id. ¶ 20.

In December 2016, Nodecker received notice from the Pennsylvania Department of Education that an Educator Misconduct Complaint had been initiated against him under the Educator Discipline Act. *Id.* ¶ 19. Section 2070.17b(a) of the Act states that "all information relating to any complaints or any proceedings relating to or resulting from such complaints, including the identity of the complainant, shall remain confidential, unless or until discipline is imposed." Releasing confidential information without authorization is a third-degree misdemeanor. *Id.* § 2070.17b(b). However, the Commission that investigates misconduct claims "may order the release of confidential information upon petition of any interested party when it is just and proper." *Id.* § 2070.17b(e).

Nodecker alleges that the School District's employees and board members initiated the educator misconduct complaint against him. Am. Compl. ¶ 19. Nodecker defended against the complaint for nearly five years, until the PDE determined no cause existed for the allegations in March 2021. *Id.* ¶¶22–23. Nodecker did not request the confidential information about his case be released by the PDE commission overseeing his case pursuant to Section 2070.17b(e); instead, he filed a right to know request. Right to Know Officer Riegel denied Nodecker's right to know request on August 27, 2021, citing to the Educator Discipline Act. *Id.* ¶¶ 24, 28.

Nodecker filed this amended complaint on October 31, 2022. Relevant here, he brought a constitutional tort claim under 42 U.S.C § 1983 against defendants Eric Hagarty, Noe Ortega, and Angela Riegel in their individual capacities. Defendants Ortega and Hagarty were also sued as policymakers under *Monell v. New York Department of Social Services*, 436 U.S. 658 (1978). The amended complaint alleges PDE Defendants' enforcement of the Educator Discipline Act's confidentiality requirements "without any exception" was unconstitutional in his case. Id. ¶ 29.

Nodecker argues the Act, as applied to him, violated his rights to free speech because School District Defendants are using the Act's confidentiality provisions to prevent him from speaking about his experience of malicious prosecution by subjecting him to criminal penalties for such speech in perpetuity. *Id.* ¶¶ 29–30. The enforcement of the Act also violated his right to seek redress of grievances because he cannot discuss details of the investigation and is thereby precluded from petitioning to the government for a redress of grievances against the School District, its employees, and its board members. *Id.* Nodecker requests this court declare the Act's confidentiality provision unconstitutional as applied to him, to enjoin defendants from enforcing the Act's con-

fidentiality provisions against him, and to order the PDE Defendants to disclose who made an educator misconduct complaint against him. *Id.* ¶ 70.

II. DISCUSSION

Section 1983 claims may be brought in federal courts before a United States District Court Judge or in state courts, which are subject to state jurisdictional requirements. In Pennsylvania, the Commonwealth Court has original jurisdiction over cases against the Commonwealth and its officials acting in their official capacities. 42 Pa. C.S. § 761(a). Plaintiff does not dispute that Defendants Hagarty and Ortega are officers of the Commonwealth, but rather argues this court has jurisdiction because the defendants are sued under federal law in their individual capacities and as policymakers pursuant to Monell v. New York Department of Social Services, 436 U.S. 658 (1978). Plaintiff's reliance on Monell is misplaced. Monell permits local government defendants to be sued in their official capacities as policymakers when an official government custom or policy is alleged to be responsible for a constitutional deprivation. 436 U.S. at 690. Plaintiff's pleadings do raise interesting issues because federal law makes clear that the Eleventh Amendment to the United States Constitution bars actions against state officials in their "official capacity" because the effect is to sue the state. However, "the Eleventh Amendment does not generally bar prospective declaratory or injunctive relief." O'Callaghan v. Hon. X, 661 F. App'x 179, 182 (3d Cir. 2016).

Here, plaintiff pleads his 1983 claim against the former secretaries of the Department of Education in their individual capacities, but not in the sense of acting outside of the scope of their authority as the Secretary of Education. Nodecker seeks declaratory and injunctive relief against the former secretaries in what is really plead as an official capacity claim under 1983 for injunctive relief and not for monetary damages. The Commonwealth Court has original jurisdiction.

III. CONCLUSION

For the reasons stated above, plaintiff's amended complaint includes allegations against PDE Defendants in their official capacities for injunctive and declaratory relief, and the Commonwealth Court has original jurisdiction over this matter. The case shall be transferred to the Commonwealth Court. An appropriate order follows.
