Crowell vs. PSX, Inc, et al

Preliminary objections - Fact-pleading - Reckless conduct - Verification

- 1. Pennsylvania is a fact-pleading state. Pursuant to Pa.R.C.P. 1019(a), a plaintiff is required to set forth the material facts upon which a cause of action is based. Material facts are ultimate facts, *i.e.*, those facts essential to support the elements of a claim.
- 2. The purpose of this rule is to give the defendant notice of what the plaintiffs' claim is and the grounds upon which it rests, thereby allowing the defendant to adequately prepare a defense.
- 3. Allegations in a complaint which fail to satisfy Pennsylvania's fact-pleading standard are subject to dismissal by a trial court.
- 4. Alleging that the defendant failed to use due care under the circumstances is simply an overly broad, catch-all averment that fails to sufficiently describe what the defendant did or did not do to cause the plaintiff's injury.
- 5. Pennsylvania courts view vague and all-inclusive language in a pleading with disfavor.
- 6. A plaintiff does not state material facts by alleging that the defendant was negligent as a matter of law as such an averment is nothing more than a legal conclusion, that is, a statement of a legal duty without stating the facts from which the duty arises.
- 7. A conclusion of law has no place in a pleading.
- 8. A plaintiff does not conform to Pennsylvania's fact-pleading standard by alleging that the defendant's negligence consists of certain as-yet-to-be-discovered facts which may be in the possession of the defendant.
- 9. A defendant's conduct is properly characterized as reckless where the defendant knows, or has reason to know, of facts which create a high degree of risk of physical harm to another, and deliberately proceeds to act, or to fail to act, in conscious disregard of, or indifference to, that risk.
- 10. In examining the legal sufficiency of a complaint, a court must draw all reasonable inferences from the alleged facts in favor of the non-moving party.
- 11. In this negligence action, plaintiff alleged he sustained personal injuries in a motor vehicle accident caused by the defendant driver's failure to bring his vehicle to a stop while he drove directly behind plaintiff's vehicle. Plaintiff alleged that defendant's negligence consisted of, *inter alia*: "failure to use due care under the circumstances"; "negligence as a matter of law"; and "negligence as may be proven from facts now exclusively in the possession of Defendants, which may be ascertained after the filing of this complaint." Defendants moved to strike these allegations by preliminary objection, asserting that they did not satisfy the fact-pleading requirements embodied in Pa. R.C.P. 1019(a). The court sustained that objection. Defendants further contended that the facts asserted against the defendant driver were legally insufficient to qualify as reckless conduct. The

Court found the conduct ascribed to the driver could plausibly qualify as reckless conduct, and, accordingly, defendants' objection on that basis was overruled. Defendants sought dismissal of the complaint because the verification was signed by counsel rather than plaintiff; however, because plaintiff filed a new verification document which contained plaintiff's signature, this objection was overruled as moot.

ORDER

AND NOW, this 26th day of October, 2020, upon consideration of Defendants' Preliminary Objections to Plaintiff's Amended Complaint and Plaintiff's Response thereto, it is hereby **ORDERED** and **DECREED** as follows:

- Defendants' Preliminary Objection in the nature of a motion to strike Paragraphs 31(h), (i), and (l) from the Amended Complaint is SUS-TAINED as said paragraphs are STRICKEN from the Amended Complaint with prejudice;
- 2. Defendants' Preliminary Objection in the nature of a motion to strike the terms "recklessly," "recklessness," and "reckless" as stated in Paragraphs 31, 33 37 and 41 of the Amended Complaint is **OVERRULED**; and
- 3. Defendants' Preliminary Objection for improper verification pursuant to Pa. R.C.P. 1024 is **OVERRULED** as moot.

It is further **ORDERED** that Defendants are granted leave to file an Answer to the Amended Complaint within twenty (20) days of the entry of this Order on the docket.¹

This action comes to the Court by way of a transfer of venue from Philadelphia County following the filing of preliminary objections by Defendants PSX, Inc. and Christopher Halliday (collectively, "Defendants") to Plaintiff Mark Crowell's ("Plaintiff") amended complaint. Instantly, Defendants raise preliminary

objections in the nature of motions to strike as well as an objection to the verification document Plaintiff pursuant Pa. R.C.P. 1024. Upon review, the objections are sustained in part and overruled in part, as more fully explained below.

This is a negligence action in which Plaintiff alleges that he sustained personal injuries in a motor vehicle accident caused by Defendant Halliday's failure to "bring his vehicle to a stop" while he drove directly behind Plaintiff's vehicle on State Route 202 in East Whiteland Township, Chester County. In paragraph 31 of the amended complaint, Plaintiff alleges that Halliday's negligence consisted of, inter alia: "Failure to use due care under the circumstances"; "Negligence as a matter of law"; and "Negligence as may be proven from facts now exclusively in the possession of [D]efendants, which may be ascertained after the filing of this complaint." See, Amd. Compl., at ¶¶ 31(h), (i), (l). Defendants move to strike these allegations, asserting that they do not satisfy the fact-pleading requirements embodied in Pa. R.C.P. 1019(a) and Pennsylvania case authority.

It is black-letter law that Pennsylvania is a fact-pleading state. See, e.g., Briggs v. Sw. Energy Prod. Co., 224 A.3d 334, 351 (Pa. 2020). Pursuant to Pennsylvania Rule of Civil Procedure 1019(a), a plaintiff is required to set forth the "material facts" upon which a cause of action is based. Ibid. Material facts are "ultimate facts," i.e., those facts essential to support the [elements of a] claim." Smith v. Wagner, 588 A.2d 1308, 1310 (Pa. Super. 1991) (cleaned up). The purpose of this rule is to "give the defendant notice of what the plaintiffs' claim is and the grounds upon which it rests," thereby allowing the defendant to adequately prepare a defense. Sevin v. Kelshaw, 611 A.2d 1232, 1235 (Pa. 1992). Allegations in a complaint which fail to satisfy Pennsylvania's fact-pleading standard are subject to dismissal by a trial court. See, Pa. R.C.P. 1028(a)(3) (Directing that a party may file a preliminary objection for "insufficient specificity in a pleading.").

Here, each of the paragraphs objected to by Defendants fail to conform to Pennsylvania's fact-pleading requirement. For starters, contrary to Plaintiff's argument, merely because Pennsylvania case law has described the term "negligence" as a "want of due care under the circumstances" does not mean that a plaintiff pleads a claim for negligence with the requisite specificity by alleging that the defendant "failed to use due care under the circumstances." <u>Amd. Compl.</u>, at ¶ 31(h). There is simply no escaping the fact that the use of such a phrase in a complaint constitutes an overly broad "catch-all" averment that fails to sufficiently describe what the defendant did or did not do to cause the plaintiff's injury. See, e.g., Philadelphia HGI Assocs., L.P. v. Cope Linder Assocs., 2001 WL 1807792, at *2 (Pa. Com. Pl. 2001) ("[B]road and general assertions do not allow [a defendant] to prepare a defense and therefore do not meet Pennsylvania's specificity requirements."); Flurer v. Pocono Med. Ctr., 15 Pa. D. & C.4th 645, 671 (Com. Pl. 1992) ("Pennsylvania courts view ... vague and all-inclusive language" in a pleading "with disfavor."). In similar fashion, a plaintiff does not state material facts under Pa. R.C.P. 1019(a) by alleging that the defendant was "negligent as a matter of law." Amd. Compl., at ¶ 31(i). This averment is nothing more than legal conclusion—that is, "a statement of a legal duty without stating the facts from which the duty arises." Mellon Bank, N.A. v. Nat'l Union Ins. Co. of Pittsburgh, 768 A.2d 865, 869 n. 1(Pa. Super. 2001) (citation omitted) (emphasis added). And it has long been the rule that "[a] conclusion of law has no place in a pleading." Ibid. (emphasis added). Finally, a plaintiff does not conform to Pennsylvania's fact-pleading standard by alleging that the defendant's negligence consists of certain as-yet-to-be-discovered "facts" which may be in the possession of the defendant. Amd. Compl., at ¶ 31(1). Whatever else might be said of facts or information exclusively within a defendant's possession, this type of forward-looking averment has repeatedly been disapproved under Pennsylvania law. See, Mitchell v. Remsky, 39 Pa. D. & C.4th 122, 125 (Com. Pl. 1998) (Holding that the allegation 'Such other acts of negligent conduct ... as shall be discovered during the course of ... discovery' represents "an improper attempt by the plaintiff to preserve all unpleaded theories of liability against the moving defendants."). Accordingly, for the forgoing reasons, Defendants' objection in the form of a motion to strike paragraphs 31(h), (i), and (l) is sustained and said allegations are stricken from the amended complaint with prejudice.

Defendants next move to strike Plaintiff's use of the descriptors "recklessly," "recklessness," and "reckless" from paragraphs 31, 33 – 37 and 41 of the amended complaint. Defendants contend that the facts asserted against Defendant Halliday in the amended complaint are legally insufficient to qualify as "reckless conduct" under Pennsylvania law.

Plaintiff's amended complaint essentially alleges that Defendant Halliday struck the rear of Plaintiff's vehicle because Halliday failed to "maintain a safe distance" and was following Plaintiff's vehicle "more closely than was reasonable and prudent," thereby causing a rear-end collision as the parties' vehicles were "halted by roadwork activity" ahead of them on State Route 202. <u>Amd. Compl.</u>, at ¶¶ 12, 31(a), 41.

In Pennsylvania, a defendant's conduct is properly characterized as reckless where the defendant

knows, "or has reason to know, of facts which create a high degree of risk of physical harm to another, and deliberately proceeds to act, or to fail to act, in conscious disregard of, or indifference to, that risk." Daniel v. Wyeth Pharm., Inc., 15 A.3d 909, 929–30 (Pa. Super. 2011) (cleaned up); see also, Tayar v. Camelback Ski Corp., 47 A.3d 1190, 1200 (Pa. 2012) (Stating that "recklessness requires conscious action or inaction which creates a substantial risk of harm to others[.]"). The Court finds that the conduct ascribed to Defendant Halliday in Plaintiff's amended complaint could plausibly qualify as "reckless conduct" under Pennsylvania law. In examining the legal sufficiency of a complaint, a court must draw all reasonable inferences from the alleged facts in favor of the non-moving party. Sullivan v. Chartwell Inv. Partners, LP, 873 A.2d 710, 720 (Pa. Super. 2005). Here, the inferences to be drawn from the act of following a vehicle too closely on a roadway runs the gambit of inattentive driving to purposeful tailgating. The Court draws the latter inference for purposes of Defendants' objection. Purposefully tailgating a vehicle on a roadway arguably amounts to reckless conduct, particularly because driving in an area of "roadwork activity" generally calls upon drivers in Pennsylvania to exercise a heightened degree of care while operating a motor vehicle. See, e.g., <a href="Freethy v. Goike, 2011 WL 7177007 (Pa. Com. Pl. Sep. 09, 2011). Accordingly, Defendants' objection on this basis is overruled.

Finally, Defendants call for dismissal of the amended complaint based on the verified pleading requirements set forth in Pa. R.C.P. 1024. This objection was not addressed in the "Agreed to Order" entered in Philadelphia County and therefore must be decided by this Court. Specifically, Defendants assert that the amended complaint is defective because the verification document was not signed by Plaintiff, but instead by his legal counsel. However, in response to this objection, and prior to this action being transferred to Chester County, Plaintiff filed a new verification document which contains Plaintiff's signature. Accordingly, Defendants' final objection is overruled as moot.
