OPINION AND ORDER

WAGNER, P.J.

Before the Court is Petitioner's untimely second PCRA petition filed on July 19, 2017, wherein were raised the issues of ineffective assistance of counsel and an illegal sentence. No attorney was appointed in this matter since the issues raised in the said second petition did not necessitate an evidentiary hearing. See Commonwealth v. Kubis, 808 A.2d 196 (Pa.Super.2002) and Pa.R.Crim.P. 904(D).

Petitioner, represented by counsel employed in the Office of the Fayette County Public Defender, entered a guilty plea on January 30, 2009 to charges of Possession of Firearm Prohibited, 18 Pa.C.S. § 6105 (a)(1); Receiving Stolen Property, 18 Pa.C.S. § 3925; Firearms Not to be Carried without a License, 18 Pa.C.S. § 6106; and Manufacturing/Delivery/Possession with Intent to Deliver, 35 P.S. 780-113 § (a)(30). He was sentenced by this Court to a term of imprisonment of five (5) to ten (10) years on February 9, 2009. His judgment of sentence became final on March 11, 2009, thirty days later since no appeal was taken, and thus Petitioner had until March 11, 2010 to file a timely second PCRA petition. 42 Pa.C.S. §9545; Commonwealth v. Taylor, 67 A.3d 1245 (Pa.2013).

Upon receipt of the untimely petition, the Court promptly reviewed the same in light of the record of this case and concluded that Petitioner has raised no issues which necessitate an evidentiary hearing, and no issues which fall within the purview of one of the exceptions to the PCRA statute's timeliness mandate. See Rule 907 Notice. The Rule 907 Notice sent to Petitioner on May 8, 2017, explained the Court's intention to dismiss the petition without a hearing, unless Petitioner filed a response within twenty days, alleging sufficient facts to demonstrate that a genuine issue of material fact exists.

As explained in the Notice sent to him, ineffectiveness of counsel is not an exception to the mandate of timeliness in the filing of a PCRA petition. See 45 Pa.C.S. § 9545. Likewise, Petitioner's claim that his sentence is "too high," and therefore illegal, is also untimely and barred by the timeliness requirement of the PCRA. See Commonwealth v. Slotcavage, 939 A.2d 901, 903 (Pa.Super.2007). Statutory time limitations are

mandatory and must be interpreted to mean exactly what they state. This Court has no authority to extend any filing periods except as permitted by the statute and no jurisdiction to consider the merits of any untimely petition. "Though not technically waivable, a legality [of sentence] claim may nevertheless be lost should it be raised for the first time in an untimely PCRA petition for which no time-bar exception applies, thus depriving the court of jurisdiction over the claim." Id.; see also Commonwealth v. Fahy, 558 Pa. #13, 737 A.2d 214 (1999).

The instant second PCRA petition is untimely on its face, and no facts are asserted therein or in Petitioner's Rule 907 Response which bring it within the purview of one of the exceptions to the timeliness requirement, nor has the said Response demonstrated to this Court that there are any evidentiary issues which require a hearing. This Court, therefore, is without jurisdiction to consider the petition any further.

Accordingly, this Court enters the following:

ORDER

AND NOW, August 24, 2017, the within untimely second PCRA petition is hereby dismissed for lack of jurisdiction.
