Dakota Oil Processing, LLC v. Hayes, et al.

Civil Action – Professional negligence – Preliminary objectives – General personal jurisdiction – Specific personal jurisdiction

- Personal jurisdiction may be exercised over a defendant under two alternative theories: general, or all-purpose jurisdiction, and specific, or case-linked jurisdiction.
- 2. General jurisdiction permits a party to be sued in any state forum for any claim, regardless of where the actions underlying the claim occurred.
- 3. For general jurisdiction to be present, the defendant must be considered at home in the forum state.
- 4. In contrast to general jurisdiction, specific jurisdiction is narrowly confined to adjudication of issues deriving from, or connected with, the very controversy that establishes jurisdiction. When there is no such connection, specific jurisdiction is lacking regardless of the extent of a defendant's unconnected activities in the forum state.
- 5. Pennsylvania authorizes its courts to exercise general personal jurisdiction over an individual defendant by demonstrating one of the following: (a) presence in the Commonwealth at the time when process is served; (b) domicile in the Commonwealth at the time when process is served; or (c) consent, to the extent authorized by the consent.
- 6. A Pennsylvania tribunal may exercise general personal jurisdiction over limited partnerships and similar entities on the basis of consent or formation or qualification as a foreign entity under the laws of this Commonwealth.
- 7. The phrase "qualification as a foreign entity under the laws of this Commonwealth" means that the foreign entity is registered to do business in Pennsylvania.
- 8. Pennsylvania may also exercise general personal jurisdiction over such business entities if they carry on a continuous and systematic part of their general business within Pennsylvania.
- Exercising general personal jurisdiction over a corporation comports with due
 process only when the corporation's affiliations with the State in which suit is
 brought are so constant and pervasive as to render it essentially at home in the
 forum State.
- 10. Absent exceptional circumstances, a corporation only is at home where it is incorporated or where it has its principal place of business.
- 11. Subjecting a corporation to general personal jurisdiction in every state where it engages in a substantial, continuous, and systematic course of business would be unacceptably grasping.
- 12. A Pennsylvania tribunal may not exercise general personal jurisdiction over a corporation or similar entity which carries on a continuous and systematic part of its general business within this state, unless those business activities are so constant and pervasive that they render Pennsylvania tantamount to the entities' state of formation/incorporation or principal place of business.

- 13. Determining whether a Pennsylvania court may exercise specific personal jurisdiction over a foreign defendant requires a two-step analysis. First, the requirements under Pennsylvania's long-arm statute must be satisfied, and second, the exercise of jurisdiction must comport with due process.
- 14. Pennsylvania's long-arm statute authorizes courts to exercise specific personal jurisdiction over a nonresident defendant to the fullest extent allowed under the Constitution of the United States and may be based on the most minimum contact with this Commonwealth allowed under the Constitution of the United States.
- 15. Specific jurisdiction allows a court to adjudicate claims which arise from activity that occurs within the forum state's borders.
- 16. Three requirements must be satisfied for a court to exercise specific jurisdiction over a nonresident defendant: (a) the defendant must have purposefully availed itself of the privilege of conducting activities within the forum State or have purposefully directed its conduct into the forum State; (b) the plaintiff's claim must arise out of or relate to the defendant's activities in the forum state; and (c), jurisdiction must be fair and reasonable so as not to offend tradition notions of fair play and substantial justice.
- 17. A party's use of interstate facilities such as phone and email are relevant factors in the personal jurisdiction analysis.
- 18. Unless the content of the defendant's communication is the basis for the cause of action asserted by the plaintiff, minimal correspondence between a nonresident defendant and the forum lacks the substantiality necessary to justify the exercise of specific in *personam* jurisdiction.
- 19. Whether a nonresident defendant's use of facilities such as phone or email is sufficient to justify the exercise of specific jurisdiction must also be considered in light of the context in which the communications occurred. For jurisdiction to be proper, it is critical that the defendant avail himself of the privilege of conducting activities in the forum state and that it is not merely the result of unilateral activity on the part of a third person or another party.
- 20. Due process requires that a defendant be hauled into court in a forum State based on his own affiliation with the State, not based on the attenuated contacts he makes by interacting with other persons affiliated with the State.
- 21. The relatedness requirement for specific jurisdiction requires, at a minimum, a direct causal connection between a defendant's contacts with the forum state and the plaintiff's claims.
- 22. The relatedness requirement is animated by a tacit *quid pro quo*—in return for conducting activities in a forum and benefitting from its laws and protections, non-citizens must submit to the forum's jurisdiction over claims that arise from those activities.
- 23. When a plaintiff points to a phone call or other correspondence as a forum-based contact upon which to predicate specific jurisdiction, the content of the communication itself must give rise to the plaintiff's claim in order to satisfy the relatedness requirement.

24. Moving defendants filed preliminary objections to plaintiff's amended complaint alleging a lack of *in personam* jurisdiction by the Court. The Court *Held*, that the preliminary objections were sustained and dismissed the amended complaint with prejudice as to defendants Jeffry L. Hardin and Locke Lord, LLP.

MEMORADUM OPINION & ORDER

This is a professional negligence, breach of contract, and breach of fiduciary duty action brought by Plaintiff Dakota Oil Processing, LLC ("Dakota") against Defendants Christopher G. Hayes, The Law Office of Christopher G. Hayes, Jeffry L. Hardin ("Hardin"), and Locke Lord, LLP ("Locke Lord"). Presently before the Court are Hardin and Locke Lords' ("Moving Defendants") preliminary objections to Dakota's amended complaint for lack of *in personam* jurisdiction. For the reasons that follow, the objections are sustained and the amended complaint is dismissed as to Moving Defendants with prejudice.

Factual Background

This action arises out of Dakota's loss of a \$2.5 million escrow payment. The facts of the case, as gleaned from the amended complaint, are as follows: Dakota is a limited liability partnership formed in the state of North Dakota with a principal place of business located in Manasquan, New Jersey. Dakota was formed for the purpose of developing, constructing, and operating a "crude oil topping refinery" near the unincorporated community of Trenton, North Dakota. In August of 2016, Dakota entered into a "collateral transaction loan" agreement with Cal & Schwartz—a venture financing firm based out of Bermuda—to raise capital in order to finance the refinery. Pursuant to the loan agreement Dakota agreed to pay Cal & Schwartz \$2.5 million if Cal & Schwartz secured a \$500 million "standby letter of credit" on Dakota's behalf through HSBC bank. The agreement required

Dakota to deposit its payment to Cal & Schwartz into an escrow account pending issuance of the letter of credit. Ultimately, Dakota intended for a third-party to utilize the letter as collateral to lend it funds to develop the refinery. See, Compl., at 11 - 13.

The loan agreement initially identified the law office of Emile Barton, a New York attorney, as the parties' escrow agent. However, "[o]n or around August 18, 2016, [Cal & Schwartz] informed Dakota that it required [Attorney Christopher] Hayes¹ to replace Attorney Barton as escrow agent in order to proceed with the [l]oan." Id., 23. Shortly thereafter Dakota retained Locke Lord, LLP, a law firm headquartered in Dallas, Texas, "to negotiate the terms of the escrow arrangement with Attorney Hayes, among other things." Id., 24. Jeffry L. Hardin, an "of counsel" attorney in Locke Lord's Washington D.C. office, represented Dakota in the transaction.

Attorney Hayes ("Hayes") is an individual licensed to practice law in Pennsylvania. Between September 14 and September 28, 2016, Hardin, on behalf of Locke Lord, communicated with Hayes regarding Hayes' potential role as escrow agent in Dakota's loan transaction with Cal & Schwartz. These communications consisted of the following: (1) Hardin advising Hayes of an "authentication process" whereby Hayes would confirm that Dakota had received a minimum amount of funding under the letter of credit prior to the release of Dakota's escrow payment to Cal & Schwartz; (2) Hardin and Hayes discussing whether Dakota's escrow payment could be held in Hayes' Pennsylvania IOLTA account pending its release to Cal & Schwartz; and (3) Hardin advising Hayes that Hayes needed to perform "legal services" on Dakota's behalf "in order to be covered by [Hayes' malpractice] insurance" during the escrow transaction.² See, Id., at Exs. H – I. Hardin stated in the same email that he believed Hayes' IOLTA account "contemplates [the existence of] an attorney-client relationship," and that he wanted to discuss with Hayes "the possibility of [Dakota] engaging you as its attorney" for purposes of the loan transaction. Id., Ex. H.

Dakota and Cal & Schwartz executed a revised collateral transaction loan agreement on September 13 and 26, 2016, respectively. On September 28, 2016, Hayes executed the agreement.³ The following day Hayes sent Hardin a confirmatory email in which he stated: "To confirm, as per the agreement, I am acting as the escrow attorney for the signed parties." <u>Id.</u>, Ex. J.

The revised loan agreement sought to ensure that Dakota received at least \$5 million in initial funding under the letter of credit prior to Hayes' release of Dakota's escrow payment to Cal & Schwartz. The agreement provided in relevant part:

Only upon the issuance of a confirmation of receipt by [Dakota's] Bank of [\$5 million in initial funding under the loan agreement] and receipt by [Hayes] of such confirmation (such conformation shall be sent by [Dakota's] Bank to [Hayes] and copied to [Dakota] and [Cal & Schwartz]), [Hayes] shall immediately issue disbursement instructions to [his bank] to pay [Cal & Schwartz] on behalf of [Dakota] the sum of [\$2.5 million] from [Hayes] [e] scrow [d]eposit [a]ccount.

Id., Ex. F, 5.

On September 30, 2016, Dakota funded the escrow payment by depositing \$2.5 million into Hayes' IOLTA account. On November 2, 2016, a representative of Dakota contacted Hardin in order to validate "that the [escrow] funds remain in the account." Id., Ex. K. However, on November 3, 2016, "Dakota discovered that Attorney Hayes had released the [e]scrow payment without authorization, and without confirmation that Dakota had received any funding under the [loan agreement]." Id., 37. Dakota alleges that it lost its entire escrow payment as a consequence, and never received any funding under the letter of credit.

Procedural History

Dakota instituted this action by writ of summons on October 15, 2018. On January 2, 2019, an amended complaint was filed setting forth claims against Moving Defendants for professional negligence, breach of contract, and breach of fiduciary duties. On January 22, 2019, Moving Defendants filed preliminary objections asserting lack of personal jurisdiction. They also submitted supporting affidavits.⁴ Dakota opposed the objections by way of responses filed February 11, 2019. On April 1, 2019, Moving Defendants filed briefs in support of their objections. On June 19, 2019, this Court entered an order stating that "an evidentiary record should be created prior to resolution of [Moving] Defendants' objections." Ord., 6/19/19 at 1, fn. 2; see also, Pa. R.C.P. 1028(c)(2) (Providing that a trial court "shall consider evidence by depositions or otherwise" to determine preliminary objections raising issues of fact). Accordingly, the order granted the parties 60 days within which to conduct discovery "regarding whether this Court may exercise *in personam* jurisdiction over [Moving] Defendants." Ord., 6/19/19 at 1.⁵

Summary of Discovery Record

Hardin was deposed by Dakota's counsel on October 22, 2019. At his deposition, Hardin testified that he was initially engaged by Dakota in the spring of 2016 to represent it in an unrelated matter, but that the scope of his representation later expanded, in August, to include "the financing transaction Dakota ... was pursuing" with Cal & Schwartz. Dep., p. 19:12-14. Hardin's services consisted of "reviewing" the revised collateral transaction loan agreement between Dakota and Cal & Schwartz as well as the terms of a secured promissory note Dakota entered into with a separate entity, the Mark Gulis 2001 Trust, in order to fund the \$2.5 million escrow payment. Id., p. 23:1-21; see also, Compl., at Ex. L. When Dakota's counsel asked Hardin whether he had "any contact with Pennsylvania in connection with" his representation of Dakota, Hardin answered: "My contact with Pennsylvania involved telephone calls to Chris Hayes and his insurance broker." Dep., p. 29:16-24.6 Hardin denied knowing that "Mr. Hayes' [insurance] broker was located" in Pennsylvania, or that Hayes' malpractice insurance coverage "was issued pursuant to Pennsylvania law[.]" Id., p. 31:6-18.

Dakota's counsel also queried Hardin regarding the use of Hayes' Pennsylvania IOLTA account as the banking depository for Dakota's escrow payment, as well the manner in which Hardin concluded that Hayes needed to be Dakota's attorney for purposes of the escrow transaction.⁷ Hardin acknowledged that Pennsylvania was "the jurisdiction where Christopher Hayes' IOLTA account [was] located," Id., p. 29:1-3, and that Pennsylvania has regulatory authority over such accounts. See, Id., p. 29:4-6. He further acknowledged "investigating IOLTA account requirements" during the course of his representation of Dakota. Id., p. 37:2-3. However, he denied conducting any research regarding "what state law would govern an attorney/client relationship between" Haves and Dakota, Id., p. 33:6-9, and stated that he could not recall whether the IOTLA account requirements he researched were specific to Pennsylvania. See, Id., pp. 37:4-6; 38:5-12. When pressed by Dakota's counsel to explain why he referred to "Pennsylvania law" in an email to Dakota's officers addressing the possibility of making a claim under Hayes' malpractice insurance, Hardin stated: "Chris Hayes is a Pennsylvania attorney. That's what implicated Pennsylvania law, what laws, what rules govern the handling of an escrow amount by a Pennsylvania attorney." Id., p. 42:4-9.

The Court's June 19, 2019 order directed the parties to file supplemental briefs and "any discovery materials" the filing party deemed relevant in order to have Moving Defendants' preliminary objections resubmitted to the Court for

disposition. See, Ord., 6/19/19 at 3 - 4. On November 19, 2019, Moving Defendants filed supportive briefs and copies of Hardin's deposition transcript. Dakota responded with briefs in opposition on November 26, 2019, together with Hardin's deposition transcript and the exhibits referenced therein. The Court also granted Moving Defendants' motions for leave to file reply briefs in further support of their objections, which briefs were docketed on December 17, 2019. The preliminary objections are therefore ripe for decision.

Discussion

Personal jurisdiction may be exercised over a defendant under two alternative theories: "general, or all-purpose jurisdiction, and specific, or case-linked jurisdiction." Vaughan Estate of Vaughan v. Olympus Am., Inc., 208 A.3d 66, 72 (Pa. Super. 2019). General jurisdiction permits a party to be sued in any state forum for any claim, regardless of where the actions underlying the claim occurred. Goodyear Dunlop Tires Operations, S.A. v. Brown, 564 U.S. 915, 924 (2011). For general jurisdiction to be present, the defendant must be considered "at home" in the forum state. Ibid. "In contrast to general jurisdiction, specific jurisdiction is narrowly confined to adjudication of issues deriving from, or connected with, the very controversy that establishes jurisdiction." Vaughan, 208 A.3d at 73 (citation and quotation omitted). "When there is no such connection, specific jurisdiction is lacking regardless of the extent of a defendant's unconnected activities in the [forum s]tate." Bristol-Myers Squibb Co. v. Superior Court of California, San Francisco Cty., 137 S. Ct. 1773, 1781 (2017). The Court examines whether either theory of jurisdiction supports the exercise of personal jurisdiction over Moving Defendants

1. General Personal Jurisdiction

Pennsylvania authorizes its courts to exercise general personal jurisdiction over an individual defendant by demonstrating one of the following: "Presence in this Commonwealth at the time when process is served," "Domicile in this Commonwealth at the time when process is served," or "Consent, to the extent authorized by the consent." 42 Pa. C.S. § 5301(a)(1)(i) - (iii). Here, Hardin was neither domiciled in Pennsylvania nor present here at the time complaint was served. On the contrary, Hardin is a resident of Virginia and his counsel in the present action accepted service of the complaint on his behalf. See, Aff., at 3, 7; Dep., p. 4:19 - 22. There is also no basis to conclude that Hardin consented to the exercise of personal jurisdiction. Accordingly, the Court lacks general *in personam* jurisdiction over Hardin

The same is true for Locke Lord. The record indicates that Locke Lord is a limited liability partnership providing legal services. <u>Aff.</u>, at 3. A Pennsylvania tribunal may exercise general personal jurisdiction over "limited partnerships ...

and similar entities" on the basis of "Consent" or "Formation or qualification as a foreign entity under the laws of this Commonwealth." 42 Pa. C.S. § 5301(a) (3)(i)-(ii). Pennsylvania may also exercise general personal jurisdiction over such business entities if they carry on "a continuous and systematic part of [their] general business within" Pennsylvania. Id., § 5301(a)(2)(iii), (3)(iii).9

Here, Locke Lord has not consented to personal jurisdiction in Pennsylvania and it is not registered to do business in Pennsylvania. Aff., at 7. Further, Locke Lord does not carry on "a continuous and systematic" part of its legal services in Pennsylvania. In Daimler AG v. Bauman, 571 U.S. 117 (2014) the United States Supreme Court explained that exercising general personal jurisdiction over a corporation comports with due process only "when the corporation's affiliations with the State in which suit is brought are so constant and pervasive as to render it essentially at home in the forum State." Id., at 122 (citation and bracket omitted). Daimler clarified that, absent exceptional circumstances, a corporation only is "at home" where it is incorporated or where it has its principal place of business. Id., at 137; accord, Hammons v. Ethicon, Inc., 190 A.3d 1248, 1261 (Pa. Super. 2018) (Explaining that, in Daimler, "the United States Supreme Court held that general jurisdiction will not lie in a state in which neither a parent corporation nor its subsidiary is incorporated or has its principal place of business."), appeal granted in part, 206 A.3d 495 (Pa. 2019). The Daimler court concluded that subjecting a corporation to general personal jurisdiction in every state where it "engages in a substantial, continuous, and systematic course of business" would be "unacceptably grasping." Id., at 138 (quotations omitted).

<u>Daimler</u> significantly narrowed the ability of state courts to assert all-purpose jurisdiction based on a corporation's business activities with a state's boundaries. As a result, a Pennsylvania tribunal may not exercise general personal jurisdiction over a corporation or similar entity which carries on "a continuous and systematic part of its general business" within this state, 42 Pa. C.S. § 5301(a)(2)(iii), (3)(iii),

The phrase "qualification as a foreign entity under the laws of this Commonwealth" means that the foreign entity is registered to do business in Pennsylvania. See generally, 15 Pa. C.S. § 411 ("Registration to do business in this Commonwealth"). In Webb-Benjamin, LLC v. International Rug Group, LLC, 192 A.3d 1133 (Pa. Super. 2018) the Pennsylvania Superior Court held that a foreign company's registration to do business in Pennsylvania constituted consent to general personal jurisdiction, thereby satisfying due process requirements. Id., at 1138 – 39. Significantly, the holding reached in Webb has divided federal courts in Pennsylvania for several years. Compare, Bors v. Johnson & Johnson, 208 F. Supp. 3d 648 (E.D. Pa. 2016) (Reaching the same result as Webb), with, In re Asbestos Prod. Liab. Litig. (No. VI), 384 F. Supp. 3d 532 (E.D. Pa. 2019) (Holding that Pennsylvania's statutory business registration scheme which conditions registration to do business on consent to general personal jurisdiction violates the due process clause of the 14th amendment); see also, Murray v. American LaFrance, LLC, 2018 PA Super 267, (Pa. Super. Sept. 25, 2018) (Granting en banc review to consider this issue; oral argument held October 31, 2019).

unless those business activities are so "constant and pervasive" that they render Pennsylvania tantamount to the entities' state of formation/incorporation or principal place of business. See, Daimler, 571 U.S. at 152 (Stating that, "in order for an out-of-state defendant to be subject to general jurisdiction, its continuous and substantial contacts with a forum State must be akin to those of a local enterprise that actually is 'at home' in the State.") (Sotomayor, J., concurring in the judgment).

Applying these principals to the case at bar, it is clear that general personal jurisdiction over Locke Lord is lacking. For starters, Locke Lord was not formed in Pennsylvania and its principal place of business is located in Dallas, Texas. Moreover, Locke Lord's business activities in Pennsylvania are not so pervasive that they render Pennsylvania the functional equivalent of Locke Lord's principal place of business or state of formation. Indeed, Locke Lord's affidavit indicates that it does not advertise in Pennsylvania; maintain any offices or facilities in Pennsylvania; own, lease or rent any real or personal property in Pennsylvania; or employ any personnel in Pennsylvania. See, Aff., at 6, 8 – 10. Accordingly, to the extent Daimler preserved all-purpose jurisdiction over a foreign company which continuously transacts business in a state, the record of Locke Lord's business activities in Pennsylvania falls well short of satisfying that standard. See, Daimler, 571 U.S., at 139, n. 19 (Stating that it would be the "exceptional case" in which a corporation's business activities in a state will be sufficient to subject it to general personal jurisdiction). Thus, like Hardin, the Court also lacks general in personam jurisdiction over Locke Lord.

An important component of this function is the creation and maintenance of diversity in the court system. A community's belief that a court dispenses justice is heightened when the court reflects the community's diversity.

The basic authority of a United States magistrate judge is specified in 28 U.S.C. § 636.

To be qualified for appointment an applicant must:

- Be, and have been for at least five years, a member in good standing of the bar of the highest court of a state, the District of Columbia, the Commonwealth of Puerto Rico, the Territory of Guam, the Commonwealth of the Northern Mariana Islands, or the Virgin Islands of the United States, and have been engaged in the active practice of law for a period of at least five years;
