Department of Transportation v. Wildauer

Medical recall of driver's license – Physician's report to be submitted to PennDOT within ten days

- 1. The Vehicle Code authorizes PennDOT to recall licenses if it determines that a licensee is medically incompetent to drive.
- 2. The Vehicle Code provides for judicial review of PennDOT's determinations.
- 3. The Vehicle Code provides for physicians to report a driver's disorder or disability to PennDOT within ten days.
- 4. Following a recall, a licensee is entitled to a *de novo* review by the Court of Common Pleas, where PennDOT has the burden of proving by a preponderance of the evidence the petitioner's incompetency on the date of the recall.
- On March 11, 2021, PennDOT received an Initial Reporting Form from Great 5. Valley Neurology indicating Defendant was examined on December 18, 2019 and given a diagnosis of "Neuropsychiatric Disorder: Mild cognitive impairment mood disorder." The Form noted Defendant never completed driving evaluation; had poor judgment and her conditions affect her ability to safely operate a motor vehicle. The lapse of time between Defendant's medical examination and the report to PennDOT was 449 days. Defendant filed an appeal from the medical recall of her license privileges. Defendant argued medical reporting form should not have been admitted to meet PennDOT's burden because the lengthy delay between the examination and the report offered no reliable evidence concerning Defendant's competency on the date of recall. The Court agreed the report was meaningless as a tool to assess a licensee's present competency and, because PennDOT failed to sustain its burden of proof to establish medical incompetency as of the date of recall, the appeal was sustained and the Notice of Recall was rescinded.

MEMORANDUM OPINION AND ORDER

Defendant, Carol A. Wildauer ("Ms. Wildauer"), appealed from the medical recall of her license privileges. A hearing was conducted November 18, 2021. At the conclusion of the hearing, counsel were requested to brief two issues. Briefs having been filed, this matter is ready for decision.

On March 11, 2021, Plaintiff, Commonwealth of Pennsylvania Department of Transportation ("PennDOT"), received an Initial Reporting Form from Great Valley Neurology concerning Ms. Wildauer. (Exh. C-1)

The Initial Reporting Form recites that Ms. Wildauer was examined on December 18, 2019 and given a diagnosis of "Neuropsychiatric Disorder: Mild cognitive impairment – mood disorder[.]" The Initial Reporting Form states under comments: "She never completed driving evaluation; she has poor judgment[.]" In response to the question, "Do these conditions affect the patient's ability, from a medical standpoint only, to safely operate a motor vehicle?" the Initial Reporting Form is checked "YES[.]"

The Initial Reporting Form is signed by Kathleen Canfield PA-C, neurology specialty. Next to Ms. Canfield's signature is the date, March 11, 2021. The lapse of time between Ms. Wildauer's examination and Ms. Canfield's report is four hundred forty-nine days.

Following receipt of the Initial Reporting Form, PennDOT issued a notice of recall of driving privilege ("Notice") to Ms. Wildauer on March 22, 2021, in the format of a two-page letter. The Notice advised Ms. Wildauer that her driving privilege was recalled due to a cognitive, neurological, and psychiatric condition which prevents her from safely operating a motor vehicle. Ms. Wildauer was also informed that as of March 29, 2021, she was no longer privileged to drive and was required to return all Pennsylvania driver license products to PennDOT on or before March 29, 2021.

On the second page of the Notice, Ms. Wildauer was informed of her right to appeal to the Court of Common Pleas within thirty days of the mail date of the Notice. Below the notice of appeal right, Ms. Wildauer was informed, "You still must send in your Pennsylvania driver's license products by the effective date of recall unless

you appear in person before a judge and receive an order permitting you to continue driving."

Ms. Wildauer turned in her driver's license.

On April 19, 2021, Ms. Wildauer filed a timely appeal from the recall of her driving privilege.

This matter was first listed for hearing on June 24, 2021, but was continued at Ms. Wildauer's request. The hearing was next listed for September 2, 2021, but the courthouse closed that date due to Hurricane Ida. The hearing was finally held November 18, 2021. PennDOT offered no testimony and relied on the Initial Reporting Form to establish a medical basis to recall Ms. Wildauer's driving privilege. Ms. Wildauer offered no testimony.

Counsel were directed to brief the following issues:

Did PennDOT have authority to medically recall Ms. Wildauer's driving privilege based on an Initial Reporting Form submitted four hundred forty-nine days after Ms. Wildauer's medical examination?
 Did PennDOT violate Ms. Wildauer's right to due process by requiring her to appear before the court within seven days of the mailing date of the Notice to obtain a supersedeas?

We address only the first issue below.¹

1. Did PennDOT have authority to medically recall Ms. Wildauer's driving privilege based on an Initial Reporting Form submitted four hundred forty-nine days after Ms. Wildauer's medical examination?

The Vehicle Code² authorizes PennDOT to recall licenses if it determines that a licensee is medically incompetent to drive. The Vehicle Code also provides for judicial review of PennDOT's determinations.

The department shall recall the operating privilege of any person whose incompetency has been established under the provisions of this chapter. The recall shall be for an indefinite period until satisfactory evidence is presented to the department in accordance

¹ PennDOT limits the period for requesting a supersedeas to seven days from the date the Notice of recall of driving privileges is mailed. This is an issue of great concern to this court. Depending on the day of the week the notice is mailed, this amounts to five business days at most to appear before a judge. The time limitation does not allow for mail delays, the licensee to be out of town, or difficulties in reaching an attorney able to advise and assist. The Notice gives only limited information for the basis of the recall making it difficult for the licensee to understand why the Notice issued. Despite our due process concerns, in the instant matter Ms. Wildauer relinquished her license rather than applying for a supersedeas during the seven days permitted and further she offered no testimony to explain what difficulties, if any, she encountered in seeking to exercise her right to seek a supersedeas. Accordingly, we will not take up the issue.

with regulations to establish that such person is competent to drive a motor vehicle. The department shall suspend the operating privilege of any person who refuses or fails to comply with the requirements of this section until that person does comply and that person's competency to drive is established. *Any person aggrieved by recall or suspension of the operating privilege may appeal in the manner provided in section 1550.* The judicial review shall be limited to whether the person is competent to drive in accordance with the provisions of the regulations promulgated under section 1517 (relating to Medical Advisory Board).

75 Pa.C.S.A. § 1519(c)(emphasis added).

The Vehicle Code provides for PennDOT to receive reports from medical personnel of medical issues affecting driving competency.

All physicians, podiatrists, chiropractors, physician assistants, certified registered nurse practitioners and other persons authorized to diagnose or treat disorders and disabilities defined by the Medical Advisory Board *shall report to the department*, in writing, the full name, date of birth and address of *every person* over 15 years of age *diagnosed as having any specified disorder or disability within ten days*.

75 Pa.C.S.A. § 1518(b)(emphasis added).³ To comply with this provision, medical personnel submit the Initial Reporting Form to PennDOT.

Following recall under §1519 of the Vehicle Code, a licensee is entitled to a *de novo* review by the Court of Common Pleas.⁴ At this hearing, PennDOT has the burden of proving by a preponderance of the evidence the petitioner's incompetency under the terms of the statute. *Klotz v. Com.*, 77 Pa.Cmwlth. 134, 137, 465 A.2d 113, 114–15 (1983). Furthermore, PennDOT "is burdened with proving [petitioner's] incompetency **on the date of the recall** of [petitioner's] operating privileges[.]" *McKay v. Com.*, 52 Pa.Cmwlth. 24, 30, 415 A.2d 910, 913 (1980)(emphasis added). PennDOT may satisfy its burden by the introduction of the medical report relied upon in recalling the driver's license. *Byler v. Com., Dep't of Transp.*, 883 A.2d 724, 728 (Pa.Cmwlth. 2005). The court is not mandated to accept PennDOT's conclusions

The administrative regulations for PennDOT provide for the same procedure:

Physicians and other persons authorized to diagnose and treat disorders and disabilities defined by the Medical Advisory Board shall report to the Department, in writing, the full name, date of birth and address of every person 16 years of age and older diagnosed as having any specified disorder or disability within 10 days, under 75 Pa.C.S. § 1518 (relating to reports on mental or physical disabilities or disorders).

based on the content of the Initial Reporting Form. *Turk v. Com., Dep't of Transp.*, 983 A.2d 805, 815 (Pa.Cmwlth. 2009)("the lack of clarity regarding the extent to which Physician's opinions were based on current examinations are circumstances which a fact-finder may consider in determining whether Licensee carried her burden to prove competency to drive.") The burden of production shifts to the licensee after PennDOT has met its initial burden. *Byler*, 883 A.2d 724.

Ms. Wildauer chose not to submit evidence of her competency, but rather argued that the Initial Reporting Form, submitted four hundred forty-nine days after her examination, should not have been admitted into evidence because PennDOT violated § 1518(b) by acting on a late report and because a medical examination so removed from the date of recall offers no reliable evidence concerning Ms. Wildauer's competency on the date of recall.

The legislature recognized the need for prompt reporting of a medical disability by mandating that a medical disability "shall"⁵ be reported "within ten days." 75 Pa.C.S.A. § 1518(b). Contrary to PennDOT's assertion that it was "required to act upon"⁶ receipt of the Initial Reporting Form, § 1519(c) does not mandate that PennDOT recall the operating privileges of every licensee for whom it receives an Initial Reporting Form. The statute says, "The department shall recall the operating privilege of any person whose incompetency has been established under the provisions of this chapter." 75 Pa.C.S.A. § 1519(c). PennDOT is mandated to recall operating privileges when a licensee's incompetency has been established in compliance with the provisions of Chapter 15 of the Vehicle Code. Whether or not the ten-day reporting period can be exceeded, four hundred forty-nine days so grossly exceeds a prompt report as to make the report meaningless as a tool to assess a licensee's present competency.

PennDOT was not required to disregard the stale initial report. PennDOT's own regulations permit the agency to request additional examinations or a driver's examination without issuing a recall when the initial reporting form is insufficient.

When a physician submits information indicating that the driver may have a condition which affects the ability to drive safely, but the Medical Unit has insufficient information to compare the patient's condition with the Medical Advisory Board's medical regulations, the Medical Unit requires the driver to have a physician complete additional medical examination forms or the driver may be required to complete a

⁵ "Under the Statutory Construction Act, when the words of a statute are free from ambiguity, its letter is not to be disregarded under the pretext of pursuing its spirit. 1 Pa.C.S.A. § 1921(b)(Supp.1995). Only if a statute is unclear may a court consider the legislature's intent by reviewing the act's necessity and object, the circumstances under which it was enacted, and other factors. *Id.* at § 1921(c). Words are generally construed according to their common usage. 1 Pa.C.S.A. § 1903. "By definition, 'shall' is mandatory." *Coretsky v. Bd. of Comm'rs of Butler Twp.*, 520 Pa. 513, 518, 555 A.2d 72, 74 (1989). PennDOT measures the ten-day requirement from the date of the examination and has not suggested that § 1518(b) is ambiguous. driver's examination.

* * *

In this instance, the licensee has 30 days to respond and upon failure to do so faces a suspension.

Pa.Code § 82.6(a), (c).

Furthermore, PennDOT recognizes there are circumstances when a report of medical incompetency is received that requires greater scrutiny. A report received from a family member is "carefully scrutinized ... for validity." 67 Pa.Code § 82.8(b) (1) PennDOT understands in this instance that different motivations may have led to the report. Similarly, here a report made after a lengthy delay following the medical examination begs the question why now. What prompted Ms. Canfield four hundred forty-nine days following the medical examination to submit the Initial Reporting Form? PennDOT has discretion when reviewing an Initial Reporting Form to evaluate whether incompetency has been properly established and when it fails to do so, abdicates its discretionary role to the medical personnel who submit the Initial Reporting Forms.

Judicial review would be nothing more than a sham if the court was precluded from considering the content of the Initial Reporting Form to determine whether PennDOT had acted on a timely report of medical incompetency. The court can determine from the face of the Initial Reporting Form whether a report has been timely submitted. Because PennDOT has failed to sustain its burden of proof to establish Ms. Wildauer's medical incompetency as of the date of recall, Ms. Wildauer's appeal is sustained.

For the reasons stated, we enter this

<u>ORDER</u>

AND NOW, this 7th day of February, 2022, the appeal of Carol A. Wildauer is sustained and the Notice of Recall is rescinded.

Public Notice Appointment of New Magistrate Judge in the United States District Court for the Eastern District of Pennsylvania

The Judicial Conference of the United States has authorized the appointment of a full-time United States magistrate judge for the Eastern District of Pennsylvania at Reading or Philadelphia. The appointee may be required to preside at court sessions to be held at Reading, Philadelphia, Allentown, and Easton. The essential function of courts is to dispense justice. An important component of this function is the creation and maintenance of diversity in the court system. A community's belief that a court dispenses justice is heightened when the court reflects the community's diversity.

The duties of the position are demanding and wide-ranging, and will include, among others: (1) conduct of most preliminary proceedings in criminal cases; (2) trial and disposition of misdemeanor cases; (3) conduct of various pretrial matters and evidentiary proceedings on delegation from a district judge; and (4) trial and disposition of civil cases upon consent of the litigants. The basic authority of a United States magistrate judge is specified in 28 U.S.C. § 636.

To be qualified for appointment an applicant must:

- Be, and have been for at least five years, a member in good standing of the bar of the highest court of a state, the District of Columbia, the Commonwealth of Puerto Rico, the Territory of Guam, the Commonwealth of the Northern Mariana Islands, or the Virgin Islands of the United States, and have been engaged in the active practice of law for a period of at least five years;
- Be competent to perform all the duties of the office; be of good moral character; be emotionally stable and mature; be committed to equal justice under the law; be in good health; be patient and courteous; and be capable of deliberation and decisiveness;
- 3. Be less than seventy years old; and
- 4. Not be related to a judge of the district court.

A merit selection panel composed of attorneys and other members of the community will review all applicants and recommend to the district judges in confidence the five persons it considers best qualified. The court will make the appointment following an FBI full-field investigation and an IRS tax check of the applicant selected by the court for appointment. The individual selected must comply with the financial disclosure requirements pursuant to the Ethics in Government Act of 1978, Pub. L. No. 95-521, 90 Stat. 1824 (1978) (codified at 5 U.S.C. app. 4 §§ 101-111) as implemented by the Judicial Conference of the United States. An affirmative effort will be made to give due consideration to all qualified applicants without regard to race, color, age (40 and over), gender, religion, national origin, or disability. The current annual salary of the position is \$205,528.00. The term of office is eight (8) years.
