## Motion to Seal – Case Records Access Policy

1. Court filings generally open to the public will not be sealed unless a party shows good cause that closure is necessary in order to prevent a clearly defined and serious injury to the party.
2. Plaintiffs indicated their awareness of remedies regarding confidential information and documents through the Case Records Access Policy by taking measures to shield information and documents by use of initials rather than the minor's name and use of the Confidential Document Form. Nonetheless, Plaintiffs seeks an *ex parte* order sealing all documents and the entire docket upon grounds of convenience, alleging it would be too burdensome to continue file Confidential Document Forms. There being no authority holding that the burden of complying with the Case Records Public Access Policy is a legally cognizable substitute for a showing of good cause to seal a record, the Court Held Plaintiff's Motion to Seal was denied.

**MEMORANDUM**

On August 30, 2023, Plaintiffs commenced this action by filing a Praecipe for Writ of Summons. The docket does not reflect service of the Writ.

On September 1, 2023, Plaintiffs filed Plaintiffs' Motion to Seal Record. On September 5, 2023, Plaintiffs presented Plaintiffs' Motion to chambers along with a copy of Plaintiffs' Notice to Defend, Plaintiffs' Civil Action Complaint with Exhibits "A" through "E", and Plaintiff's Confidential Document Form.<sup>1</sup> Plaintiffs did not file a certificate of service of the Motion.

By its *ex parte* Motion, Plaintiffs aver that this case concerns "the actions of the Defendants upon a minor child, BW within an educational setting at the Avon Grove Charter School." Motion, 9/1/2023, ¶ 3. Plaintiffs aver that "[t]he assertions of facts in the Complaint and the exhibits attached thereto center around and contain numerous references to both BW's educational records, medical and psychological records and other highly sensitive information." Motion, 9/1/2023, ¶ 4. Plaintiffs ask this court for an *ex parte* order "sealing all documents and the entire docket[.] Motion, 9/1/2023, p. 1 (introductory paragraph).

Here, Plaintiffs' request for relief is overbroad. Regarding assertions of fact in the complaint, Plaintiffs' remedy regarding confidential information is found at § 7.0 of the Case Records Public Access Policy of the United Judicial System of Pennsylvania. Regarding confidential documents, Plaintiffs' remedy is found at § 8.0 of the Case Records Public Access Policy of the United Judicial System of Pennsylvania. Indeed, Plaintiffs are fully aware of those remedies and have taken measures to shield confidential information and confidential documents, for example, by Plaintiffs' use of initials instead of the minor's name pursuant to § 7.0A(5) and Plaintiff's use of the Confidential Document Form for the Complaint Exhibits "A" through "E" pursuant to § 8.0A(2) and (3). *See also* Brief, 9/1/2023, pp. 3-4 (describing Case Records Public Access Policy).

Recognizing the availability of these remedies, Plaintiffs have filed their Motion asking this court to seal the entire docket upon the ground of convenience. *See* Brief, 9/1/2023. p. 4 ("In this case, because so many of BW's records and information are germane to the lawsuit and so many references are made to those documents in the pleading (and anticipated in future pleadings), it would be too burdensome for the parties to file Confidential Information Forms for every such instance.") (parentheses in original). However, it is the law that court filings generally open to the public will not be sealed unless a party shows good cause which exists when a party shows that "closure is necessary in order to prevent a clearly defined and serious injury to the party seeking it." A.A. v. Glicker, 237 A.3d 1165, 1170 (Pa.Super. 2020) (internal quotation omitted). Plaintiffs have cited no authority and this court has found no authority holding that the burden of complying with the Case Records Public Access Policy is a legally cognizable

substitute for a showing of good cause.

Accordingly, for the reasons set forth above this court will enter an order denying Plaintiff's Motion to Seal Record filed September 1, 2023.
