OLD BUSINESS

Kevin O'Hearn, Court Administrator was in attendance to explain the changes to the arbitration procedures and to answer any questions. Mr. O'Hearn reported that the process they would be implementing was similar to that used in Schuylkill County and that the Court Administrator's Office would be in charge of coordinating all panels and hearings. They have built into the current Court calendar every other Wednesday afternoon as the time for hearings. They felt that a minimum of 3 cases could be heard each afternoon. After finalization of all of the details, a notice will be run in the North'd Legal Journal advising as to the start-up date for the new procedure.

Atty Joe Michetti reported that attorneys can now by-pass the security scanner at the main entrance to the Court House. If the security guards do not recognize you as an attorney, you will be asked to show your PA bar identification card. Atty Michetti also reported that the Register &

Recorder's office is now open over the lunch hour to accept filings, etc. The staff is staggering their lunch hours to accommodate the public.
