Commonwealth v. Ferguson

Habeas motion - Discovery as to a confidential informant

- 1. When the Commonwealth establishes *prima facie* evidence as to each element of each crime charged, a *Habeas* motion should be denied.
- 2. The Court determined Defendant presented sufficient evidence that disclosure of the identity of the confidential informant (CI) was material to preparation of his defense. Further, Defendant's request was not unreasonable: the actual drug transactions were not observed by law enforcement; there was nothing in the record as to the reliability of the CI or his involvement in prior matters; there was no evidence or testimony concerning a threat to the CI's safety if his identify was disclosed; there were times during the surveillance when neither the CI nor the Defendant were visible to law enforcement; and the Defendant was not arrest immediately after either buy. On the other hand, Defendant did not present any evidence that the CI's involvement in other investigations unrelated to Defendant's case was material to his defense, so, his request for "any other dealings with said confidential informant" was overbroad and, accordingly, denied. The Court Held Defendant's Habeas Motion was denied, and Defendant's Motion for Discovery was granted in part and the Commonwealth was ordered to provide the name of the confidential informant; the nature and extent of CI's involvement with the police and any recordings, written documents, phone calls, and memorandum involving and/or concerning the CI and Defendant.

AMENDED ORDER

AND NOW, this 10th day of October, 2023, upon consideration of Defendant's Pre-Trial *Habeas* Motion and Discovery Motion, filed May 15, 2023, after supplemental testimony and oral argument heard on May 18, 2023, Defendant's *Habeas* Motion is hereby DENIED¹ and Defendant's Motion for Discovery is GRANTED in part, and DENIED in part.² The Commonwealth is ORDERED to provide the following:

- Name of Confidential Informant (herein CI)
- Nature and extent of CI's involvement with the police
- Any recordings, written documents, phone calls, memorandum involving and/or concerning the CI and Defendant.

¹ The supplemental testimony of Detective Oscar Rosato and review of the preliminary hearing transcript shows the Commonwealth established *prima facie* evidence as to each element of each crime charged. At the preliminary hearing, Trooper Timothy O'Connor testified a controlled drug buy was coordinated between CI and Defendant on June 10, 2021. Trooper O'Conner stated he observed the CI and Defendant meet at a designated location, a three-bay-garage. The CI left the meet with a controlled substance and the controlled substance was tested and confirmed as methamphetamine. Trooper O'Connor did not see the controlled substance "change hands."

At the May 18, 2023 Pre-Trial Hearing, Detective Rosato testified to his involvement in and observations of the controlled buy on June 10, 2021 between the CI and Defendant. Detective Rosato stated he observed Defendant arrive to the garage as the passenger in a black Volkswagen Jetta. Defendant exited the vehicle carrying a black bag and entered the middle garage bay. Defendant then exited the middle garage bay carrying the same black bag, entered the vehicle, and left. Defendant did not meet with anyone other than the CI while at the garage.

At the preliminary hearing, Trooper O'Connor also testified to observing a similar process occurring on June 25, 2021 wherein a controlled buy was coordinated by phone, the CI and Defendant met, the CI left

with a controlled substance, the substance was tested and confirmed as methamphetamine. Again, Trooper O'Connor did not observe the controlled substance "change hands." Trooper O'Connor explicitly testified the CI and the CI's vehicle were searched to ensure the CI did not possess any controlled substances prior to either controlled buy.

Trooper James Wisnieski also testified at the preliminary hearing concerning his involvement with the June 25, 2021 controlled buy. Trooper Wisnieski stated he and other officers observed Defendant arrive to the garage on a motorcycle where he met with the CI. After meeting with the CI, Defendant left the garage and the controlled substance was recovered, tested, and confirmed as methamphetamine.

For all the reasons stated above, Defendant's Habeas Motion is hereby DENIED.

² Defendant presented sufficient evidence that disclosure of the CI's identity is material to preparation of his defense. Further, Defendant's request is not unreasonable. *See, Commonwealth v. Koonce*, 190 A.3d 1204, 1209 (Pa. Super. 2018) (*Commonwealth v. Marsh*, 997 A.2d 318, 321-22 (Pa. 2010) (*Commonwealth v. Carter*, 233 A.2d 284, 287)).

The actual exchanges were not observed by law enforcement. There is nothing in the record as to the reliability of the CI or his involvement in prior matters. There was no evidence or testimony concerning a threat to the CI's safety if their identify is disclosed. There were times during the surveillance when neither the CI nor the Defendant were visible to law enforcement on scene. Lastly, the Defendant was not arrest immediately after either buy.

Defendant did not present any evidence that the CI's involvement in other investigations unrelated to his case is material to his defense. To the extent that Defendant requests "any deals" to be disclosed, the Commonwealth is ORDERED to disclose the nature and extent of CI's involvement with the police. Defendant's overbroad statement regarding "any other dealings with said confidential informant" is DENIED.
