In Re: 51st Judicial District---Request
for Emergency Judicial Order

1. Michael A. George, President Judge
of the 51 st Judicial District, hereby
requests the following relief by Order
of the Supreme Court:

- a. Authorize the president judge to
declare a judicial emergency in
this judicial district and take any
actions authorized by Pa.R.J.A.
No. 1952(B)(2).
- b. Suspend or modify statewide
procedural or administrative rules
in this judicial district as follows:
 - I. Authorize the expanded use
of advanced communication
technology to conduct court
proceedings as follows:
Suspension of Pa.R.Crim.P.
119 until September 30,
2021.

2. The circumstances necessitating this
request for an emergency judicial
order are as follows:

- a. A nationwide pandemic involving
the Coronavirus disease 2019
(COVID-19);
- b. The continued judicial emergency
in place in the 51 st Judicial
District, and
- c. Adams County is elevated to the
category of "High" level of com-
munity transmission of COVID-19
per CDC definition as of the date
of this application.
- d. Adams County experiencing an
increase in COVID infection rates
including the highly contagious
delta variant.

3. To the extent possible and practical
under the circumstances, notice of
this request for an emergency judicial
order has been or will be posted in the
courthouse and other judicial offices,
posted on the county's website, pro-
vided to the Adams County Bar
Association, submitted to the
Administrative Office of Pennsylvania
Courts for publication pursuant to
Rule of Judicial Administration No.
1952(C)(5) and published in the
Adams County Legal Journal.

4. Interested parties are advised that
objections to any emergency judicial
order issued by the Supreme Court
should be transmitted to the Supreme
Court Prothonotary.
