### PROPOSED CHANGES TO BCBA BY-LAWS

**Article V-Officers and Executive Board shall be revised as follows:**

#### • ARTICLE V- OFFICERS AND EXECUTIVE BOARD

*Section 5. The association shall have an Executive Committee, which shall consist of seven (7) elected committee members and the Young Lawyers Division President. The association shall, hold elections at the last quarterly meeting of the year. The Executive Committee term of office shall be for two (2) years beginning January 1 and ending December 31, with the exception of the Young Lawyers Division President who shall serve for one year during his/her Presidency. Election of the Executive Committee shall be four (4) new members in even years: (example: 2006, 2008), and three (3) new members in odd numbered years: (example 2007, 2009). Officers of the Association shall serve as the Executive Board of the Association for the following year. The Executive Board shall be chaired by the President of the Association. The secretary shall keep minutes of the meetings of the Executive Board, which shall be available for inspection by the members. The Executive Board shall meet at least monthly, or more often if necessary, to carry out its function. The authority of the Executive Board shall be limited to the following:*

The remaining portions of Section 5 shall remain intact.

**Article VI- Standing Committees and Sections shall be revised as follows:**

#### • ARTICLE VI- DIVISIONS, STANDING COMMITTEES AND SEC110NS

*Section 1: There shall be a Young Lawyers Division (YLD), which shall consist of all members who are under the age of 40 or have been admitted to the practice of law for 10 years or less. The YLD shall operate under By-Laws and amendments thereof, not inconsistent with these By-Laws, duly adopted by the Division and approved by the BCBA Executive Committee.*

*The Officers of the Division shall be a President, Vice President, Secretary, Treasurer and Immediate Past President.*

Existing Section 1 shall be renamed Section 2 and Young Lawyers shall be stricken from the new Section 2.
