ESTATE OF BLAKE S. WALKER, DECEASED

- 1. A constructive trust arises where a person who holds title to property is subject to an equitable duty to convey it to another on the ground that he would be unjustly enriched if he were permitted to retain it.
- 2. A constructive trust is the formula through which the conscience of equity finds expression. When property has been acquired in such circumstances that the holder of the legal title may not in good conscience retain the beneficial interest, equity converts him into a trustee.
- 3. There is no rigid standard for determining whether the facts of a particular case require a court to impose a constructive trust.
- 4. The controlling factor in determining whether a constructive trust should be imposed is whether it is necessary to prevent unjust enrichment...Such a constructive trust may be imposed even though the acquisition of property was not wrongful and the defendants' intention was not malign...
- 5. In Pennsylvania each court of common pleas, through its orphans' court division, has mandatory jurisdiction over decedents' estates. Thus, it follows that this Court has the right to exercise its equitable powers, if appropriate, in determining the proper distribution of the annuity payments at issue.
- 6. A disabled person with substantial assets may maintain eligibility for Medical Assistance benefits if he transfers all of his assets into a special needs trust with the caveat that Department of Public Welfare (DPW) would recover all of those assets remaining in the trust upon the beneficiary's death.

OPINION

Before the Court for disposition is the Amended Objection To Petition For Adjudication/Statement of Proposed Distribution filed by Pennsylvania Department of Public Welfare (DPW). For reasons set forth herein, said petition is granted.

PROCEDURAL BACKGROUND

- On March 15, 2012, David S. Walker, Administrator of the Estate of Blake Scott Walker, filed the First and Final Account in the estate as well as a Statement of Proposed Distribution.
- 2. Estate assets consisted of certain post-death monthly annuity distributions.

- 3. The Estate proposed distribution of the net estate to David S. Walker, Decedent's father.
- 4. On May 3, 2012, DPW filed it Objection claiming entitlement to the post-death annuity payments.
- 5. On June 25, 2012, DPW filed its Amended Objection.
- 6. No hearing has been conducted. Instead, the parties have submitted a Joint Stipulation of Facts.¹

FACTUAL BACKGROUND²

- 1. Decedent was born on November 30, 1993.³
- 2. Decedent was severely and permanently injured during birth and required total assistance throughout his lifetime for all his activities of daily living.⁴
- 3. Decedent qualified for and received medical assistance (MA) from DPW from 1994 through 2003 because of such injuries and his resulting disability.⁵
- 4. A medical malpractice lawsuit was filed on Decedent's behalf in the Court of Common Pleas of Franklin County, Pennsylvania at docket No. 1995-523. Therein, DPW asserted a casualty lien in the amount of \$1,344,502.17 against any settlement.⁶
- 5. On August 19, 2003, almost 10 years after Decedent's birth, his father, David S. Walker, individually and as parent of Decedent, executed a Release to settle the medical malpractice action. As part of the Release, an arrangement was to be made

"for a Qualified Assignment within the meaning of Sections 104(a)(2) and 130(c) of the Internal Revenue Code of 1986, as amended on behalf of Blake Walker to provide yearly income of \$36,468

- ... increasing at 3% per year compounded annually and payable for 20 years certain and life. If said Blake Walker dies within the 20-year period, the remaining payments will be made to the beneficiary or beneficiaries until the 20-year period has expired. These periodic payments shall be payable to the Guardian of Blake Walker until he reaches the age of majority . . . The Assignee shall be the sole owner of the annuity and shall retain all incidence of ownership." (emphasis added).
- 6. On August 20, 2003, the Franklin County Court entered an Order ("the Settlement Order")⁸ approving a Petition For Approval of Minor's Settlement & Distribution of Settlement Funds for a total structured settlement of \$2,500,000. The Order also provided, inter alia, that:
 - a. Pursuant to Pa. R.C.P. 2039(b)(4) . . . the corporate fiduciary authorized to do business in the Commonwealth of Pennsylvania selected by David S. Walker is authorized to execute the Blake Walker Special Needs Trust (SNT) Declaration in the form of the Declaration attached to the Petition as Exhibit "B" (emphasis added);
 - b. The corporate trustee of the SNT was to receive \$229,387.40;9
 - c. The DPW was to receive \$380,681.23 on its claim of \$1,343,502.17; and
 - d. The sum of \$800,000 was to be used to purchase an annuity from American General Life Insurance Company (AGLIC) that would provide monthly payments of \$3,039 guaranteed for 20 years beginning on February 1, 2004 and continuing for life, with payments increasing 3% compounded annually and payable "to the duly appointed trustee of the Blake Walker Special Needs and its successors."

- On or about September 23, 2003, the medical malpractice defendant's counsel issued a check payable to the SNT in the amount of \$200,000 in compliance with the Settlement Order.¹⁰
- 8. On or about December 11, 2003, Sterling Financial Trust Company executed the Blake Walker Special Needs Trust Declaration in its capacity as the duly appointed trustee (Trustee) of the SNT.¹¹
- 9. The Trust Declaration provided that upon termination of the SNT, either by court order or Decedent's death, the trust was to pay all valid DPW claims and any balance would be paid to Decedent's estate. The Declaration also provided that a copy thereof was to be provided to DPW.¹²
- 10. On or about December 30, 2003, a Single Premium Immediate Annuity Contract, Contract No. 414152 ("Annuity"), was purchased from AGLIC for the sum of \$800,000 pursuant to the terms of the Release and as required by the Settlement Order.¹³
- 11. The Annuity Application indicated, in descending order, that the "Measuring Life" was "Blake S. Walker," the "Beneficiary" was "the estate of Blake S. Walker," the "Payee (if Other Than measuring Life)" was "same as above", and the "Owner of Annuity" was "American General Annuity Service Corporation".¹⁴
- 12. The annuity provided that the monthly benefit was to be guaranteed for a period of 20 years with the first payment due February 1, 2004. The initial monthly amount was set at \$3,039.92,¹⁵ but that amount was to increase each year by 3%.¹⁶

- 13. Page 3 of the annuity contained a provision that "IF THE ANNUITANT DIES PRIOR TO PAYMENT OF ALL INSTALLMENTS DURING THE GUARANTEED PERIOD, ANY REMAINING PAYMENT DUE SHALL BE PAID IN ACCORDANCE WITH THE SETTLEMENT AGREEMENT, AS THEY BECOME DUE." The term "SETTLEMENT AGREEMENT" is not defined in the Annuity. 17
- 14. Page 5 of the annuity contained a provision that "The Beneficiary, as named in the application or later changed by the Owner, will receive, subject to the terms of this policy, any payments which are due after the death of the Measuring Life . . ." Stated otherwise, the Annuity provided that the Decedent's Estate would receive the guaranteed monthly annuity payments due after Decedent's death.¹⁸
- 15. On or about December 31, 2003, the medical malpractice defendant's counsel issued a check payable to the SNT in the amount of \$29,387.40 in compliance with the Settlement Order.¹⁹
- 16. The aforesaid initial payments into the SNT in the amount of \$229,387.40, as well as the monthly annuity payments made during Decedent's lifetime to the SNT, were received, managed and distributed by the Trustee and successor Trustee of the SNT in accordance with the terms of the SNT Declaration.²⁰
- 17. DPW received copies of the executed SNT Declaration and notice of the subsequent Franklin County Orphans' Court proceedings concerning distributions made from the SNT before its termination as hereinafter indicated.²¹
- 18. On or about January 4, 2004, DPW received the aforementioned \$380,681.34.²²
- 19. All monthly annuity payments issued from the annuity during Decedent's lifetime were made to Trustee and its successor by merger, PNC Bank, N.A.²³

- 20. On February 25, 2011, the Decedent passed away.²⁴
- 21. On October 26, 2011, PNC Bank, N.A., as the successor Trustee of the SNT, filed a Petition for Adjudication/ Statement of Proposed Distribution Pursuant to Pa. O.C. Rule 6.9 and a First and Final Account ("SNT Accounting") with the Clerk of Orphans' Court in Franklin County. Attached to the SNT Accounting was a copy of the annuity.²⁵
- 22. On or about October 26, 2011, DPW received a copy of a Notice of Audit and of the SNT Accounting from the successor Trustee of the SNT.²⁶
- 23. In the SNT Accounting, the successor Trustee acknowledged receipt of notice of an outstanding claim against the SNT in the amount of \$1,359,704.15 from DPW dated March 9, 2011, for the MA provided to the Decedent after the Settlement Order.²⁷
- 24. There being no objections or exceptions filed to the SNT Accounting, on or about December 1, 2011, the Franklin County Orphans' Court approved the SNT Accounting, which provided for 100% of the balance remaining in the SNT to be distributed to DPW as required by the SNT since the amount of the MA claim of DPW exceeded the remaining balance in the SNT.²⁸
- 25. On or about January 3, 2012, the successor Trustee distributed the balance in the SNT in the amount of \$430,643.22 to DPW and thereafter the SNT terminated.²⁹
- 26. From March 2011 to the present time, all monthly annuity payments have been made directly to Decedent's Estate as the designated Beneficiary of the annuity.³⁰

27. After adjusting for the \$430,643.22 payment, which DPW received from the SNT, the \$929,060.93 balance of the MA claim for which DPW now seeks reimbursement still exceeds the balance of guaranteed payments under the terms of the annuity.³¹
