SUMMARY OF OPINION:

The estate of a nursing home resident filed this professional liability action against the skilled nursing facility and its attending physician that allegedly failed to timely respond to the decedent's respiratory distress and to promptly transfer her to the hospital before she suffered cardio-pulmonary arrest and died. Shortly before trial, the estate filed a motion seeking to amend the complaint to include a claim for punitive damages. Although the estate's expert witnesses opined that defendants breached the accepted standards of care, no expert accused them of wanton or reckless conduct. While it is not necessary that every punitive damages claim in a professional liability action be supported by an expert opinion charging the health care provider with reckless or outrageous conduct as manifested by a subjective appreciation of the risk of harm and an accompanying conscious disregard of that risk, the record must contain sufficient evidence demonstrating a triable issue of fact in that regard in order to submit a punitive damages claim to the jury. Since the evidence in the record did not support a possible finding that defendants had a subjective appreciation of the risk of harm to which the decedent was exposed, and nevertheless acted or failed to act in conscious disregard of that risk, the motion to amend the complaint to include a claim for punitive damages was denied.

SUMMARY OF OPINION:

Defendant filed a pro se petition seeking a new trial under the PCRA on the grounds that his trial counsel allegedly provided ineffective assistance by failing to request three jury instructions. Following the appointment of PCRA counsel and his subsequent review of the case materials, PCRA counsel filed a petition to withdraw as counsel "pursuant to <u>Turner/Finley</u> letter," which included a "no-merit" letter that was also enclosed in correspondence forwarded to defendant advising him of his right to proceed *pro* se or to retain new counsel.

The petition to withdraw and accompanying exhibits satisfied the technical requirements of <u>Turner/Finley</u>. Furthermore, an independent review of the PCRA petition and the court record reflected that the ineffectiveness claims being asserted by defendant were meritless inasmuch as two of the identified jury instructions were actually provided to the jury, and the third instruction was clearly inapplicable and unwarranted based upon the evidence presented at trial. Accordingly, the petition to withdraw was granted, and pursuant to Pa.R.Crim.P. 907(1), defendant was notified of the intention to dismiss his PCRA petition and afforded 20 days within which to file a response or an objection to the proposed dismissal.

SUMMARY OF OPINION:

Defendant filed preliminary objections to the complaint which asserted causes of action for breach of contract and unjust enrichment based upon defendant's failure to pay its insurance premiums for commercial package liability insurance, commercial auto insurance, and workers compensation insurance. Defendant contended that five paragraphs of the complaint lacked the requisite factual specificity, and that plaintiff's demand "for costs and interest" were insufficient as a matter of law. The complaint contained specific averments that defendant requested the insurance coverage, that plaintiff provided the requested coverages and complied with the policies' terms, that defendant received, accepted, and enjoyed the insurance coverages, and that defendant failed to pay all earned premiums for those coverages. When viewed in their entirety, the allegations were sufficient to provide defendant with notice of the claims being asserted so as to enable it to prepare a response and defense. Furthermore, plaintiff merely demanded statutory interest and taxable costs, rather than counsel fees, as a result of which defendant's reliance upon the "American Rule" was misplaced. Thus, defendant's preliminary objections were overruled.

SUMMARY OF OPINION:

A licensed practical nurse at the county prison filed this action against the prison's medical care contractor, and asserted that she was forced to quit her job due to the employer's "systematic retaliation" and "hostile work environment" in violation of the antiretaliation provision of the Fair Labor Standards Act (FLSA). Under the burden-shifting framework governing FLSA retaliation claims, the employee must first state a *prima facie* case of retaliation by showing that she was subjected to an adverse employment action after she engaged in protected activity and that there was a causal connection between the activity and the adverse action, and once she has done so, the burden of production shifts to the employer to produce "clear and reasonably specific" evidence that its actions were taken for legitimate, non-retaliatory reasons. If the employer meets that burden by articulating a legitimate, non-retaliatory justification for the adverse action, the burden shifts back to the employee to show that the proffered reason was merely a pretext for a retaliatory reason.

An employee may defeat a motion for summary judgment by identifying some direct or circumstantial evidence from which a factfinder could reasonably either (1) disbelieve the employer's articulated legitimate reason, or (2) believe that a retaliatory reason was more likely than not a determinative cause of the employer's action. The nurse produced evidence indicating that after she filed a complaint with the Department of Labor which resulted in the employer being compelled to pay overtime compensation to her and other employees, the employer engaged in a persistent course of retaliatory conduct. With respect to the non-retaliatory reasons proffered by the employer, the nurse demonstrated factual issues as to whether those justifications were pretextual, and that retaliation was the more likely determinative cause of the adverse employment action. Consequently, the employer's motion for summary judgment was denied.
