ORDER

AND NOW this 25th day of June, 2019, after consideration of Defendant's Preliminary Objections,¹ IT IS HEREBY ORDERED that:

1. Defendant's Preliminary Objections are SUSTAINED.²

2 On *February 11, 2019*, Plaintiff filed a Mechanics' Lien in the amount of \$22,624.00 against Defendant for property located at 52 Summit Street, New Milford, Pennsylvania. At that time, Plaintiff also filed an affidavit of service indicating that on *February 8, 2019*, Plaintiff served notice of the Lien on Defendant by certified mail. Defendant filed preliminary objections on May 31, 2019 asserting that Plaintiff failed to perfect the Mechanics' Lien as the Mechanics' Lien is replete with errors contrary to the strict requirements of the Mechanics' Lien Law because: (1) Plaintiff, within one month of filing, failed to serve Defendant with the filed Mechanics' Lien with the term, number and date of filing; (2) Plaintiff failed to serve Defendant at any time with the filed Mechanics' Lien; (3) Plaintiff failed to file an affidavit of service of notice, or acceptance of service, within 20 days after service setting forth the date and manner of service to Defendant.

When faced with preliminary objections in mechanics' lien proceedings that will result in a denial of claim or a dismissal of suit, courts should only sustain objections in cases which are clear and free from doubt. <u>Castle Pre-Cast Superior Walls of Delaware, Inc. v. Strauss-Hammer</u>, 610 A.2d 503, 504 (Pa. Super. Ct. 1992). Strict compliance with Mechanics' Lien Law is necessary in order to

¹ Plaintiff Ryan Sievers d/b/a RFS Construction Solutions ("Plaintiff") did not file an answer. Defendant Kerr Land Holdings, LLC ("Defendant") has requested an expedited hearing or, in the alternative, a determination on the pleadings alone without a hearing. The Mechanics' Lien Law of 1963 permits the court to make a determination on the pleadings alone, without first holding a hearing. See Wentzel-Applewood Joint Venture v. 801 Mkt. St. Assocs., LP, 878 A.2d 889, 894 (Pa. Super. Ct. 2005)(finding that a trial court is not required to hold a hearing prior to sustaining preliminary objections to a mechanics' lien because "[n]othing in section 1505 [49 Pa.C.S. § 1505, which permits preliminary objections to liens,] *requires* a trial court to either hold a hearing or to solicit depositions.")(citing Mele Construction Company, Inc. v. Crown American Corporation, 618 A.2d 956, 960 (Pa. Super. Ct. 1992)(emphasis in original)). Given that Plaintiff failed respond to Defendant's objections and where Plaintiff failed to perfect the Lien on its face, the court has determined that a decision based on Defendant's objections alone is appropriate.

2. Plaintiff's mechanics' lien is STRICKEN.

to effect a valid claim. <u>Brann & Stuart Co. v. Consol. Sun Ray, Inc.</u>, 253 A.2d 105, 106 (Pa. 1969); <u>Bricklayers of W. Pennsylvania Combined Funds, Inc. v. Scott's Dev. Co.</u>, 41 A.3d 16, 28 (2012), reversed on other grounds, 90 A.3d 682 (Pa. 2014)(finding that "a strict compliance standard may be used to determine certain issues of notice and/or service"); <u>Regency Investments, Inc. v. Inlander Ltd.</u>, 855 A.2d 75, 77 (Pa. Super. Ct. 2004)(stating that "[s]ervice requirements under Pennsylvania's Mechanics' Lien law are strictly construed such that a complaint will be stricken if the statutory service requirements are not met").

Section 1502(a) & (c) of the Mechanics Lien Law of 1963 provides that in order to perfect a mechanics' lien:

(a) ... every claimant must:

(1) file a claim with the prothonotary as provided by this act within six (6) months after the completion of his work; and

(2) serve written notice of such filing upon the owner within one (1) month after filing, giving the court, term and number and date of filing of the claim. An affidavit of service of notice, or the acceptance of service, shall be filed within twenty (20) days after service setting forth the date and manner of service. Failure to serve such notice or to file the affidavit or acceptance of service within the times specified shall be sufficient ground for striking off the claim.

(c) Manner of service. Service of the notice of filing of claim shall be made by an adult in the same manner as a writ of summons in assumpsit, or if service cannot be so made then by posting upon a conspicuous public part of the improvement.

49 Pa.C.S. § 1502. As indicated, pursuant to Plaintiff's affidavit of service, service of notice of the filing of the mechanics' lien was performed on February 8, 2019 although the mechanics' lien was not filed until February 11, 2019. Further, this notice did not contain the term and number as required under § 1502(a) because service was performed *prior* to the filing of the mechanics' lien. Additionally, Plaintiff served the written notice by certified mail. However, personal service must be made by the sheriff. See Clemleddy Const., Inc. v. Yorston, 810 A.2d 693, 697 (Pa. Super. Ct. 2002)(finding that requirement that personal service to "be made by an adult in the same manner as a writ of summons in assumpsit" means that the notice of filing of claim in a mechanics' lien case must be served by the sheriff). For these reasons, Plaintiff failed to perfect its mechanics' lien and that lien will be stricken. Notably, if a mechanics' lien claim is not perfected, the plaintiff still has an adequate remedy in a claim for monetary damages for breach of contract. See Regency Investments, Inc., 855 A.2d at 80.


