BAR NEWS

PARENT TAKES A POCKET KNIFE TO SCHOOL

In the case of *Com. v. Goslin*, 2017 PA Super 38 (Feb. 16, 2017), the Defendant's son was suspended from elementary school for three days for bringing a knife to school. Subsequently, Defendant (Mr. Goslin) and his wife attended a meeting at the school to discuss the disciplinary action with school administrators. Mr. Goslin arrived at the meeting directly from his job as a carpenter, and brought with him a pocketknife that he uses not only at work as a carpenter, but also to "sharpen pencils, whittle sticks with his sons, and 'open tuna cans when my wife forgets to pack me a tuna can opener." During the meeting, Mr. Goslin removed the knife from his pocket and placed it forcefully on a conference table around which the meeting attendees were seated and asked whether he would be arrested.

It turns out, he was arrested and charged with the Possession of Weapon on School Property as well as Terroristic Threats with Intent to Terrorize Another. The trial court found him guilty and rejected the defense that he had the pocketknife on school property "for other lawful purpose[s]" because the ostensible lawful purposes were not related to school activities.

The Superior Court disagreed, vacating the judgment of sentence and remanding for a new trial stating, "the plain meaning of the phrase 'other lawful purpose' is an aim or goal different from, or in addition to, an aim or goal described in the first clause of Section 912(c), i.e., in conjunction with "a lawful supervised school activity or course." The second clause of this subsection, thus, serves as a catchall provision. Contrary to the trial court's conclusion, the "other lawful purpose" language does not restrict the defense provided in Section 912(c). Instead, the phrase does just the opposite: it expands the defense to include any additional or different lawful reason not otherwise mentioned in the first clause of Section 912(c), regardless of whether it is school-related." *Goslin*, supra.
