## Obiter Dictum

From the *ABA Journal Daily Newsletter*:

[1] In a 6-3 decision, the U.S. Supreme Court held that a defense lawyer who failed to investigate his capital client's tumultuous childhood provided ineffective assistance of counsel and remanded the case for a determination of whether the deficient performance was prejudicial.; [2] According to a recent study by the University of California at Berkeley, prosecutors in California routinely use peremptory challenges to remove prospective jurors who are black and Latino which strikes are routinely upheld on appeal. The study reflected that prosecutors removed black prospective jurors in about 72% of appeals cases reviewed in connection with the study and removed Latino prospective jurors in about 28% of the cases. Prosecutors most often cite the prospective jurors' demeanor to support the strikes.; [3] The U.S. Supreme Court refused to hear several cases challenging the doctrine of qualified immunity which often shields police officers accused of misconduct. Although both Justices Thomas and Sotomayor have criticized the doctrine in the past, only Justice Thomas dissented from the court's denial in one of the cases which involved a homeless man bitten by a police dog.; [4] The U.S. Supreme Court in a 5-4 decision has overturned the Trump administration's decision to phase out a program that deferred deportation for some immigrants. The decision to rescind the program known as Deferred Action for Childhood Arrivals ("DACA") was deemed arbitrary and capricious in an opinion authored by Chief Justice Roberts. According to Chief Justice Roberts, the "dispute before the court is not whether the [Department of Homeland Security ("DHS")] may rescind DACA. All parties agree that it may. The dispute is instead primarily about the procedure the agency followed in doing so." According to Chief Justice, the DHS failed to "provide a reasoned explanation" for its decision, constituting a violation of the Administrative Procedures Act and the DHS will now have to "consider the problem anew."; [5] The CEO of the Pacific Gas & Electric Co. pleaded guilty on the company's behalf to 84 counts of manslaughter arising from deadly California wildfires. The company was sentenced to pay a \$3.5 million fine and \$500,000 to cover investigative costs for poorly maintained equipment which started the fire.

**Other news:** The Pennsylvania Supreme Court has approved a rule change that will prohibit a lawyer from engaging in conduct in the practice of law that the lawyer knows or reasonably should know is harassment or discrimination. New Rule of Professional Conduct 8.4(g) is a modified version of an ABA Model Rule adopted in 2016 and will take effect six months from its adoption date on June 8, 2020.
