Dear Counselor:

I hope this letter finds you and your families safe and well as we all continue to weather the challenges of the past year.

As I assume the role of Chief Justice of Pennsylvania, I am honored to continue Chief Justice Tom Saylor's annual custom of writing to thank you for the financial support you provide to legal aid organizations as a component of our annual attorney registration fee, and to encourage each of Pennsylvania's more than 75,000 attorneys to provide pro bono service through direct representation and additional financial support of the Commonwealth's legal aid programs.

This year, the need is especially acute. The global pandemic has disproportionately impacted low-income groups, and the resulting financial and familial stressors are exacerbating the need for civil legal aid among those who cannot afford private counsel. The Supreme Court supports civil legal aid programs in a variety of ways, including creating a continuing legal education pilot program to increase support for those programs, enacting rule changes to facilitate the provision of bro bono services by retired lawyers, funding a loan forgiveness program, and celebrating the work of pro bono volunteers. The Pennsylvania Legal Aid Network works in conjunction with a range of regional and specialty legal aid providers, and these structures offer myriad opportunities for volunteer lawyers to donate their time and legal skills as well as their financial support.

I join with Pennsylvania Bar President Kathleen Wilkinson in asking you to commit to the goal of Rule 6.1 of the Rules of Professional Conduct, which calls upon lawyers to render public interest legal service. To those of you who already do so much to support this important work, thank you.

Wayne County District Attorney A.G. Howell announces the following cases were addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — April 29, 2021

ZACHARY ALFRED BAHAJ, age 29 of New York NY, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to a DUI. He was also ordered to pay all costs, undergo a Drug and Alcohol Evaluation and comply with all recommendations for treatment, complete the Alcohol Highway Safety program, perform 20 hours of community service and have his operator's privileges suspended for 30 days. The incident occurred on June 24, 2020 in Dreher Township.

KARL EDWARD BUSINSKI, age 56 of Newfoundland Pa, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to a DUI. He was also ordered to pay all costs, undergo a Drug and Alcohol Evaluation and comply with all recommendations for treatment, complete the Alcohol Highway Safety program, perform 20 hours of community service and have his operator's privileges suspended for 60 days. The incident occurred on August 15, 2020 in Dreher Township.

JONATHAN RYAN CRAWN, age 21 of Hawley Pa, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to Possession Small Amount Marijuana and related charges. He was also ordered to pay all costs, undergo a Drug and Alcohol Evaluation and comply with all recommendations for treatment, complete the Alcohol Highway Safety program, and perform 20 hours of community service. The incident occurred on February 15, 2021 in Hawley Borough.

STEVEN ENGLERT ESTUS, age 35 of Lake Ariel Pa, was sentenced to undergo incarceration in a State Correctional Facility for a period of not less than 14 months nor more than 60 months for one count of Criminal Trespass-Break Into Structure (F2) and one count of Harassment-Communicate Lewd, Threatening, Etc. Language (M3). He was also ordered to pay the costs of prosecution. The incidents occurred on December 17, 2019 and October 14, 2020 in Lake Township.

MICHAEL JOHN POTOPOWICZ, age 49 of Gouldsboro Pa, was sentenced to 6 months probation for one count of Harassment-Communicate Lewd, Threatening, Etc. Language (M3). He was also ordered to pay the cost of prosecution, pay restitution in the amount of \$370.00, undergo a mental health evaluation and comply with any recommendations for treatment, complete an anger management program, and have no contact with the victim or the victim's family. The incident occurred on May 23, 2020 in Lehigh Township.

LEONARD STEWART, 45 of Wilkes-Barre Pa, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to a DUI. He was also ordered to pay all costs, undergo a Drug and Alcohol Evaluation and comply with all recommendations for treatment, complete the Alcohol Highway Safety program, perform 20 hours of community service and have his operator's privileges suspended for 60 days. The incident occurred on November 23, 2018, in Salem Township.

ROBERT SHAWN WEATHERLY JR, age 24 of Milford Pa, was sentenced to pay a fine of \$150.00 for one count of Unsworn Falsification-Statement Under Penalty (M3). He was also ordered to pay the cost of prosecution. The incident took place on March 20, 2020


