### **SUMMARY OF OPINION:**

Plaintiff, who was injured in an accident when a tractor and lowboy unloading an excavator allegedly blocked the only clear lane of travel and forced him into a snow and ice-covered lane causing him to lose control and crash, filed a personal injury suit against the commercial driver and his employer. Plaintiff averred that those defendants blocked the roadway "when they knew" that it would force other motorists to drive "into the unplowed snowy and icy" lane of travel, and that they did not place, or even possess, the emergency reflective triangles, fusees, or other warning devices required by federal and state law. After plaintiff gathered evidence in support of those allegations during discovery, including expert reports that concluded that those defendants acted recklessly and with conscious disregard for safety, he filed a motion to amend his complaint to include a claim for punitive damages. Leave to amend a pleading should be liberally granted unless the amendment seeks to assert a new cause of action after the statute of limitations has expired or will result in prejudice to an adverse party. A request for punitive damages does not constitute an independent cause of action and is merely incidental to an underlying claim, and plaintiff's proposed amendment merely amplified his earlier allegations without asserting a new time-barred cause of action. Furthermore, the commercial defendants did not identify any resulting prejudice that warranted the denial of plaintiff's requested amendment. Therefore, the motion to amend the complaint to include a punitive damages claim was granted.

### **SUMMARY OF OPINION:**

Plaintiff asserted fraud and negligence by defendant in installing a fire protection system pursuant to their contract by failing to install the system piping in conditioned, heated spaces, by neglecting to install the system in accordance with the International Building Code and the National Fire Protection Association standards, and by performing its services in an "unworkmanlike manner." Plaintiff also asserted that in order to induce it to execute the installation agreement, defendant represented that it would perform certain inspection and testing services that it never intended to complete, and that defendant later sought payment for inspection services that it never performed and even filed a mechanics' lien for services that it did not provide. Defendant demurred to the negligence claim based upon the gist of the action doctrine, and asserted that the fraud claim had not been alleged with sufficient particularity.

Although the parties' contract was the means by which the vendor/contractor relationship was created between the parties, the negligence claims were not predicated upon any specific executory promises contained in their agreement, particularly the duty of reasonable workmanship which is implied by law and exists independently of any contractual representation. Since the negligence claims were based upon defendant's alleged violation of a broader societal duty, the demurrer to the negligence claim was overruled. Fraud is sufficiently alleged under Pa.R.C.P. 1019(b) if the pleading adequately explains the nature of the claim to the opposing party so as to permit the preparation of a defense, and the allegations are sufficient to convince the court that they are not merely subterfuge. Inasmuch as plaintiff's averments adequately explained the nature of its misrepresentation claim so as to permit defendant to prepare a defense, and they were sufficient to convince the court that they were not merely subterfuge, the demurrer to the fraud claim was also overruled.
