Obiter Dictum

From the ABA Journal Daily Newsletter: [1] The Oregon Supreme Court has given final approval to a program that allows licensed paralegals to provide limited legal services in family law and landlord/tenant cases. Licensed paralegals won't be able to argue in court, but they will be able to represent clients in settlement discussions and mediations, as well as help clients draft and fill out forms, assist clients in discovery, help clients prepare for court appearances, attend clients' court appearances and depositions to provide support and to explain court orders and notices to clients. Under new rules approved by the Oregon Supreme Court, people seeking paralegal licenses will have to meet minimum educational and experience requirements and pass an entrance examine, as well as a character and fitness review and will have to follow many of the same rules and regulatory requirements that apply to lawyers. Other states having been given a green light to license paralegal programs include Washington, Utah, Arizona, and Minnesota. [2] A judge in Arizona has allowed an ex-husband to serve as personal representative of an embryo in a wrongful death lawsuit that he filed against an abortion clinic and its doctors. The judge allowed the ex-husband to make the argument that the embryo that he conceived with his then wife was a person for purposes of the lawsuit. The exhusband had accompanied his wife to the abortion clinic in Phoenix, where she received abortion pills to end her seven-week pregnancy and has alleged in the suit filed in 2020 that the clinic failed to obtain proper informed consent from his then wife. [3] The practice of chalking tires to track how long cars are parked in the city of Saginaw, Michigan, is an unconstitutional search under the 4th Amendment, according to a United States District Judge in the eastern district of Michigan. In doing so, the District Judge relied on two decisions from the United States Court of Appeals for the 6^{th} Circuit, which held that chalking tires without a warrant is a search that is presumptively unreasonable under the 4^{th} Amendment, and a subsequent decision in which the Court of Appeals, after reviewing several exceptions to the warrant requirement, determined that such exceptions were inapplicable. The ruling came in connection with a class action filed on behalf of members who received parking tickets and, while not entitled to a refund, were entitled to nominal damages of a dollar for each instance of chalking, by the District Court.
