REALTY TRANSFER TAX 2021 COMMON LEVEL RATIO REAL ESTATE VALUATION FACTORS

June 2021

The following real estate valuation factors are based on sales data compiled by the State Tax Equalization Board in 2020. These factors are the mathematical reciprocals of the actual common level ratio (CLR). For Pennsylvania Realty Transfer Tax purposes, these factors are applicable for documents accepted from July 1, 2021 to June 30, 2022. The date of acceptance of a document is rebuttably presumed to be its date of execution, that is, the date specified in the body of the document as the date of the instrument (61 Pa. Code § 91.102).

BROWNDALE MAN ARRESTED FOR INDECENT CONTACT WITH A MINOR

July 6, 2021 — Wayne County District Attorney A.G. Howell announced today the arrest of Joseph A. Christensen, 42, of Browndale, Clinton Township, Wayne County, PA. Christensen was charged with one count of False Imprisonment of a Minor, a felony 2nd degree, one count of Corruption of Minors, a felony 3rd degree, one count of Unlawful Contact With a Minor, a felony 3rd degree, one count of Indecent Assault by Forcible Compulsion, a misdemeanor 1st degree, one count of Indecent Assault Without the Consent of Other, a misdemeanor 2nd degree and Indecent Assault of a Person Less Than 16 Years of Age, a misdemeanor 2nd degree.

According to the Criminal Complaint Affidavit of Probable Cause, the Wayne County Detectives received a "Child Welfare Report To Law Enforcement Official" stating that a 13-year-old juvenile female had reported being sexually assaulted by an adult. The juvenile reported that she was at her friend's house and the friend's father, later identified as the defendant, Joseph Christensen, sexually assaulted her.

The incident took place in early 2021 at Christensen's residence in Browndale. The juvenile stated that she was sitting on the couch in the living room playing video games when Christensen came up to her, pinned her down on the couch and tried to kiss her. She was able to move away from him, but he kept moving closer. He managed to hold her down and again tried to kiss her. He then bit her on the neck and kissed her on the lips, after which he got up and left the room.

On July 2, 2021, Christensen was taken into custody pursuant to an arrest warrant. A Preliminary Arraignment was conducted by Magisterial District Judge Carney and he was remanded to the Wayne County Correctional Facility on \$15,000.00 cash bail. His next court appearance is scheduled for July 7, 2021 at 9:00 am.

*NOTE: The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

HONESDALE, PA — July 1, 2021

LAURIE ELLEN ALGERIO, age 66 of Honesdale Pa, was sentenced to 12 months probation with 60 days house arrest through the SCRAM program for two counts of DUI (M). She was also ordered to pay the costs of prosecution, pay a mandatory minimum fine of \$600.00, participate in and cooperate with the drug and alcohol addiction treatment in accordance with her assessment, complete the Alcohol Highway Safety Program, participate in counseling with the Wayne County Drug and Alcohol Recovery Specialist and comply with all recommendations, and undergo a mental health evaluation and comply with any recommendations for treatment. These incidents occurred on December 24, 2020 and February 5, 2021 in Honesdale Borough.

KARISSA LESLIE KREIDLER, age 33 of Honesdale Pa, was sentenced to 24 months probation with 90 days house arrest through the SCRAM program for one count of DUI (M). She was also ordered to pay a mandatory minimum fine of \$1,500.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with her assessment, continue with mental health treatment, complete the Alcohol Safety Program, and complete 25 hours of community service. The incident occurred on October 10, 2020 in Berlin Township.

JAMES EDWARD MIHALIS, age 62 of Honesdale Pa, was sentenced to undergo incarceration in a State Correctional Facility for a period of not less than 6 months nor more than 24 months for one count of Recklessly Endangering Another Person (M2) and one count of Criminal Mischief – Damage Property (M3). He was also ordered to pay the costs of prosecution, and pay restitution in the amount of \$8,464.01. The incident occurred on February 25, 2021 in Damascus Township.

JUSTIN KENNETH SINGER, age 33 of Hawley Pa, was sentenced to undergo incarceration in a State Correctional Facility for a period of not less than 9 months nor more than 24 months for one count of Flight to Avoid Apprehension, Trial or Punishment (M2) and one count of Possession of a Controlled Substance (M). He was also ordered to pay the costs of prosecution. The incident occurred on January 14, 2021 in Honesdale Borough.

ANDREW JOSEPH SLEDZINSKI, age 24 of Lake Ariel Pa, was sentenced to 6 months probation for one count of Disorderly Conduct – Obscene Language/Gesture (M3). He was also ordered to pay the costs of prosecution, pay a fine of \$500.00, undergo a mental health evaluation and follow any recommendations for treatment, complete 20

hours of community service, have no contact with the victim, and not enter the Dollar General in Salem Township. The incident occurred on December 14, 2020 in Salem Township.

BRADLEY ISAAC SWASEY, age 19 of Honesdale Pa, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 10 days nor more than 12 months followed by 12 months probation for one count of Forgery-Altering Writing (F2), one count of Criminal Conspiracy-Engaging (M2), and one count of Theft by Deception-False Impression (M3). He was also ordered to pay the costs of prosecution, undergo a drug and alcohol evaluation and comply with any recommendations for treatment, undergo a mental health evaluation and comply with any recommendations for treatment, and obtain employment within 30 days of parole or provide documentation from a doctor precluding him from employment. The incidents occurred on February 6, 2021, February 23, 2021 and February 25, 2021 in Honesdale Borough.
