SUMMARY OF OPINION:

The defendant-hospital in this malpractice action appealed an Order to the Superior Court which had directed the hospital to submit event reports and a patient safety report for an *in camera* review to facilitate a determination as to whether those materials were shielded from discovery by the Patient Safety and Quality Improvement Act ("PSQIA"), the Peer Review Protection Act ("PRPA"), or the Medical Care Availability and Reduction of Error ("MCARE") Act. As the party asserting evidentiary privileges under the PSQIA, the PRPRA, and the MCARE Act, the hospital bore the burden of establishing that discovery of the requested reports was prohibited by those statutes, but its limited submissions raised a series of unanswered questions regarding the applicability of those claimed privileges. Rather than grant the plaintiffs' motion to compel the production of those reports based upon the hospital's failure to satisfy the statutory criteria for the asserted privileges due to deficiencies in the record that it had presented for review, the hospital was directed to submit the disputed reports for an *in camera* review in an effort to resolve those unsettled issues. For the reasons set forth in the Opinion pursuant to Pa.R.A.P. 1925(a), it was submitted that it was not an abuse of discretion to order the *in camera* review under the circumstances.

SUMMARY OF OPINION:

Residential property owners, who allegedly suffered damage as a result of negligent construction work by a contractor, filed suit against the contractor and the entity that was hired to act as the borough's building construction code official to perform inspections and grant approvals for construction activities upon request by the contractor. They asserted that the contractor commenced and completed substandard work without requesting any inspections or obtaining approvals, and contended that the building official was "careless and negligent" in conducting inspections and failing to issue stop work orders. The building official filed a motion for summary judgment on the grounds that it was immune from liability under the International Residential Code and the Political Subdivision Tort Claims Act.

Under the International Residential Code, the building construction code official was immune from liability for any act or omission in the discharge of its official duties for the borough which occurred while acting "in good faith and without malice." Even when the record was viewed in the light most favorable to the property owners, it lacked any evidence whatsoever to support a claim that the building construction code official acted with malice or in bad faith. Therefore, it was clear and free from doubt that the building code official was entitled to judgment in its favor as a matter of law, as a result of which its motion for summary judgment was granted.
