The agreement must be signed and approved by the court to be legally binding.

A birth relative is only as a parent, grandparent, stepparent, sibling, uncle or aunt of the child's birth family, whether the relationship is by blood, marriage or adoption.

This voluntary agreement may allow you to have continuing contact or communication, including but not limited to:

- Letters and/or emails
- Photos and/or videos
- Telephone calls and/or text messages; or
- Supervised or unsupervised visits
