

MEMORANDUM OPINION

Before this Court is Defendant's Preliminary Objections to Plaintiff's Complaint. For the following reasons Defendant's Preliminary Objections are **DENIED**.

DISCUSSION

Preliminary objections, if sustained, would result in the dismissal of a cause of action, and "should be sustained only in cases that are clear and free from doubt." *Bower v. Bower*, 531 Pa. 54, 611 A.2d 181, 182 (1992).

Defendant's Objection I – Pa. R.C.P. 1028(a)(2)

Plaintiff established chain of title by the Affidavit of Sale of Account by Original Debtor dated May 2, 2017 and Bill of Sale dated March 23, 2017. Thus, as the owner of, and/or successor to the account from Synchrony Bank, Plaintiff has proper standing to sue for the outstanding obligation owed by Defendant on the account.

Defendant's Objection II - Pa. R.C.P. 1028(a)(3)

"In a claim for breach of contract, the plaintiff must allege that there was a contract, the defendant breached it, and plaintiff suffered damages from the breach." *Discover Bank v. Stucka*, 33 A.3d 82, 87 (Pa. Super 2011). A defendant has sufficient notice of the claims against him, if the allegations contained in the complaint if ultimately proven, would permit the plaintiff to recover. <u>Id.</u>

Plaintiff sets forth in its Complaint material facts, which if ultimately proven, are sufficient to demonstrate a claim for breach of contract. Further, the Pennsylvania Superior Court in *Stucka*, held that "[w]here a complaint is based on the failure of a debtor to pay the balance due on a credit card account, it is proper under Rule 1019(i) for the defendant to assert in preliminary objections that the plaintiff failed to produce a cardholder agreement and statement of account." *Stucka*, 33 A.3d at 87. However, neither case law nor Rule 1019(i) requires that the agreement provided be the original signed agreement of the parties. <u>Id.</u> Thus, the credit agreement exemplar provided by the Plaintiff is sufficient to prove a contract between the parties.

Defendant's Objection III - Pa. R.C.P. 1028(a)(2)

Pa. R.C.P. 1024(c) states as follows: "[t]he verification may be made by any person having sufficient knowledge or information and belief and shall set forth the source of his information as to matters not stated upon his own knowledge and the reason why the verification is not

made by a party."

In *Monroe Contract Corp.*, the Superior Court of Pennsylvania reasoned that the language in Pa. R.C.P. 1024(c), specifically, "the verification may be made by **any person** having sufficient knowledge or information and belief" properly includes a party's legal counsel. *Monroe Contract Corp. v. Harrison Square, Inc.*, 405 A.2d 954, 958. Further, even if some error did occur in the execution of the verification of the Complaint, the error amounted to a *de minimus* error and not prejudicial to the parties. As the *Monroe Court* stated, "[i]t would not be in the best interests of judicial economy to remand the mater for the sole purpose of effecting a miniscule and purely formal amendment." *Id.* at 959. Any person, including a party's attorney, could verify on behalf of the party, provided that the person does so only in those cases in which the conditions delineated from Rule 1024 exist. *Id.*
