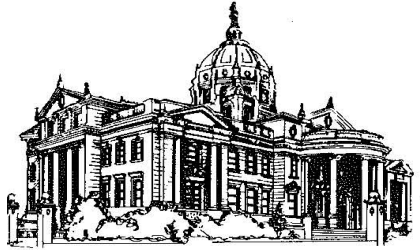

Obiter Dictum

From the *ABA Journal Daily Newsletter*: [1] A federal appeals court recently ruled that a federal judge should take another look at a Second Amendment challenge to a Pennsylvania township’s zoning restrictions on “Sportsmen’s Clubs” shooting ranges. The decision by the U.S. Court of Appeals for the 3rd Circuit has revived a lawsuit which had challenged a zoning regulation enacted by Robinson Township after residents complained about plans to reopen the Greater Pittsburgh Gun Club as a shooting range and to sell firearms. The new regulation governing Sportsmen’s Clubs allowed such clubs in interchange business districts and required the clubs to operate as non-profits, as well as contained a ban on center fire rifle practice. [2] According to a recent decision of the Massachusetts Supreme Judicial Court, lawyers can’t exclude potential jurors during *voir dire* based on sexual orientation, having determined that such practice is prohibited by the state constitution and the equal protection clause of the U.S. Constitution. The Massachusetts Supreme Judicial Court is the second top state court to issue such a ruling. Nevada was the first. At the federal level, the U.S. Court of Appeals for the 9th Circuit has also held that sexual orientation of the jurors is a protected class during jury selection. [3] The Chief Justice of the Virginia Supreme Court has issued an emergency order to increase the pool of lawyers who can represent indigent tenants who are facing evictions and others in need of free legal help. The order expands legal representation by authorizing pro bono practice by some law professors licensed outside of Virginia, and as well as lawyers outside of the Commonwealth. The order was predicated on the Chief Justice’s determination that the Covid-19 pandemic is a “major disaster” that has created “an emergency affecting the justice system” in Virginia which has particularly increased the number of civil cases affecting housing and the indigent, as well as created a backlog resulting in the increased need for legal representation. [4] A federal appeals court has sided with a non-profit organization that provides free food to homeless people in a park in Ft. Lauderdale, Florida, finding that a city rule that limits the practice is unconstitutional. In its ruling, the U.S. Court of Appeals for the 11th Circuit held that Ft. Lauderdale Park Rule 2.2, which requires the city’s written permission for “social service food sharing events” in all its parks, violates the 1st Amendment rights of Ft. Lauderdale Food Not Bombs.

NOTICE TO THE PROFESSION

Local Rules of Juvenile Procedure

Beginning Monday, November 29, 2021, Local Rules of Juvenile Procedure 120 and 1120 became effective. The rules designate the Juvenile Probation Office as the Clerk of Courts (as that phrase is defined by the applicable statewide rules) for juvenile delinquency and dependency matters. The Juvenile Probation Office will have the responsibility and function to maintain the official court record and docket as set forth in Pa. R. Juv. C. P. 166 and 1166. Pursuant to the local rules, the Chief Juvenile Probation Officer has the authority to certify records of, and affix the seal of, the Court of Common Pleas of Washington County where applicable.

The juvenile probation office is located on the 4th floor of the Family Court Center at 29 West Cherry Avenue, Suite M414, Washington, PA 15301, and can be reached at 724-228-6794. Whenever possible, attorneys/parties should utilize PACFile for filings. If necessary, documents can be filed in person at the above address.

Subpoenas must be requested in delinquency and dependency cases through PACFile. Upon filing a request, a subpoena will be issued by a judge of the Court of Common Pleas in accordance with the Juvenile Act. Subpoenas will be issued and mailed within the same business day whenever possible. No subpoenas without the signed authority of a common pleas judge should be used after the effective date of the local rules.

You may also contact the Juvenile Probation Office at the above number. Upon request, arrangements will be made for timely access to the paper file.

All requests for certified criminal documents, or other matters concerning criminal cases, should continue to be directed to the Clerk of Courts. Please contact the Chief Juvenile Probation Officer, Amanda Gallagher, with any questions regarding these procedures.
