#### **OPINION AND ORDER**

Cordaro, J.

Before this Court is a Motion in Limine filed on behalf of the Defendant (hereinafter "Tressler"). After full consideration of the record, arguments of counsel and pertinent case law, it is hereby ORDERED and DIRECTED that said motion is GRANTED in part and DENIED in part. The Commonwealth is precluded from introducing evidence to the jury regarding prior incidents when Tressler allegedly assaulted the same victim with a knife. The Commonwealth may introduce evidence of an alleged suicide attempt by Tressler.

#### BACKGROUND

The Defendant has been charged with criminal homicide in connection with the death of Robert Lee Engle (hereinafter "Engle") on August 22, 2015. The Commonwealth has presented notice of its intention to present testimony related to prior bad acts of Tressler. Counsel for the Defendant presented a Motion in Limine requesting that the Commonwealth be precluded from offering evidence in connection with an incident from September 9, 2009, involving Engle, when Tressler was charged with aggravated assault, simple assault, and harassment. These charges were subsequently dismissed at the preliminary hearing on February 11, 2010.

In addition, Tressler has been listed as either the accused or victim in several other types of domestic violence incidents, which the defense argues as inadmissible.

Finally, the Commonwealth may present evidence to show that Tressler attempted to injure herself on August 22, 2015, as a result of her culpability, which the defense argues should be inadmissible.

#### DISCUSSION

Evidence of the defendant's prior crimes or bad acts is governed by Pa.RE. Rule 404. The rule provides that : "Evidence of a crime, wrong, or other act is not admissible to prove a person's character in order to show that on a particular occasion the person acted in accordance with the character." At Pa.RE. 404(b)(2), the permitted use of any

such evidence is limited. "This evidence may be admissible for another purpose, such as proving motive, opportunity, intent, preparation, plan, knowledge, identity, absence of mistake, or lack of accident. In a criminal case this evidence is admissible only if the probative value of the evidence outweighs its potential for unfair prejudice." Evidence of prior bad acts committed by a defendant is not admissible solely to show the defendant's bad character or his propensity for committing bad acts. Commonwealth v. Billa, 521 Pa. 168,555 A.2d 835, 840 (1989). However, evidence of prior bad acts is admissible where there is a legitimate reason for the evidence, such as to establish: 1) motive; 2) intent; 3) absence of mistake or accident; 4) a common scheme or plan; and 5) identity. Commonwealth v. Ross, 57 A.3d 85.

The Commonwealth alleges that the prior bad acts of the defendant in this case are relevant to show motive. This Court, however, cannot find the specific "logical connection" between the prior acts and the current crime. "The mere identification of similarities between the prior bad acts and the crime at issue, however, does not establish motive. Instead, as indicated above, there must be a firm basis for concluding that the crime currently on trial 'grew out of or was in any way caused by the prior set of facts and circumstances." Ross, citing Commonwealth v. Martin, 479 Pa.63, 68-69, 387 A.2d 835, 838.

The Commonwealth also argues that the prior bad acts are relevant to show Tressler's intent to kill Engle and should be admissible to prove the identity of Tressler as Engle's killer. Intent is a mental state that can be inferred from conduct. Commonwealth v. Martinez, 301 Pa.Super. 121, 447 A.2d 272, 274 (1982). The fact that Tressler may have retrieved a kitchen or steak knife on many prior occasions when there were domestic disputes with Engle does not necessarily tend to prove that her intent on this particular occasion was in fact to kill him. Evidence of these prior acts would simply show that Tressler responded to domestic disputes by grabbing a kitchen or steak knife. Additionally, this Court fails to find that the similarities between the defendant's prior acts and the present offense satisfy the standard set forth by the Pennsylvania Supreme Court in Commonwealth v. Shively, 492 Pa. 411, 424 A.2d 1257 (1981). The standard requires that the similarities are so "unusual and distinctive as to be like a signature." Again, the prior bad acts show that Tressler went for a kitchen or steak knife when she had domestic disputes with Engle.

Finally, the Commonwealth argues that the prior bad acts testimony should be admissible to prove a "common scheme, plan or design." Under Pennsylvania law, evidence of prior bad acts is admissible to prove "a common scheme, plan or design where the crimes are so related that proof of one tends to prove the others." Commonwealth v. Elliott, 549 Pa. 132, 145, 700 A.2d 1243, 1249 (1997). In this case, the Commonwealth seeks to show a distinct pattern of conduct of Tressler. That is, Tressler, on at least one occasion and perhaps many other times, grabbed a steak or kitchen knife to stab Engle when they were having a domestic dispute.

The Court has carefully considered that even if the Commonwealth could show any of the exceptions set forth in Pa.R.E. 404(b), the probative value of the evidence does not outweigh the potential for unfair prejudice. It would be difficult, if not impossible,

for a jury not to simply conclude that Tressler stabbed and killed Engle on this occasion since she stabbed or tried to stab him on one or twenty previous occasions. The purpose of Rule 404(b) is to prohibit the admission of prior bad acts to prove "the character of a person in order to show action in conformity there wit h." The prior bad acts testimony offered in this case would certainly cause the jury to conclude that if Tressler stabbed Engle previously, then she must have stabbed him on this occasion.

With respect to the Commonwealth's evidence to show that Tressler attempted to harm herself on the day she was charged, this Court finds this to be admissible. The Pennsylvania Supreme Court has held that a suicide attempt by a defendant is admissible to show consciousness of guilt. Commonwealth v. Homeyer, 373 Pa.15 0, 94 A.2d 743 (1953).

#### ORDER

AND NOW, this 22nd day of June, 2017, after full consideration of the briefs, arguments of counsel and pertinent case law, it is hereby ORDERED and DIRECTED that Defendant's Motion in Limine is GRANTED in part and DENIED in part. The Commonwealth, during its case in chief, is precluded from introducing evidence of Defendant's prior bad acts related to the 2009 incident for which the Defendant was charged and charges were dismissed. In addition, the Commonwealth, during its case in chief, is precluded from introducing evidence of prior attempted stabbings or occasions when the Defendant retrieved a knife while arguing with the victim in this case. It is further ORDERED and DIRECTED that the Motion in Limine to preclude evidence of the Defendant's attempted suicide is hereby DENIED.

Notwithstanding this Order, this Court reserves judgment on the admissibility of prior bad acts evidence once the defense rests, should the Commonwealth present any rebuttal witnesses.


