#### SUMMARY OF OPINION:

In three consolidated actions stemming from tragic shootings that occurred outside the Pennsylvania State Police station in Pike County, the adult shooter's parents filed preliminary objections seeking to dismiss the negligence claims against them on the ground that they did not owe any recognized duty to the shooting victims for the actions of their adult son. Pennsylvania law recognizes a parental duty to exercise reasonable care in controlling or restricting access to their firearms by a minor child or an adult child who suffers from mental illness or a cognitive disability. Additionally, they owe a duty to refrain from engaging in affirmative misfeasance that is likely to affect the conduct of the shooter in such a manner as to pose an unreasonable risk of harm to others.

Plaintiffs alleged that the parents knew that the shooter suffered from mental illness, cognitive disabilities, delusions, and the inability to distinguish fantasy from reality since the time that he was a child, and rather than seek warranted mental health treatment for their son, his parents fostered his phantasms by financing his "military simulation hobby" as an adult, providing him firearms training, and furnishing him with a text on sniper techniques. Plaintiff also asserted that the parents "psychologically manipulated" their son's vulnerable mental health state and compromised cognitive condition by inculcating him with their "dangerous views" that police are "too militarized" and "wield too much power" and that "change" was necessary "to end misuse of power" by police, thereby causing their son to develop strong antipathy toward police. In addition to averring that the parents have built be parents manipulative influence, plaintiffs contended that the parents had had formed "violent, terroristic plans" as a result of the parents manipulative influence, plaintiffs contended that the parents have, or should have known, that the son "was planning to spark a revolution by shooting Pennsylvania State Troopers." Finally, plaintiffs alleged that despite this knowledge, the parents failed to contact the police or any mental health professionals regarding their son's intentions and actions, and, to the contrary, granted him unfettered access to the repository of firearms that they owned or controlled at their residence, including the firearm that he used during his terroristic attack on the PSP station.

Based upon those averments, the parents did not establish that it was free and clear from doubt that they owed no duty of care under the law. The allegations of parental nonfeasance and misfeasance were deemed to state cognizable claims of negligence and recklessness by the parents. Thus, the parents' demurrers were overruled.

#### SUMMARY OF OPINION:

The purchaser of a truck engine and accompanying warranty filed a breach of contract and unjust enrichment action against the seller/warrantor that allegedly failed to honor the purchaser's post-sale warranty claim. The parties' warranty agreement contained a choice of law provision stating that the agreement was governed by Virginia law, and a forum selection clause providing that all disputes had to be litigated in the Virginia Beach courts. The seller filed a preliminary objection asserting improper venue in Lackawanna County based upon the forum selection provision.

Under Virginia law, a forum selection clause is enforceable unless the party challenging its validity establishes that the chosen forum is unfair or unreasonable, or was imposed upon that party by fraud or unequal bargaining power. Mere inconvenience and additional expense associated with litigating a claim in the designated forum are not sufficient to render enforcement of a forum selection provision unfair or unreasonable. Since the purchaser had not demonstrated that Virginia Beach was an unfair or unreasonable forum, nor that the selected forum was the product of unequal bargaining power, the clause was enforceable and required the parties' warranty dispute to be litigated in Virginia Beach. Therefore, the preliminary objection asserting improper venue under Pa.R.C.P. 1028(a)(1) was sustained.
