You have been sued in Court to obtain sole legal custody and primary physical custody of the children named in the Complaint.

You are ORDERED to appear in person at the Schuylkill County Courthouse, Courtroom 1, on July 12, 2016

at 10:00 a.m. for an Intervention Hearing.

I. CUSTODY CONCILIATION CONFERENCE

You are ORDERED to appear on July 12, 2016, at 11:00 a.m. for a Custody Conference at the Custody Conciliation Office, Schuylkill County Courthouse.

You are ORDERED to bring with you the fully completed conciliation questionnaire provided by the Court.

If you fail to appear as provided by the Order, an Order for Custody may be entered against you or the Court may issue a warrant for your arrest.

You must file with the Court a verification regarding any criminal record or abuse history regarding you and anyone living in your household on or before the initial in-person contact with the Court (including, but not limited to, a conference with a conference officer or judge or conciliation) but not later than 30 days after service of the Complaint.

No party may make a change in the residence of any child which significantly impairs the ability of the other party to exercise custodial rights without first complying with all of the applicable provisions of 23 Pa. C.S. §5337 and Pa. R.C.P. No. 1915.17 regarding relocation.

II. PARENT EDUCATION PROGRAM

The application must be filed in the Prothonotary's Office. A continuance will be granted only upon good cause shown.

The moving party shall immediately serve on all interested parties a copy of the original pleading, this order, the designated Parent Education Program Brochure which includes registration and information, and a Custody Conciliation Questionnaire, and shall further file an affidavit verifying service.

PETITION FOR LEAVE TO INTERVENE IN A CUSTODY ACTION

AND NOW, come JOSEPH JOHN PELETSKY and DEBRA JEAN POWERS, by and through their undersigned counsel and seek leave to intervene in this custody action, as follows:

1. Petitioner Joseph John Peletsky is the maternal grandfather of the minor child and resides at 249 N. Front Street, Saint Clair, PA 17970.

2. Petitioner Debra Jean Powers is the maternal aunt of the minor child, and also resides at 249 N. Front Street, Saint Clair, PA 17970.

3. Father filed a petition to modify custody in this matter and has not effectuated service upon Mother, Jennifer A. Peletsky, as he has made several attempts to serve Jennifer at her last known address, maternal grandfather's residence; however she is no longer residing with maternal grandfather and mother's current whereabouts are unknown to all parties.

4. As mother's whereabouts are unknown to all parties, Petitioners respectfully request permission for service upon mother via publication.

5. Petitioners Joseph John Peletsky and Debra Jean Powers each have standing for any form of physical or legal custody under 23 Pa. C.S.A. Section 5324(2), as they have acted in loco parentis to the minor child.

6. Petitioner Joseph John Peletsky has standing under 23 Pa. C.S.A. 5324(3) for any form of physical or legal custody, as his relationship began with the consent of the parents; he has assumed and is willing to assume responsibility for the child; the child is substantially at risk due to parental abuse, neglect, drug or alcohol abuse or incapacity; and, as the child has for a period of at least 12 consecutive months resided with the Maternal Grandfather, Father is now seeking to remove the child from Maternal Grandfather's home.

7. Petitioner Joseph John Peletsky also has standing under 23 Pa. C.S.A. 5325, as the parents have been separated for a period in excess of six months.

8. Considering the above, Petitioners Joseph John Peletsky and Debra Powers should be granted intervention in this custody action.

WHEREFORE, Petitioners respectfully request that this Honorable Court grant each intervention in this Custody Action.
