Orphans' Court – Nonprofit law – Public charity – Cy pres doctrine – Conveyance of charitable assets

- Pursuant to 20 Pa.C.S. §7740.3(a), if a particular charitable purpose becomes unlawful, impracticable or wasteful: (a) the trust does not fail, in whole or in part; (b) the trust property does not revert to the settlor or the settlor's successors in interest; and (c) the court shall apply cy pres to fulfill as nearly as possible the settlor's charitable intention, whether it be general or specific.
- 2. A provision in the terms of a charitable trust that would result in distribution of the trust property to a noncharitable beneficiary prevails over the power of the court under subsection 20 Pa.C.S. §7740.3(a) to apply cy pres.
- 3. A court may modify an administrative provision of a charitable trust to the extent necessary to preserve the trust.
- 4. A trust solely for charitable purposes having assets of less than \$100,000 may be terminated at its inception or at any time thereafter by the trustee with the consent of the Attorney General and all charitable organizations that are designated as beneficiaries by name in the trust instrument.
- 5. Upon termination, the assets, subject to the approval of the Attorney General, shall be delivered to the organizations, if any, designated in the trust instrument or, if none, to organizations selected by the trustee, in either case to be held and applied for the general or specific charitable purposes and on the terms that will, in the trustee's discretion, fulfill as nearly as possible the settlor's intention.
- 5. If the separate existence of a trust, whenever created, solely for charitable purposes results or will result in administrative expense or other burdens unreasonably out of proportion to the charitable benefits, the court may, upon application of the trustee or any interested person and after notice to the Attorney General, terminate the trust, either at its inception or at any time thereafter, and award the assets outright, free of the trust, to the charitable organizations, if any, designated in the trust instrument or, if none, to charitable organizations selected by the court, in either case for the purposes and on the terms that the court may direct to fulfill as nearly as possible the settlor's intentions other than any intent to continue the trust, if the court is satisfied that the charitable organizations will properly use or administer the assets.
- 6. Petitioner is a Nonprofit Pennsylvania corporation and a public charity. Petitioner filed a petition seeking to have the Court approve an asset transfer agreement between Petitioner and a New York not-for-profit corporation and charity which intended to establish a chapter in Pennsylvania. The Court <u>Held</u> the Petition was denied.

MEMORANDUM

Petitioner is a Nonprofit Pennsylvania Corporation and a public charity formed to facilitate yoga among the prison population. Petitioner asks this court to approve an Asset Transfer Agreement to be made between Petitioner and Defy Ventures, Inc., a New York not-for-profit corporation and charity which intends to establish a chapter in Pennsylvania by which "Petitioner's founder and executive director will continue Petitioner's prison yoga programs and will also be offered meaningful and regular volunteer opportunities." Petition, 7/11/2023, ¶ 6. Petitioner intends to transfer to Defy Ventures, Inc. assets not specified in the Petition whereupon the corporate existence of Petitioner "will continue, but Petitioner will be dissolving shortly after completing the transfer of assets contemplated by the [Asset Transfer Agreement.]" Petition, 7/11/2023, ¶ 5.

Petitioner rests its Petition on 20 Pa.C.S. § 7740.3 which provides in its entirety as follows:

§ 7740.3. Charitable trusts - UTC 413

(a) General rule.--Except as otherwise provided in subsection (b), if a particular charitable purpose becomes unlawful, impracticable or wasteful:

- (1) the trust does not fail, in whole or in part;
- (2) the trust property does not revert to the settlor or the settlor's successors in interest; and
- (3) the court shall apply cy pres to fulfill as nearly as possible the settlor's charitable intention, whether it be general or specific.

(b) Exception.--A provision in the terms of a charitable trust that would result in distribution of the trust property to a noncharitable beneficiary prevails over the power of the court under subsection (a) to apply cy pres.

(c) Administrative deviation.--A court may modify an administrative provision of a charitable trust to the extent necessary to preserve the trust.

(d) Administrative termination of small charitable trusts.--A trust solely for charitable purposes having assets of less than \$100,000 may be terminated at its inception or at any time thereafter by the trustee with the consent of the Attorney General and all charitable organizations that are designated as beneficiaries by name in the trust instrument. Upon termination, the assets, subject to the approval of

the Attorney General, shall be delivered to the organizations, if any, designated in the trust instrument or, if none, to organizations selected by the trustee, in either case to be held and applied for the general or specific charitable purposes and on the terms that will, in the trustee's discretion, fulfill as nearly as possible the settlor's intention.

(e) Judicial termination of charitable trusts.--If the separate existence of a trust, whenever created, solely for charitable purposes results or will result in administrative expense or other burdens unreasonably out of proportion to the charitable benefits, the court may, upon application of the trustee or any interested person and after notice to the Attorney General, terminate the trust, either at its inception or at any time thereafter, and award the assets outright, free of the trust, to the charitable organizations, if any, designated in the trust instrument or, if none, to charitable organizations selected by the court, in either case for the purposes and on the terms that the court may direct to fulfill as nearly as possible the settlor's intentions other than any intent to continue the trust, if the court is satisfied that the charitable organizations will properly use or administer the assets.

20 Pa.C.S. § 7740.3 (emphasis in original).

Petitioner did not specify what subsection Petitioner relies upon but this court's best surmise is that Petitioner relies on 20 Pa.C.S. § 7740.3(e) controlling the judicial termination of charitable trusts since Petitioner intends to dissolve and its founder and executive director intends to work under the aegis of Defy Ventures, Inc. Thus it follows that Petitioner must aver at a minimum that "the separate existence of a trust, whenever created, solely for charitable purposes results or will result in administrative expense or other burdens unreasonably out of proportion to the charitable benefits[.]" 20 Pa.C.S. § 7740.3(e). Here, Petitioner has averred only that the transfer is "in the best interest of both organizations [and] will enhance the charitable purposes of each and better fulfill their shared missions." Petition, 7/11/2023, ¶ 3. That averment does not rise to the level required by 20 Pa.C.S. § 77740.3(e) and the Petition is insufficient on its face.

Accordingly, for the reasons set forth above this court will deny the Petition for Conveyance of Charitable Assets Under 20 Pa.C.S.A. [sic] § 7740.3 filed July 11, 2023 without prejudice.
