# IN THE COURT OF COMMON PLEAS OF LANCASTER COUNTY, PENNSYLVANIA CIVIL ACTION - LAW

No. CI-13-07228

S.R., Plaintiff, vs. J.M., Defendant.

### **OPINION**

This case is before the court on the petition for modification filed by Plaintiff, S.R. ("Mother") on September 29, 2020. Mother and Defendant, J.M. ("Father") are parents of the minor child L.M. ("Child"). Following a hearing on February 17, 2021, which was attended by both parties, Mother with counsel and Father without counsel, this matter is ripe for review.

#### I. Procedural History

The parties' custody dispute was most recently before the court on Mother's proposed relocation, seeking to relocate with the Child to Ulster, Pennsylvania, and proposing to modify the custody schedule so that Father's periods of partial custody would be every other weekend instead of two out of every three weekends. Father objected both to the proposed relocation and to the proposed modification of the custody schedule. The court held a hearing on February 13, 2020.

The court denied Mother's request to relocate with the Child. If Mother continued to reside in Lancaster County, she would have had primary physical custody of the Child. If, however, Mother chose to move to Ulster without the Child, Father would have primary physical custody of the Child. Mother moved to Ulster without the Child and Mother had custody every other weekend during the school year, and every other week during the summer.

On September 29, 2020, Mother filed a petition to modify the custody order, asking for primary physical custody of the Child in Ulster. The court held a hearing on February 17, 2021, at which both parties were present, Mother with counsel and Father without counsel, and at which the court met with the Child.

## II. Summary of the Facts

Mother and Father are the parents of the Child who is nine (9) years old and is in fourth grade during the 2020-2021 school year. Father currently has primary custody of the child, with Mother having every other weekend during the school year, and every other week during the summer. Mother relocated to Ulster, Pennsylvania – approximately

three hours and twenty minutes away from Father- due to her new husband's new job at the county jail. Up until Mother's relocation to Ulster in January 2020, Mother had primary custody of the Child.

Mother continues to live in Ulster, Pennsylvania, with her husband, Aaron Dorman ("Stepfather"), and her roommate, Harley Swayne. Mother and Stepfather rent a four-bedroom home. In addition to the Child, Mother lives with her three-month-old son and her two stepdaughters, aged nine (9) and five (5), during times her husband has custody of them. Mother's extended family lives in Lancaster, Pennsylvania, but regularly drives to Ulster to visit. Additionally, the Child sees Mother's family when Mother picks her up in Lancaster County and they stop to see relatives. Mother's in-laws live in Ulster, about one mile from where Mother lives. The Child sees Mother's in-laws on a nearly daily basis, and the Child has a close relationship with both families.

Although Mother testified at the relocation hearing to the much greater job opportunities for her and her new husband, they are both unemployed. Mother is unemployed and does not plan on going back to work because she wants to be a stay-at-home mom. Stepfather testified that he is currently on a waiting list for a position at the Ulster sheriff's department. Stepfather was working at the prison in Ulster but was diagnosed with epilepsy and had to leave. In the meantime, Stepfather is a self-employed contractor. Stepfather stated that he is able to support his family with his income.

Father lives in Manheim, Pennsylvania, and resides with his mother, sister, and brother. This is Father's third residence since February 2020. Father works for a roofing company, with his usual hours being from 8:00 a.m. to 4:00 p.m. In Father's busiest season, he usually works from 8:00 a.m. to 5:00 p.m. Father testified that the maximum number of hours he would work in a week is forty-five (45) hours. While Father takes the Child to school when he can, paternal grandmother provides the majority of transportation for the Child to and from school and gymnastics.

Mother lives in Athens School District and Father lives in Manheim Central School District. The Child currently attends Baron Elementary School while residing with Father and does well in school. She receives positive comments from all of her teachers. Father decided for the Child to attend in-person school this year and admitted to overruling Mother's opinion that the Child should virtually attend school.

Mother and Father are both involved in the Child's education. Both parents help her with homework and contact teachers. The Child has also been heavily involved in gymnastics since the age of four (4). She currently has practice four times a week for three hours a night at Spooky Nook Sports and participates in competitions for gymnastics at

least once a month that both Mother and Father attend. The Child has taken an interest in trumpet, and both Mother and Father have helped her practice trumpet and attend her concerts.

Mother and Father do not communicate well with one another. Father does not always inform Mother of the Child's school information though both parents have access to an assignment app for the Child's school. They can see the Child's assignments and what is or is not being completed. Mother has a My LG Health app where she can see the after summary of the Child's doctor visits. Both parents take the Child to the doctor or dentist depending on when it is needed and who the Child is with at that time. There have been many instances where Father has not informed Mother of the Child's visit to the doctor or dentist. Father testified that Mother could see what happened through the My LG Health app, and therefore did not update Mother on what occurred at the visits. Father admitted that he does not inform Mother of routine medical information but does inform Mother of emergency medical situations. The Child recently had an ankle injury in October of 2020, and she had to wear a boot for two and a half weeks, but Father let her take the boot off four days early. The Child reinjured her ankle in December of 2020, and after an MRI doctors discovered a stress fracture in her foot. The Child currently wears a boot and is not participating in gymnastics.

Both parents encourage the Child to be in contact with the other party. Neither parent restricts the contact the Child can have with the other parent. Both parents have phone calls, text, or FaceTime conversations with the Child.

Mother would like the current custody schedule to be reversed. If the Child were to live with Mother, the Child would attend Athens School District. There is also a gymnastics center about twenty minutes from where Mother lives that the Child could attend. Father would like to keep the current custody schedule and keep the Child enrolled in the same school and gymnastics program. The Child has friendships with people from school and her teammates from gymnastics. Despite being unemployed, Mother and Stepfather are not considering moving back to Lancaster County.<sup>2</sup>

When the court interviewed the Child, the Child expressed that she has no concerns with either household and likes spending time with both parents. The Child expressed that she would like to see Mother more.

#### III. Standard of Review

In considering modification of a custody order between parents, each party bears the burden of proof by a preponderance of the evidence to show they should be granted custody, and thus the evidentiary scale

is evenly balanced at the outset of the proceedings. 23 Pa.C.S.A. § 5327(a); Sawko v. Sawko, 625 A.2d 692 (Pa. Super. 1993); In re Temos, 450 A.2d 111 (Pa. Super. 1982). In making a custody determination, a court's guiding principle is the best interests of the child, in accordance with the factors set forth in 23 Pa.C.S.A. § 5328.

#### IV. Discussion

This action is a petition to modify custody. The parties currently share legal custody, with Father having primary custody of the Child. Mother has the Child every other weekend during the school year and every other week during the summer. In consideration of the factors set forth in 23 Pa.C.S.A § 5328(a) as they relate to Child's best interests, based on the evidence presented by the parties, the court finds:

- 1. Which party is more likely to encourage and permit frequent and continuing contact between the child and another party.

  Mother and Father both permit and encourage the Child to contact the other party. This factor does not favor either party.
- 2. The present and past abuse committed by a party or member of the party's household, whether there is a continued risk of harm to the child or an abused party and which party can better provide adequate physical safeguards and supervision of the child. Neither party presented evidence of abuse.
- 2.1. The information set forth in section 5329.1(a) (relating to consideration of child abuse and involvement with protective services). Neither party presented evidence of abuse.
- 3. The parental duties performed by each party on behalf of the child. Mother and Father both perform normal parental duties for the Child when she is in their care, with the help of family members. This factor does not favor either party.
- 4. The need for stability and continuity in the child's education, family life and community life. Father has lived in two different school districts within the last year, while Mother has lived in Ulster for the past year. Mother is married and Father is not. This factor does not favor either party.
- 5. The availability of extended family. Both parties have extended family in Lancaster County. In Ulster, Mother has her in-laws and Stepfather to help with the Child. This factor favors Father because of Mother's choice to relocate to Ulster when all of Child's family is in Lancaster County.
- 6. The child's sibling relationships. Mother has a three-monthold son that the Child has enjoyed spending time with since his birth. Stepfather has three children who are the Child's step siblings, and he has custody of the older two (who live in New Jersey which is closer to Lancaster County and to Bradford County) every other weekend but does not have custody

- of his youngest child, a two-year-old daughter who lives with her mother in Lancaster County. Stepfather's custody schedule with his daughters coincides with the custody schedule of the Child. Stepfather's two older children live in New Jersey. Father does not have any other children. This factor slightly favors Mother, though living in Lancaster County would obviously facilitate Mother's Husband's custody with his other children.
- 7. The well-reasoned preference of the child, based on the child's maturity and judgment. The Child values her time with and loves both parents. She expressed no concerns with either parent but indicated she would like to live with Mother. She did not express concern with cutting back on her gymnastics or moving to a new school district. While the court is not convinced Child's preference is very well reasoned, she did express a sincere desire to live with Mother. This factor slightly favors Mother.
- 8. The attempts of a parent to turn the child against the other parent, except in cases of domestic violence where reasonable safety measures are necessary to protect the child from harm. Neither party presented evidence that the other is trying to turn the Child away from the other parent, and the court is encouraged that despite their differences, Father and Mother respect each other enough and love the Child enough to not attempt to turn the Child against each other. This factor does not favor either party.
- 9. Which party is more likely to maintain a loving, stable, consistent and nurturing relationship with the child adequate for the child's emotional needs. Both parties love the Child, and the Child loves both parties. Both parties are able to maintain a loving and nurturing relationship with the Child. This factor does not favor either party.
- 10. Which party is more likely to attend to the daily physical, emotional, developmental, educational and special needs of the child. Father takes the Child to medical and dental appointments. Mother provides insurance for the Child, although Father has also offered to put the Child on his insurance. Father typically purchases school supplies and clothes for the Child. Mother is currently unemployed, and Father works full-time. Paternal grandmother helps with many of the day-to-day activities with the Child such as preparing the Child's lunch and driving the Child to and from school and gymnastics. Mother is a stay-at-home mother and is the primary caregiver for the Child while she is in Mother's custody. This factor very slightly favors Mother.

- 11. <u>The proximity of the residences of the parties.</u> The parents currently live three hours and twenty minutes apart. Mother chose to relocate to Ulster. This factor favors Father.
- 12. Each party's availability to care for the child or ability to make appropriate child-care arrangements. Both parties are available to care for the Child or are able to make appropriate child-care arrangements. This factor does not favor either party.
- 13. The level of conflict between the parties and the willingness and ability of the parties to cooperate with one another. The court is encouraged that despite their differences, Father and Mother respect each other and there is a relatively low level of conflict between them. However, testimony made clear that Father routinely overrules Mother in decisions that must be made together, like schooling. Father and Mother share legal custody and neither can make unilateral decisions when one disagrees with the other. Additionally, Father has not kept Mother informed of medical and dental appointments before they occur as required by the court's previous order indicating that Father believes he can make unilateral decisions and not proactively keep Mother informed of medical issues. This factor favors Mother.
- 14. The history of drug or alcohol abuse of a party or member of a party's household. Mother has a DUI from approximately six years ago. There was speculation around Father smoking marijuana, but no credible evidence was offered to substantiate the allegation. This factor does not favor either party.
- 15. The mental and physical condition of a party or member of a party's household. Both parties have the mental and physical ability to care for Child. This factor does not favor either party.
- 16. Any other relevant factor. Over the past year, Father exhibited a habit of excluding Mother from the educational and medical decision-making process for their Child. Father stated that if his opinion were backed by data, he would overrule Mother's opinion and proceed with what he thought was best for their daughter. Additionally, Father failed to notify Mother before scheduling medical appointments as was required by the February 24, 2020 order (see page 12 of the order). This factor weighs against Father.

#### V. Conclusion

Both parents clearly love the Child very much and have a strong, loving relationship with the Child. Mother continues to reside at a residence over three hours from where Child has grown up and where all of Mother's family continues to live. Despite neither Mother nor her husband being employed, the proffered reason provided to the court for Mother's relocation, Mother and her Husband remain far away. The

court will remain cognizant in the future of Mother's actions and will be vigilant to ensure Mother does not use the distance she created to undermine Father's ability to be part of his daughter's life.

The most significant factor in the court's decision to grant Mother primary custody during the school year is Father's unilateral decision making and actions that border on bullying in decision-making for the child. The court is also taking into consideration the wishes expressed by the Child. However, Mother should in no way conclude that this court is pleased with her decision to leave the Child and relocate to Ulster, Pennsylvania. Mother has created the significant travel time between her and Father and Mother will bear the burden of transporting the Child. Mother made the decision to move three hours away and hinder the Child's connections in Lancaster County, however Father tends to make unilateral decisions and act disrespectfully towards Mother. Upon consideration of these statutory factors, the court finds it is in the best interests of the Child for Mother and Father to continue to share legal custody and for Mother to have primary physical custody of the Child during the school year, with Father having substantial partial physical custody, consistent with the order accompanying this opinion.
