ORDER DENYING DEFENDANT'S MOTION FOR POST-CONVICTION COLLATERAL RELIEF

AND NOW, this 7th day of March, 2019, after a review of the pleadings and the record, Defendant's request for Post-Conviction Collateral Relief is HEREBY **DENIED**.

HISTORY OF THE CASE

There was an old woman who swallowed a fly; I do not know why she swallowed the fly, poor old woman she was sure to die.

I recite this children's nursery rhyme as it mirrors Gregory Hess' varieties of self-induced dilemmas as well has his problem solving skills. Prior to the instant case, Defendant had been charged with hiring Calvin Jones, Jr. to kill his wife's lover. Mr. Jones then reported this matter to the state police and Hess was charged for the solicitation.

In the process of that proceeding, Hess then swallowed the spider to catch the fly, as he then hired Michael Crampton to kill Calvin Jones to prevent Jones from testifying against him in that case. Mr. Crampton reported this matter to the District Attorney's Office and Hess was again charged with a second offense similar to the first.

Hess then swallowed the bird to eat the spider when he hired Doensae Bryant to kill Michael Crampton to prevent Crampton from testifying against him. Hess was acquitted of soliciting Calvin Jones in the trial, which preceded the instant case. The second and third solicitation cases were consolidated. Hess went to trial on those two solicitations and was ultimately convicted. This conviction was appealed and affirmed.

Now the defendant appears before the court challenging his 2015 convictions. He alleges that his trial counsel, Farley Holt, George Margetas, and Suzanne Smith, were ineffective in their representation of him.

DISCUSSION

Defendant raises four claims in his Petition. First, that his attorneys were ineffective for failing to obtain exculpatory text messages. Second, that his attorneys were ineffective for failing to request a mistrial when it was revealed that one of the jurors may have knowledge of Defendant's prior case. Third, that the Commonwealth violated Defendant's constitutional rights by failing to disclose the existence of plea deals with Michael Crampton and Edward Luttrell. Finally, that a sentencing error was made by not making Petitioner eligible for the Recidivism Risk Reduction Incentive Program.

I. Ineffective Assistance Claim Regarding Allegedly Exculpatory Text Messages

During the course of the trial, there was testimony from Michael Crampton in which he referred to a text communication between himself and trooper Shawn Wolfe of the Pennsylvania State Police. This communication allegedly happened during a period of time that Crampton was the subject of a fugitive warrant. Counsel for Defendant asserts that these text messages should have been requested. Defendant's trial attorneys testified at the PCRA hearing that they were satisfied that there were no text messages.

During the PCRA hearing, testimony revealed that trial counsel for the defendant immediately met with the District Attorney who was trying the case to inquire as to why they had not received copies of these test messages. Testimony also revealed that it was explained to counsel that there were no text messages and that the witness was mistaken. The trooper to whom this text message was allegedly sent testified that there was a phone call in which the witness told the trooper that he desired to turn himself in.

Despite all of this testimony confirming that the information was relayed to the trooper via telephone call rather than text message, Defendant's PCRA counsel maintains that these nonexistent text messages are exculpatory and should have been revealed. We are satisfied that these text messages do not exist and therefore cannot be categorized in any way as to their impact on the defendant.

Counsel for the defendant alternately argues that Defense should have recalled Trooper Wolf and had him explain the conversations. They assert again that the conversations were exculpatory as they would have revealed some undisclosed deal between the witness and the trooper which induced the witness to appear in the proceedings. Again, counsel for the petitioner asserts exculpatory evidence out of whole cloth. There was a great deal of cross examination throughout the course of the trial as to what the PCRA counsel asserts.

Defendant's trial attorneys testified that they chose not to call Trooper Wolf as it, in their minds, would be more productive to argue the missing facts to the jury, which they did vehemently. The alternative would have been to call the officer, have him explain, and lose any traction with the jury by proving that there was no exculpatory evidence for the defendant in these communications. There was clearly a strategic reason for their not calling Trooper Wolf.

II. Ineffective Assistance Claim Regarding the Alleged Failure to Request a Mistrial

Second, Defendant's counsel asserts the trial counsel were ineffective for failure to request a mistrial when it was revealed from the beginning of the second week of trial that one of the jurors had apparently indicated to other jurors that they had learned some facts about the case over the weekend. The facts included background for why everybody was in jail and information related to the first trial, which resulted in the acquittal. The court and counsel conducted an inquiry of the jurors in an effort to clarify what was said. This inquiry revealed that there was both disagreement and dispute as to what was said and who heard it.

Defendant asserts that he instructed his attorneys to ask for a mistrial. All three of his attorneys testified that they did discuss with their client the option of a mistrial. During this discussion everyone agreed that they were halfway through the case, they all felt confident in the way in which the testimony was going, and they all believed that the jury knowing that the defendant had been acquitted of very similar charges would weigh in their favor and not be detrimental to their client.

It was reported to the court during the PCRA hearing that all attorneys and the defendant were unanimous in not requesting a mistrial. Rather, they confirmed that a cautionary instruction be given. This was done at trial. This is a matter of credibility as to whether counsel for the defendant are the more honest in this case. We believe counsel to be more credible.

III. Constitutional Claims

Counsel for the defendant asserts that the Commonwealth failed to disclose the existence of deals with Michael Crampton and Edward Lutrell. While counsel has made reference to the impact for such a failure, they have not shown that there was a deal that was not disclosed. In this case, both Crampton and Lutrell testified that there was no deal; they were merely told that "consideration would be given." Plea documents reflect that there was no deal; the District Attorney's Office testified that there was no deal, and therefore there was nothing to disclose. Defense asserts that because the defendants were happy with their sentences that there must have been a deal. This court is satisfied that there is no merit to this last claim.

IV. Sentencing Error

PCRA Counsel alleges that an error was made in Defendant's sentence, as he should have been eligible for the Recidivism Risk Reduction Incentive Program. Petitioner cites <u>Commonwealth v. Cullen-Doyle</u>, 164 A.3d 1239 (Pa. 2017) in support of their position. However, <u>Cullen-Doyle</u> is distinguishable from the instant case. In <u>Cullen-Doyle</u>, the Appellant had pled guilty to one count of first-degree felony burglary. *Id.* at 1241. The court held that "the single, present conviction for a violent crime does not constitute a history of violent behavior." *Id.* at 1244.

Petitioner also recognizes that there has been case law decided since <u>Cullen-Doyle</u> that is distinguishable; including <u>Commonwealth v.</u> <u>Munoz</u>, 183 A.3d 1054(2018) (No. 668 EDA 2017) January 12, 2018, as well as <u>Commonwealth v. Sterling</u>, 2018 WL 2093377 (Pa. Super. 2018), and <u>Commonwealth v. Trusty</u>, 2018 WL 1281053 (Pa. Super. 2018). We recognize that <u>Sterling</u> and <u>Trusty</u> are non-precedential decisions, however we find them persuasive when deciding this issue. What these cases all share is the distinguishing feature of an Appellant who was either convicted of, or pled guilty to, a number of offenses whereas the Appellant in <u>Cullen-Doyle</u> pled guilty to the single burglary offense.

We do find the reasoning in these post-<u>Cullen-Doyle</u> cases to be persuasive. In the instant case, Petitioner was found guilty of Criminal Conspiracy to Commit Murder of the First Degree, and Criminal Solicitation to Commit Murder of the First Degree. In case docketed at 2023-2000, Petitioner pled guilty to one count of burglary. We find that Petitioner's repeated attempts to hire hit men, and his prior burglary charge, constitute a history of present or past violent behavior. Petitioner is therefore not RRRI eligible.

Defendant is HEREBY NOTIFIED that he has the right appeal this order and that if he wishes to do so, must file the notice of appeal within thirty (30) days after entry of this order.
