



#### BENCKINI vs. ESTATE OF LICHTENWALNER

#### Breach of Contract—Frivilous Litigation—Attorney's Fees.

Over the course of several years, Gene Benckini filed multiple *pro se* civil suits against the Estate of Lloyd W. Lichtenwalner stemming from an alleged breach of contract relating to the Plaintiff's landscape and nursery business. All of Plaintiff's previous claims were dismissed with prejudice. Upon filing an Amended Complaint in 2019, Defendants filed a Motion for Sanctions and Request for Attorney's Fees.

A verified complaint may not be submitted for any improper purpose, the claims within the complaint must be warranted by existing law, and there must be evidentiary support for the factual allegations. If not, the court may issue sanctions against the complaining party. The court may award counsel fees if the conduct of the other party was arbitrary, vexatious, or in bad faith. An action with no basis in law or fact is arbitrary; an action that serves only to cause annoyance is vexatious.

The Court found that the claims raised in the 2019 amended complaint were essentially the same as a prior case filed in 2016, which was dismissed with prejudice. The only difference was that the 2016 case was pled as a conversion case, and in 2019, the same allegations were pled as a breach of contract. Because Plaintiff could have raised the breach of contract in 2016, res judicata and collateral estoppel applied. The Court therefore found that the Amended Complaint was arbitrary, vexatious, and in bad faith, and awarded attorney's fees to the Defendants.

#### MEMORANDUM OPINION

JOHNSON, J., August 31, 2020. Before the Court for consideration is Defendants' Motion for Sanctions and Request for Attorney's Fees Pursuant to Pa. R.C.P. No. 1023.1 and 42 Pa. C.S.A. Section 2503 filed January 2, 2020. Hearing was held on June 25, 2020.

Defendants argue that Plaintiff's conduct in filing the above-captioned Complaint is arbitrary, vexatious and otherwise brought in bad faith and, therefore, Defendants are entitled to an award of its counsel fees for having to defend Plaintiff's frivolous claims and the above-captioned Complaint should be dismissed with prejudice. We agree.

By signing, filing and submitting a verified complaint, the party certifies that, to the best of that person's knowledge, information and belief, formed after an inquiry reasonable under the circumstances, that it is not being presented for any improper purpose, such as to harass or to cause unnecessary delay or needless increase in the cost of litigation; that the claims, defenses, and other legal contentions therein are warranted by existing law; and that the factual allegations therein have evidentiary support. Pa. R.C.P. No. 1023.1. If the court determines that Rule 1023.1 has been violated. the court may impose an appropriate sanction upon any party that has violated the rule. Pa. R.C.P. No. 1023(d). In addition, Pennsylvania law provides that a party is entitled to an award of counsel fees if "the conduct of another party in commencing the matter or otherwise was arbitrary, vexatious or in bad faith." See 42 Pa. C.S.A. §2503(9). "An opponent's conduct has been deemed to be 'arbitrary' ... if such conduct is based on random or convenient selection or choice rather than on reason or nature." Berg v. Georgetown Builders, Inc., 822 A.2d 810, 816 (Pa. Super. 2003). By definition, where there is no basis in law or fact for commencement of an action, the action is arbitrary, and opposing party may be awarded attorney fees under statute. Id., citing Thunberg v. Strause, 545 Pa. 607, 682 A.2d 295, 301 (1996). Further, conduct is considered vexatious, for the purposes of awarding counsel fees if it is instituted without sufficient grounds and serves only to cause annoyance. Id. at 817, citing Bykowski v. Chesed, Co., 425 Pa. Superior Ct. 595, 625 A.2d 1256, 1259 (1993).

The evidence illustrates that Plaintiff has filed various complaints against Defendants over many years, all of which were dismissed with prejudice. In Plaintiff's most recently filed case prior to the above-captioned one, Lehigh County Case No. 2016-C-3545 (hereinafter, "Plaintiff's 2016 Case"), the Honorable President Judge Edward D. Reibman dismissed Plaintiff's Complaint with prejudice, citing multiple reasons. Plaintiff appealed that decision to the Superior Court of Pennsylvania which affirmed Judge Reibman's decision.

The claims raised in the above-captioned case are based on essentially the same allegations raised in Plaintiff's 2016 Case, which was dismissed with prejudice. One of the reasons for the dismissal of Plaintiff's 2016 Case was pursuant to Pennsylvania's

Dead Man's Rule because Plaintiff's claims hinged upon him establishing an agreement between Plaintiff and Lloyd W. Lichtenwalner, deceased (hereinafter, "Decedent"), and Plaintiff failed to identify any signed agreements or any disinterested witnesses that could testify to the existence of such agreement.

The Complaint in the above-captioned case is based on essentially the same allegations raised in Plaintiff's 2016 Case. But now, Plaintiff attaches an alleged signed lease agreement between Plaintiff and Decedent dated September 1, 2007 (hereinafter, "Lease Agreement"), and alleges that it was witnessed by Plaintiff's employee. Plaintiff now raises the same claims but couches them as a breach of contract action, attaching the Lease Agreement. Plaintiff's claims are that Defendants breached the Lease Agreement by illegally removing his trees and equipment from the leased property in 2015 and 2016. These allegations were already the subject of Plaintiff's 2016 Case, although they were pled as an action in conversion. Had Plaintiff believed he had a claim in breach of contract based on the same allegations and the Lease Agreement, Plaintiff could have and should have raised them in Plaintiff's 2016 Case. To further support this, it must be noted that the Lease Agreement and the allegations of its breach all occurred prior to Plaintiff filing his 2016 Complaint. As such, we find that Plaintiff's Complaint in the above-captioned case is barred and precluded by the doctrines of res judicata and collateral estoppel.

Based on the above analysis and the evidence presented at Hearing, we find that Plaintiff's conduct in filing the above-captioned Complaint was arbitrary, vexatious and in bad faith and that he is subject to sanctions under Pa. R.C.P. No. 1023.1(d) and 42 Pa. C.S.A. §2503.

Therefore, we find that Defendants are entitled to a dismissal of the Complaint with prejudice and an award of attorney's fees and costs in the amount of \$12,372.00.

#### ORDER

AND NOW, this day of August, 2020, upon consideration of Defendants' Motion For Sanctions And Request For Attorney's

Fees Pursuant To Pa.R.C.P. No. 1023.1 And 42 Pa.C.S.A. Section 2503 filed January 2, 2020; after Hearing held June 25, 2020 and for the reasons set forth in the accompanying Memorandum Opinion;

#### IT IS ORDERED that:

- 1. Said motion is GRANTED;
- 2. Plaintiff's Complaint filed July 12, 2019 is DIS-MISSED with prejudice; and
- 3. Plaintiff shall pay Defendant's attorneys' fees and costs in the amount of \$12,372.00 to Defendant c/o Anne K. Manley, Esquire, Gross McGinley, LLP, 101 Larry Holmes Drive, Suite 202, Easton, PA 18042 within thirty (30) days of the date of this Order.


