Editorial (according to the criminal complaint):

On October 27, 2025, officers responded to a domestic-related call involving a report of a disturbance at a residence in Gouldsboro. Upon arriving at the property, officers detected a strong odor of marijuana and observed a marijuana plant growing in plain view inside a greenhouse. A search warrant was later obtained for the residence.

During the search, officers discovered multiple marijuana plants and related substances throughout the home. Robert Krzan arrived on scene during the search and identified himself as the property owner. He admitted that the marijuana grown belonged to him.

Editorial (according to the criminal complaint):

On October 30, 2025, Wayne County Detective responded to a report involving Liam Bolger, who was accused of recording audio from a recent court proceeding before Judge Janine Edwards. The report originated from Wayne County Probation Department staff who overheard Bolger replaying the recording on his cellphone while at the Adult Probation Office.

Detectives met with Bolger, who admitted to recording the court session, stating he wanted to hear how he sounded while speaking. He acknowledged seeing the posted signs prohibiting recordings within the courthouse. Bolger voluntarily provided the recording to investigators.

Recording any court proceeding without authorization is a criminal offense under Pennsylvania law.

^{*}The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.*
